Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Monarch Healthcare 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Monarch Healthcare 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of Monarch Healthcare 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 1994, and has been amended throughout the years to comply with tax legislation. The Plan was last restated effective February 1, 2024, due to the acquisition of four divisions effective January 1, 2024. The Plan is a defined contribution plan covering all employees of Monarch Healthcare Management, LLC and participating employers as outlined in the Plan document (collectively referred to as Company). Effective July 15, 2022, the Plan was amended to excluded residents of Puerto Rico, leased and independent contractors from all contribution sources and part-time, temporary and seasonal employees that work less than 1,000 hours during the Plan year to be excluded from discretionary and qualified non-elective contribution sources. Employees need to attain age 18 and complete three months of service to participate in the deferral portion of the Plan and complete one year of service to participate in the Company discretionary matching or nonelective contribution portion of the Plan. The Plan was amended effective July 15, 2022 to remove the three month service requirement for the deferral portion of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). A Summary Plan Description including information relative to eligibility requirements, vesting, contributions, allocations, distribution, and any other significant Plan provisions is provided to each participant. The Investment Committee is responsible for the oversight of the Plan.

Subsequent to year end, the Plan was restated effective January 1, 2025 to update the number of loans that participants are allowed to have outstanding.

Contributions

The Plan includes a 401(k) cash or deferred provision. Under this provision, and subject to Plan provisions, eligible participants may elect pre-tax contributions up to a percentage of their annual compensation, as defined by the Plan. Participants age 50 and older may make catch-up contributions. Contributions are subject to certain limitations. Rollover contributions from other qualified plans are also permitted. Participants direct the investment of contributions into the various investment options offered by the Plan.

Each year the Company may make matching or nonelective contributions to the Plan at the discretion of the Company's Board of Directors. For the years ended December 31, 2024 and 2023, the Company matching contribution was a tiered contribution based on employee classification ranging from 100% of a participant's deferrals up to 5% to 50% of a participant's deferrals up to 5% of compensation deferred. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year in order to share in Company matching and nonelective contributions.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions and an allocation of the Company's matching and nonelective contributions and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on each participant's share of the fund. The benefit to which the participant is entitled is the benefit that can be provided from the participants vested account.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings thereon.

Employees hired on or after July 1, 2017, are subject to a three-year cliff vesting schedule whereby a participant is 100% vested after the completion of three years of credited service. For employees hired prior to July 1, 2017, vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after the completion of six years of credited service subject to a graded vesting schedule.

Notwithstanding the above, participants shall, however, become 100% vested in their account upon attaining age 59 1/2, their death, or disability as defined in the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participants' account and bear interest at the prime rate plus 2%. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon termination or retirement (age 59 1/2), the participant may elect to receive distributions in the form of a lump sum or installments. If the vested account balance exceeds \$5,000 (increased to \$7,000 in 2024) they may defer the distribution of benefits. The Plan also permits distributions upon attainment of age 59 1/2 or in the event of financial hardship, as defined in the Plan. If a participant's vested account balance is not greater than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent.

Forfeited Accounts

Forfeitures of any Company contributions may be used to pay Plan expenses or reduce Company contributions. There were \$44,135 and \$34,416 of forfeitures at December 31, 2024 and 2023, respectively. Forfeitures of \$3,398 and \$281 were used to pay Plan expenses for the years ended December 31, 2024 and 2023. Forfeitures of \$30,325 and \$76,877 were used to reduce Employer contributions for the years ended December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the Insurance Company General Account which is on a contract basis. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Certain administrative expenses are paid by the Company on behalf of the Plan. Administrative expenses paid by the Plan are reflected in the statements of changes in net assets available for benefits. Fees related to processing benefit payments and participant loans are charged directly to the participant's account. Revenue sharing credits are used to offset the Plan's administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the trustee, and Principal Life Insurance Company, the insurance company, have supplied the Plan administrator with certification as to the completeness and accuracy of all the investment information and notes receivable from participants presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 PLAN TAX STATUS

The standardized pre-approved plan issued by Principal obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service (IRS) stated that the standardized pre-approved plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. There is a routine audit by the DOL currently in process.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. Investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company accounts.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by Delaware Charter Guarantee and Trust Company dba: Principal Trust Company. Principal Trust Company is the trustee as defined in the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.

NOTE 9 NONEXEMPT TRANSACTIONS

During 2019, 2020, and 2021, the Company failed to remit employee 401(k) deferral contributions and loan repayments for certain individuals within the timeframe prescribed by the Department of Labor. These are deemed prohibited transactions in accordance with ERISA and the IRC. The Company took corrective action by remitting lost earnings and filing excise tax returns in 2024.

NOTE 10 ANNUITY CONTRACT WITH INSURANCE COMPANY

Effective in 2023, participants maintain an individual annuity contract with Principal. As part of the contracts, Principal maintains a portion of the contributions in a “guaranteed account”, which is called the Traditional Annuity. The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by Principal. The guaranteed minimum rate of interest is based on a formula established by Principal and will not be less than 1% or greater than 3%. Any additional interest is not guaranteed. The Traditional Annuity does not permit Principal to terminate the agreement prior to the scheduled maturity date.

Certain traditional annuity individual annuity contracts meet the fully benefit-responsive criteria and therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Upon termination of the investment contract, the lump sum liquidation value of the guaranteed account portion of the participant’s accumulation value shall be equal to the product of (a) the participants guaranteed account accumulation value on the liquidation date, reduced by the liquidation charge applicable on the liquidation date; and (b) a market value adjustment percentage. There are no reserves against contract value for credit risk of the contract issuer or otherwise.
