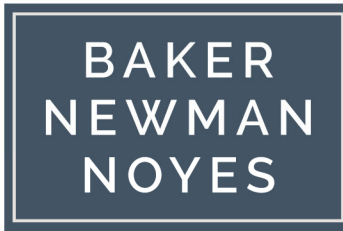

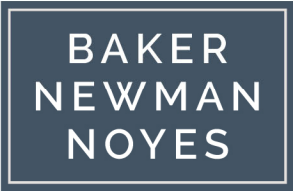

1. Description of Plan

The following description of Thos. Moser Cabinetmakers, Inc. 401(k) Retirement Savings Trust (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Thos. Moser Cabinetmakers, Inc. (the Company). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Eligibility

Employees who are at least 18 years of age are immediately eligible to participate in the Plan.

Contributions

Participants may voluntarily contribute a percentage of their compensation up to limitations established by the Internal Revenue Service (IRS) on a pre-tax and post-tax basis. The Company may elect to match a portion of the participants' voluntary contribution at an amount determined annually by the Board of Directors. During 2024 and 2023, the Company made matching contributions of 50% of the participants' contributions up to 6% of their compensation per payroll period (for a maximum matching contribution of 3.0% of compensation).

At the participants' option, contributions may be invested in various pooled separate accounts or collective trust funds. Participants should refer to the funds' prospectuses for a description of the investments. Participants may change their investment options at any time during the year through the use of a telephone automated program or via the internet.

Effective January 1, 2024, the Plan contains a provision for automatic enrollment of eligible employees at a deferral rate of 3% of eligible compensation. The Plan did not adopt an auto increase feature. Upon eligibility, participants are automatically enrolled at this rate of deferral unless an alternative affirmative election is made or the participant opts out of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and, (b) Plan earnings or losses, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Rollover Accounts

Employees may rollover into the Plan, assets distributed as vested interest upon their termination from a qualified defined benefit plan or a qualified defined contribution plan in which they were formerly participants on or before the sixtieth day after the day that they received the distribution.

Vesting

Participants are immediately vested in their voluntary contributions and rollover accounts. Vesting in the Company's matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of service, vesting 20% after 2 years of service and increasing 20% each year until they become fully vested.

Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. Effective January 23, 2025, the Company's Board of Directors voted to freeze and terminate the Plan. All Plan assets were distributed to Plan participants by April 25, 2025.

Distribution of Benefits

Any benefits payable under the Plan to a participant who has retired or terminated employment for any reason other than death shall be distributed to the participant as follows: (1) if the value of the vested account balance does not exceed \$5,000, the Plan Administrator will distribute the participant's vested balance in a lump sum payment and (2) if the value of the vested account balance exceeds \$5,000, the distribution shall, at the election of the participant and with spousal consent, where applicable, be in the form of a lump sum or in partial withdrawals.

Participant Notes Receivable

Loans may be granted to participants in accordance with the Plan document. In no event shall the total of any such loan to any participant exceed the lesser of (a) 50% of the participant's vested interest in their elective deferral accounts, or (b) \$50,000. No loan shall be for a term exceeding five years, unless the loan proceeds are used to acquire a dwelling unit.

2. Summary of Significant Accounting Policies

Forfeitures

Amounts forfeited by participants shall be used to reduce employer contributions otherwise payable for the Plan year in which such forfeitures arise and for each succeeding Plan year, if necessary, until such forfeitures have been exhausted. Forfeitures can also be used to pay Plan expenses. Forfeitures in 2024 and 2023 were not significant.

Administrative Expenses

Administrative expenses of the Plan are paid by the Company, to the extent that they are not paid by the Plan.

Basis of Accounting

The accrual basis of accounting is utilized for financial reporting purposes.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investment options which invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

Investments in pooled separate accounts and collective trust funds are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned; dividend income is recorded on the ex-dividend date. Net appreciation in fair value of pooled separate accounts and collective trust funds includes realized gains and losses on pooled separate accounts and collective trust funds that were both purchased and sold during the year, as well as net unrealized appreciation of the investments held at the end of the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest.

Contributions

Contributions are recorded in the period in which payroll deductions are made. Employer matching contributions are recorded in the same period as the corresponding participant contributions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued. On February 6, 2025, the Plan was amended to adopt certain provisions in the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act).

3. Investments and Information Certified

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted by such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Empower Trust Company, LLC (Empower), the custodian, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has determined that the custodian meets the requirements of a qualified institution defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments, participant notes receivable, net appreciation in fair value of investments, dividends and interest, interest income on participant notes receivable and investment and note receivable transactions were certified by Empower as of December 31, 2024 and 2023 and for the years then ended.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets that are measured at fair value using the net asset value per share practical expedient (NAV) have not been classified in the fair value hierarchy.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value (there are no liabilities):

Pooled separate accounts and collective trust funds – Valued at NAV, which is based on the market prices of the underlying mutual funds. The Plan has no unfunded commitments for these accounts and they can be redeemed daily at net asset value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The significant investment strategies of the pooled separate accounts (measured at NAV) are as follows:

Asset Allocation – Lifecycle: These funds are model portfolios that seek to provide a high total return through the balance of growth, income and capital conservatism through a mix of equity and fixed income exposures through the target retirement date, with a greater focus on income beyond the target date.

Conservative: This fund seeks to achieve maximum current income consistent with preservation of principal and liquidity. The fund seeks to maintain a stable NAV.

Growth: These funds seek capital appreciation foremost by investing in equity securities across domestic and international markets. The secondary focus on these funds is current income.

Growth and Income: These funds seek a balance between a high level of income and the growth of capital, with a higher degree of emphasis on growth from exposure to various equity allocations.

Income: These funds seek current income with capital appreciation and growth of income, primarily by investing in fixed income securities through broad sectors of the bond market and gaining exposure to various types of credit and interest rate risk.

Value: These funds seek capital appreciation by investing in equity securities that appear undervalued.

5. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not currently taxable.

The Plan is a pre-approved plan sponsored by Downeast Pension Services, Inc. (Downeast). The IRS has issued an opinion letter for the Plan dated June 30, 2020 stating that the Plan is acceptable under Section 401(a) of the Internal Revenue Code (IRC). The Plan has been amended since the opinion letter was issued. The Plan Administrator believes that the Plan is currently being operated in compliance with the terms of the Plan and IRC and remains qualified under IRC and applicable regulations.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

6. Party-in-Interest Transactions

The pooled separate accounts are managed by Empower, the custodian of the Plan, and therefore, these investments and transactions qualify as party-in-interest. Notes receivable from Plan participants, the related interest income and transactions are also party-in-interest transactions.

The Plan pays administrative expenses to Downeast, the Plan's third-party administrator, and amounts paid to Downeast were approximately \$1,300 and \$1,500 in 2024 and 2023, respectively.

During 2024 and 2023, the Plan paid Empower approximately \$31,600 and 27,600, respectively, for program and administration services.

The Plan paid approximately \$16,100 and \$12,800 to Valmark Advisors, its investment advisory services provider using Plan forfeitures during the years ended December 31, 2024 and 2023, respectively.

7. Reconciliation to Form 5500

Participant notes receivable are reflected as a receivable on the financial statements which is different from the Form 5500 presentations for 2024 and 2023. On Form 5500, notes receivable are classified as investments under the caption "participant loans."
