## INDEPENDENT AUDITOR'S REPORT

**To the Audit Committee of Times Square  
District Management Association, Inc.**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Times Square District Management Association, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 Code of Federal Regulations (CFR) 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

### 1. DESCRIPTION OF PLAN

The Times Square District Management Association, Inc. Retirement Plan (the Plan) was adopted as of January 1, 1993. The Plan has been restated effective January 1, 2024. The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

Effective January 1, 2024, the Plan changed its recordkeeper and third-party administrator to Principal Life Insurance Company (Principal Life) and designated Principal Trust Company as its custodian. Both organizations are members of the Principal Financial Group.

#### ***General and Eligibility***

The Plan is a defined contribution plan which permits all eligible employees of the Times Square District Management Association, Inc. (the Plan Sponsor) to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees can begin participating under the Plan once they have satisfied the eligibility requirements and reached their entry date, provided they are not excluded employees. The employees who are excluded are:

- Certain nonresident aliens who have no earned income from sources within the United States
- Employees who normally work less than 20 hours per week (however, if the employee actually completes a year of service, the employee will no longer be a part of this excluded class.)

Employees are eligible to participate in the Plan for purposes of making elective deferrals as of their date of hire, which is the entry date. Employees are eligible to participate in the Plan for purposes of nonelective contributions when they have satisfied the following eligibility conditions and reached the entry date, which is the first day of the month coinciding with or next following the date on which the employees satisfied the eligibility requirements.

- Attainment of age 18
- 90 days of employment

## NOTES TO FINANCIAL STATEMENTS - CONTINUED

### 1. DESCRIPTION OF PLAN - CONTINUED

#### ***Participant Contributions***

Each year participants may contribute their annual pre-tax compensation as defined in the Plan up to the limits imposed by sections 415, 402(g) and 403(b) of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contribution). Participants direct the investment of their contribution into various investment options offered by the Plan. The Plan currently offers various mutual funds and a fixed income account as investment options for participants. All eligible employees are auto-enrolled to contribute 3% of compensation to the Plan as pre-tax deferral with 1% annual auto escalation every September up to 7% of compensation unless the participant elects otherwise.

#### ***Employer Contributions***

At the employer's discretion, the employer can make a nonelective contribution to the Plan to participants who are at least employed for 90 days. Employer's share of the nonelective contribution depends on the participant's compensation for the year. The discretionary contribution in 2024 amounted to \$253,715.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of the employer discretionary contributions, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan's adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their employee contributions and share of employer contributions into investment options offered by the Plan.

#### ***Vesting***

Participants are vested immediately in their employee contributions plus actual earnings thereon. For participants first hired before January 1, 2021, they will remain 100% vested in their accounts. For participants first hired on or after January 1, 2021, their vested percentage for certain employer contributions is based on vesting periods of service. The participants' vested percentage in their account attributable to nonelective contributions is determined under the following schedule:

#### 1. DESCRIPTION OF PLAN - CONTINUED

##### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance reduced by any outstanding loan balance, if any during the one-year period ending on the day before the new loan is made, if less. The loan is secured by the balance in the participant's account. Generally, the term of the loan may not exceed ten years. The loan must be repaid through payroll deduction. Loans currently outstanding bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through regular payroll deductions.

##### ***Benefit Distributions***

Benefit distributions are based on the vested interest of the participants' account upon retirement, death, disability, or termination of employment. The Plan also allows for hardship distributions, subject to certain Plan provisions.

##### ***Forfeitures***

At December 31, 2024 and 2023, the balance of the forfeited nonvested accounts totaled \$3,443 and \$5, respectively. These accounts will be used to pay Plan expenses and reduce future employer contributions. During the year ended December 31, 2024, the Plan sponsor's contribution were reduced by and the Plan expenses were paid in the amount of \$22,737 and \$11,555, respectively, from forfeited non-vested amounts.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

##### *Investment Valuation and Income Recognition - Continued*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income which is reinvested. Realized gains and losses on investments are recognized upon the sale of the related investments, and unrealized appreciation or depreciation is recognized at year end when the carrying values of the related investments are adjusted to their estimated fair value.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Expenses relating to investment management are paid directly by the respective investment vehicle and are included as a reduction to net appreciation (or an increase in depreciation) in fair value of investments. Other administrative expenses of the Plan, at times, may be paid by the Plan Sponsor.

##### *Subsequent Events*

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Subsequent to year-end, effective September 1, 2025, the Plan was amended to increase the maximum automatic elective deferral contribution rate from 7% to 15% of compensation.

#### **3. INFORMATION CERTIFIED (UNAUDITED)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank and Principal Trust Company, the custodians of the Plan, have certified to the completeness and accuracy of all the investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Part, IV, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### **4. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **4. INVESTMENTS AND FAIR VALUE MEASUREMENTS - CONTINUED**

The Plan's investments at fair value of \$8,585,159 and \$7,440,316 as of December 31, 2024 and 2023, respectively, represent mutual funds that are considered Level 1 in the fair value hierarchy.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2 or 3.

#### **5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Plan entered into fully benefit-responsive investment contracts, the Guaranteed Interest Balance Contract (GIBC) and Principal Guaranteed Options (PGO), with Principal Life. Principal Life maintains the contributions in general accounts. The guaranteed investment contracts' issuer provides participants with guaranteed returns. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and certain administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets.

The PGO's crediting rate is fully guaranteed and communicated in advance to the Plan Sponsor and plan participants. The contract's guaranteed crediting rate is currently reset on June 1st and December 1st every year. During 2024, the net crediting rates were 6.05% from December 1, 2023 to May 31, 2024, 5.15% from June 1, 2024 to November 30, 2024, and 4.85% effective December 1, 2024. Withdrawals and transfers are permitted at contract value, except that transfers to competing investment options are subject to an equity wash provision. If the Plan terminates its interest in the contract, amounts are generally payable in installments or as a lump sum subject to an early termination charge.

For GIBC, the guaranteed minimum interest rate will be first established at the contract date and declared in the applicable schedule for the initial composite crediting rate period. Subsequently, the guaranteed minimum interest rate will be redetermined immediately prior to each time a new composite crediting rate is announced. The guaranteed minimum interest rate established in each schedule is applicable only for the composite crediting rate period established by such schedule.

#### **5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY - CONTINUED**

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and certain administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (b) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate either contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contracts represent approximately 26% and 24% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively, and represent an obligation from Principal Life to repay as amounts come due.

#### **6. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

#### **7. TAX STATUS**

Effective January 1, 2024, the Plan has adopted a Prototype Non-standardized 403(b) Plan sponsored by Principal Life (the Principal Plan). On March 31, 2017, the Internal Revenue Service (IRS) stated in an opinion letter that the Principal Plan sponsored by Principal Life and adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC Section 403(b) and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### **8. PARTY-IN-INTEREST**

The Plan is managed by Principal Life, the Plan's recordkeeper and third-party administrator. Principal Trust Company is the Plan's custodian. Accordingly, these transactions qualify as party-in-interest transactions. Administrative fees directly paid by the Plan to the recordkeeper for the year ended December 31, 2024 amounted to \$23,683.

Certain employees of the Plan Sponsor, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

#### **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
