### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Amherst H. Wilder Foundation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Amherst H. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

***Basis for Opinion***

The following description of the Amherst H. Wilder Foundation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Amherst H. Wilder Foundation (Employer). The Plan was established on January 1, 2000 and has been amended and restated throughout the years to conform with tax legislation. The Plan was last amended and restated effective April 1, 2022. The Plan covers all employees of the Employer with the exception of union employees whose employment is governed by a collective bargaining agreement and part-time/ temporary/seasonal employees whose regularly scheduled service is less than 780 hours in the eligibility computation period. Employees who have completed one month of service and have attained age 18 are eligible to participate in the Plan. Plan entry dates are monthly. The Plan is subject to ERISA, as amended. The Board of Directors is responsible for the oversight of the Plan.

Effective January 1, 2025, the Plan was amended to add an automatic increase feature whereby eligible employees will be increased by 1% on the first day of each Plan year until they reach a maximum of 6%, unless otherwise elected. Participants are now also 100% vested immediately in their Employer discretionary profit sharing and matching contributions.

**Contributions**

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage of their compensation contributed as pre-tax 401(k) contributions and Roth contributions to the Plan. The Plan contains an automatic deferral provision whereby eligible participants will have 3% withheld from their eligible compensation, unless otherwise elected. The Plan allows participants age 50 or over to make catch-up contributions.

Each year, at its discretion, the Employer may choose to make a discretionary matching contribution to eligible participants. For the years ended December 31, 2024 and 2023, the matching contribution was equal to 75% of the first 3% of eligible earnings deferred plus an additional 50% of eligible earnings deferred that exceed 3% but do not exceed 6%.

Also, each year, at its discretion, the Employer may choose to make a discretionary profit sharing contribution, which is determined annually. Such contribution will be allocated to participants who are credited with at least 780 hours of service and who were employed by the Employer on the last day of the Plan year, unless termination is due to death, disability, or retirement (age 65). For the year ended December 31, 2024, there was no Employer discretionary profit sharing contribution authorized. For the year ended December 31, 2023, the Employer discretionary profit sharing contribution was authorized to be 1% of a participant's eligible compensation.

Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's deferral contributions, the Employer matching contributions, the Employer discretionary profit sharing contribution, and an allocation of Plan earnings or losses and expenses. Allocations are based on participant account balances or participant compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their deferral contributions and rollover contributions, plus actual earnings thereon. Vesting in the Employer's matching contributions and discretionary profit sharing contributions, plus actual earnings thereon, is based on years of credited service using a graded vesting schedule. Participants vest at a rate of 20% per year, beginning with one year of credited service. Participants are 100% vested after the completion of five years of credited service. Notwithstanding the above, participants shall, however, become 100% vested in their account upon their death or total and permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service, death, disability, or retirement, the participant may elect to receive the value of their account in the form of a lump sum, partial withdrawal or installment payments. If a participant terminates employment and the participant's account balance is not greater than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan allows in-service distributions at age 59 1/2 and hardship distributions, subject to Plan provisions. Effective in 2024, in-service distributions for qualified disaster recovery and qualified birth or adoption are now allowed due to the SECURE 2.0 Act. Participants who terminate employment with an account balance between \$1 and \$5,000 will automatically be rolled over to an Individual Retirement Account in the participant's name. Effective in 2024, the threshold was increased from \$5,000 to \$7,000 due to the SECURE 2.0 Act.

**Forfeitures**

Forfeited nonvested accounts are used to pay administrative expenses or reduce Employer contributions. Forfeited nonvested accounts totaled \$13,741 and \$71,228 at December 31, 2024 and 2023, respectively. Forfeitures of \$-0- and \$572 were used to pay administrative expenses for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$136,511 and \$45,635 were used to reduce Employer matching contributions for the years ended December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions based on the terms of the Plan document.

**Administrative Expenses**

Certain expenses related to maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Expenses incurred by the Plan are included in the statements of changes in net assets available for benefits. Fees related to the administration of participant loans and benefit payments are charged directly to the participant's account. Trustee and investment advisory fees are allocated to the participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

The Standard Insurance Company, the insurance company and qualified institution, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and the investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for benefits for the year then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Minnesota Life Insurance Company, the insurance company and qualified institution, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and the investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2023 and the statement of changes in net assets available for benefits for the year then ended.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants will become 100% vested in their Employer contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the pre-approved plan indicating that the pre-approved plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 7 PLAN TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Investments are managed by Minnesota Life Insurance Company and The Standard Insurance Company, the qualified institutions. Therefore, these investment transactions qualify as party-in-interest transactions.
