Summary of Principal Plan Provisions

Effective Date:

The Plan was established effective January 1, 2016.

Eligibility:

Participation begins on the January 1 or July 1 coincident with or next following the first anniversary following the date of hire. Participants must be at least 21 years old.

Retirement Dates:

The Normal Retirement Date is the first day of the month coincident with or next following the participant's 62nd birthday with at least 5 Years of Service.

There is no **Early** Retirement Date.

Retirement Benefit:

The annual Normal retirement benefit is calculated as 9.0% of Highest Three Years' Average Earnings times years of service, up to 100%.

Accrued Benefit:

The Accrued Retirement Benefit at any point in time is calculated as:

9.0% of Highest Three Years' Average Earnings
multiplied by years of service up to the time of calculation.

The Accrued Benefit is limited by §415(b) maximum of 10% per Year of Participating Service since the Effective Date of the Plan.

For purposes of accrual and vesting, service includes one year of service before the effective date of the plan for those participants who were employees one year before the effective date of the plan.

Vesting:

Participants become 20% vested after the second Year of Credited Service. Each additional Year of Service credits the participant with another 20% of vesting until the 100% limit is reached after the sixth year. Service before the establishment of the Plan is included in this determination.

Death Benefit:

Post-retirement death benefits are limited to those implicit in the selection of the form of annuity. The Pre-retirement death benefit is the Accrued Benefit earned through the date of death, payable as a lump sum.

Form of Annuity Payment:

The normal form of payment is a life annuity for non-married Participants. The normal form for married Participants is an unreduced joint-and-100% survivor annuity equal to the amount of the life annuity.
