SUMMARY OF PRINCIPAL PLAN PROVISIONS

Effective Date:

The plan was established January 1, 1995.

Eligibility:

Participation begins on the first day of the Plan Year following the attainment of age 21 and completion of one year of service. The Plan was frozen to new entrants as of January 1, 2013.

Retirement Dates:

The Normal Retirement Date is the Participant's 65th birthday.

A Deferred Retirement Date is any date following the Normal Retirement Date.

Retirement Benefit:

The annual normal retirement benefit is calculated as the sum of:

1 % of a Participant's Five-Year Average Compensation,

and

.65 % of a Participant's Five-Year Average Compensation in excess of the Participant's Covered Compensation,

multiplied by the Participant's Years of Service at their Normal Retirement Date not to exceed 35 years.

A Participant who postpones his retirement will continue to accrue benefits according to the plan formula until such time as he retires.

Accrued Benefit:

The Accrued Benefit for a Participant is the Normal Retirement Benefit multiplied by a fraction equal to the Participant's Years of Service at the Determination Date divided by the Participants projected Years of Service at the Normal Retirement Date. Years of Service after 2012 are not included in the determination of Years of Service at the Determination Date. However, the Accrued Benefit is never less than the Top-Heavy benefit.

Vesting:

The Participant becomes 100% vested after five years of service. For any Top-Heavy Plan Year, Participant's vesting percentage will be determined according to the following schedule:

<u>Years of Service</u>	<u>Percentage</u>
Less than 2	0%
2	20%
3	40%
4	60%
5	80%
6	100%

Death Benefit:

Post-retirement death benefits are limited to those implicit in the selection of the form of annuity. The basic pre-retirement death benefit is 100% of the Participant's Accrued Benefit.

Form of Annuity Payment:

The normal form of payment is a life annuity.

Optional forms include joint and survivor annuities, certain and life annuities, period certain annuities, contingent annuities, and lump sum payouts.
