Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of The Options Clearing Corporation Retirement Savings Plan (the “Plan”) is provided for general informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan.

General—The Plan, which became effective January 1, 1984, is a defined contribution plan offered to eligible employees of The Options Clearing Corporation (the “Corporation”) who elect to participate in the Plan. Eligible employees consist of all employees of the Corporation other than temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Fidelity Management Trust Company (the “Trustee”) serves as Trustee of the Plan’s assets. The Plan is administered by an administrative committee appointed by the Board of Directors of the Corporation.

Profit Sharing— Profit sharing contributions were discontinued effective January 1, 2022. Prior to January 1, 2022, to be eligible for the profit-sharing contribution, an employee must have been employed on December 31 of the applicable calendar year and worked at least 1,000 hours in the Plan year. The employer contribution percentage for this profit-sharing component was awarded upon Board of Director’s approval and allocated based upon an individual’s compensation.

Contributions—Each year, participants may elect to have their pretax annual compensation, as defined in the Plan, reduced up to 60%. This amount, subject to Internal Revenue Code (“IRC”) limitations, is then paid into the Plan by the Corporation on behalf of the participant. Participants may also elect Roth deferral contributions to the Plan, as well as non-Roth after-tax contributions. Effective January 1, 2022, the Corporation makes a matching contribution of 50% of pre-tax and Roth contributions up to a maximum of 12% of participant compensation. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans.

Investment Funds—Contributions are invested at the participants’ direction in various investment options offered by the Plan. Participants can change their investment elections at any time and the change will go into effect at the beginning of the subsequent payroll period. Deposits allocated to a specific fund are commingled with those of other participants and are invested in accordance with the nature of the specific fund. Pending such investment, the Trustee is authorized to invest in short-term investments.

Participant Accounts—Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, the Corporation’s matching contribution, and Plan earnings, and charged with withdrawals (if any), an allocation of Plan losses, and certain administrative expenses.

Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting—A participant’s vesting service is the total number of years and fractional years of employment with the Corporation as determined in accordance with rules established in the Plan document. Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting related to the matching and profit-sharing contributions is based on years of service as follows:

Notes Receivable from Participants—Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of either \$50,000 or 50% of their vested account balance. All loans must be repaid in level payments on at least a quarterly basis over a five-year period unless it is for the purchase of your principal residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan. Notes receivable transactions are treated as a transfer between the investment fund and notes receivable fund. Notes receivable are secured by the participants’ vested account balance and bear interest at the prevailing prime rate plus market rate adjustment determined at the time the loans are made in accordance with the terms in the Plan document. Participants are not permitted to borrow from their profit-sharing contribution account. Payments of notes receivable principal, plus interest are paid ratably through payroll deductions. As of December 31, 2024, participant loans have maturities through 2034 at interest rates ranging from 3.75 percent to 11.50 percent.

Payment of Benefits—Account balances are payable in a lump-sum amount upon retirement, disability, death, resignation, or dismissal.

Forfeited Accounts—Forfeited allocations may be used to reduce the Corporation’s matching contributions and/or pay administrative expenses. Forfeitures from participant’s accounts reduced the Corporation’s contributions by \$1,286,565 during the year ended December 31, 2024. As of December 31, 2024 and 2023, there were \$24,615 and \$19,766 in total forfeited nonvested accounts, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Although these estimates and assumptions are based on the best available information, actual results could differ from those estimates.

Risks and Uncertainties—The Plan invests in various investment instruments, including mutual funds and common collective trusts. Investment securities are exposed to various risks, such as interest rate,

credit, and overall risk and market volatility. Market risk includes the impact of global pandemics and international conflicts. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and that these changes could materially affect the value of the participants' accounts and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices.

The Galliard Stable Return Fund C ("Fund") is the collective trust stable value fund held by the Plan at December 31, 2024 and 2023, that is managed by Galliard Capital Management, LLC ("Galliard") for employee benefit plans. The Fund has invested all of its assets in the Galliard Stable Return Fund Core ("Fund Core"). Fund Core primarily invests in investments issued by insurance companies and financial institutions, including guaranteed investment contracts, bank investment contracts, and security-backed contracts. The strategy of Fund Core is to provide investors with a moderate level of stable income without principal volatility. The fair value of Fund Core is the net asset value ("NAV") of its holdings at year-end. Units are redeemed and issued daily at Fund Core's NAV. Distribution to the Fund's unitholders will be made at the NAV determined following receipt of written redemption instructions. The recorded appreciation in the Fund's fair value reflects the interest income earned by the Fund based on the returns provided by Fund Core. There is no guarantee that the Fund will be able to maintain the NAV.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Fund at contract value. Contract value is principal plus accrued interest. Certain events may limit these withdrawals or transfers at contract value, such as premature termination of the investment contract by the Plan, a termination of the Plan, establishment of a defined contribution plan that competes with the Plan for contributions, failure of the Plan to qualify under the applicable sections of the IRC, or substantive modifications to the Fund or the Fund's administration. The Plan believes that any events that would limit the ability of the stable value fund to transact at contract value with the participants in the Plan are not probable of occurring.

The Fund's crediting rates, and hence the return, may be affected by many factors, including purchases and redemptions by unitholders. The impact depends on whether the fair value of the underlying assets is higher or lower than the contract value of those assets at the time of those transactions. Crediting rates are reset quarterly.

The units of the Fund are stated at fair value within the Statements of Net Assets Available for Benefits, as determined by the issuer of the Fund, Galliard. Fair value is based on the NAV of the underlying investments.

Vanguard Target Retirement Funds (collectively, the "Target Retirement Funds") are the common collective trust funds held by the Plan at December 31, 2024 and 2023, that are managed by The Vanguard Group ("Vanguard") for employee benefit plans. The Target Retirement Funds may also invest in other common, collective or commingled trust funds maintained by unaffiliated banks and trust companies, for the limited purpose of gaining exposure to underlying funds that pursue an index strategy that is not available through Vanguard. The Target Retirement Funds are designed to provide exposure to a variety of asset classes through investments in underlying funds, with an emphasis on fixed income funds over equity funds and other funds. The fair value of the Target Retirement Funds is

the NAV of its holdings at year-end. Units are redeemed and issued daily at the Fund's NAV. Distribution to the Target Retirement Fund's unitholders will be made at the NAV determined following receipt of written redemption instructions. The recorded appreciation in the Target Retirement Fund's fair value reflects the interest income earned by the Target Retirement Fund based on the returns provided by the Target Retirement Funds. There is no guarantee that the Target Retirement Funds will be able to maintain the NAV. The units of the Target Retirement Funds are stated at fair value within the Statements of Net Assets Available for Benefits, as determined by the issuer of the Target Retirement Funds, Vanguard. Fair value is based on the NAV of the underlying investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and collective funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for investments.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid at December 31, 2024 and 2023.

Administrative Expenses—Administrative expenses of the Plan are paid by either the Plan or the Corporation, as described in the Plan documents. Participants pay administrative costs for loans, distributions and qualified domestic relation orders.

Contributions—Participant contributions and employer matching contributions are recorded when withheld or when earned, respectively.

3. FAIR VALUE MEASUREMENTS

Fair value represents the amount expected to be received to sell an asset or paid to transfer a liability in its principal or most advantageous market in an orderly transaction between market participants at the measurement date. In accordance with fair value accounting guidance, the Plan measures, records, and reports various types of assets at fair value in the Statements of Net Assets Available for Benefits.

Depending on the nature of the asset, the Corporation uses various valuation methodologies and assumptions to estimate fair value. GAAP provides a three-tiered fair value hierarchy based on the inputs used to measure fair value. The hierarchy is defined as follows:

Level 1—Quoted prices in active markets for identical assets.

Level 2—Observable inputs other than level 1 prices, such as quoted prices for similar instruments, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

Level 3—Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets. These inputs require significant management judgment or estimation.

Assets are assigned to a level within the fair value hierarchy based on the lowest level of significant input used to measure fair value. Assets may change levels within the fair value hierarchy due to market conditions or other circumstances. Those transfers are recognized at the end of the reporting period. There were no transfers of assets between levels of the fair value hierarchy during the periods presented.

The following describes the valuation techniques and inputs used for each major class of asset measured at fair value, including the level in the fair value hierarchy.

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price and are classified as level 1 in the fair value hierarchy.
- Common collective trust funds are valued at NAV on the last business day of the Plan's year-end, provided by the Trustee of the fund. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding. The investment objective of the fund is to provide participants with a stable crediting rate, safety of principal plus accrued interest and minimize volatility.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Corporation has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination or partial termination of the Plan or discontinuance of contributions to the Plan, the affected participants become fully vested in their accounts.

5. FEDERAL INCOME TAX STATUS

The Internal Revenue Service determined and informed the Corporation by a letter, dated May 16, 2011, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Plan has been amended since receiving the determination letter; however, the Corporation and Plan administrator believe the Plan and related Trust is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. RELATED PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds, which are managed by the "Trustee", and therefore, these transactions qualify as exempt party-in-interest transactions. The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund.

7. INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the information regarding the Plan as of December 31, 2024, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by the Trustee and furnished to the Plan

administrator (Corporation). The Plan administrator has obtained certifications from the Trustee that the information is complete and accurate.
