SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT OF THE 2024 FINANCIAL STATEMENTS

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of Premier Medical Group, P.C. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, as amended and restated effective January 1, 2022, is a participant directed defined contribution plan, covering substantially all eligible employees of Premier Medical Group, P.C. (the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Eligibility

All employees, other than union or leased employees and nonresident aliens, are eligible to participate in the Plan beginning the January 1 or July 1 after reaching age 21 and completing 1 year of service, as defined in the plan document.

Investment options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Contributions

Each year, participants may elect to defer up to 100% of their compensation, as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified plans. Participants may change their salary deferral percentage at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer makes safe harbor contributions equal to 100% of eligible employee salary deferrals not to exceed 4% of compensation. For 2024, the Employer also made a top heavy minimum contribution of an additional 3% for certain applicable participants. The total safe harbor and top heavy minimum employer contributions for 2024 totaled \$659,548. The Employer may also make certain discretionary contributions, as defined in the plan document. No discretionary match contribution was made in 2024.

Employer matching contributions may be discontinued in accordance with various provisions of the Plan.

DECEMBER 31, 2024

Contributions are subject to certain limitations in accordance with applicable regulatory requirements.

The Employer may, at its sole discretion, make a profit sharing contribution to the Plan. All eligible participants are categorized into groups based on their annual compensation. For the year ended December 31, 2024, the Employer made profit sharing contributions of \$1,318,828, net of forfeitures of \$17,603, in the percentages of compensation for each of the following categories: Compensation at least \$100,000 - 9.33%, compensation \$50,000 - \$100,000 - 6.35%, and compensation less than \$50,000 - 3.50%.

Participant accounts

Each participant's account is credited with the participant's contributions, allocations of Employer contributions and plan earnings, and reduced by an allocation of administrative expenses, any distributions and plan losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Employer safe harbor and top heavy contributions, plus actual earnings thereon. Vesting in the Employer profit sharing and discretionary match contributions is based on years of continuous service. Participants vest ratably over 5 years, resulting in 100% vesting after 5 years of credited service.

Participant loans

Under the terms of the Plan, participants are not permitted to borrow from their accounts.

Payment of benefits

Benefit distributions equal to a participant's vested account balance are payable to the participant or their beneficiaries upon normal retirement (age 55), death, disability or termination of employment.

Forfeitures

Forfeitures result from termination of employment under circumstances which do not entitle the participant to be fully vested in their Employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,339 and \$29,816, respectively, and are available to reduce Employer contributions. Forfeitures of \$38,994 were used to reduce Employer contributions during 2024.

ERISA recapture account

In accordance with the service agreement with the Plan Administrator, a separate account called a Recordkeeping Expense Account (REA) is used for fee recapture and for redirecting partnership and alliance amounts. The fee recapture amount is calculated on a monthly basis and is equal to (a) any aggregate fund revenue for the month plus (b) the administrative services fee (the recordkeeping fee deducted from the participant accounts), minus (c) the aggregate of the Voya Retirement Insurance and Annuity Company (VRIAC) required revenue for the month plus (d) the quarterly amount(s) calculated under the Partnership and/or Alliance TPA Reimbursement Program(s). Any surplus is deposited into the REA to cover additional plan expenses and if not used will be allocated pro rata to participant accounts. During the year ended December 31, 2024, the Plan received \$32,731 in the REA which is netted against administrative expenses on the statement of changes in net assets available for benefits. At December 31, 2024 and 2023, the account balance was \$14,400 and \$28,271, respectively, and were available to reduce administrative expenses.

In-service withdrawals

In-service distributions are available to participants that have attained age 65 with at least five years of service. The method of distribution shall be determined by the Plan Administrator in accordance with the provisions of the Plan. Participants may also receive a hardship distribution according to the safe harbor rules and regulations if certain conditions are met.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the investment advisers and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the Employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

Payment of benefits

Benefit payments are recognized in the year paid.

Expenses

The Plan is responsible for its administrative expenses unless paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Certain investment fund-related expenses are included in net appreciation in fair value of investments.

Recent regulatory update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024 and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 6, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified by VRIAC, the Trustee of the Plan.

NOTE 4 - FAIR VALUE

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using unadjusted quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

Mutual funds	Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
Collective trust funds	Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in investment securities which are exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

At both December 31, 2024 and 2023, the Plan had a concentration of investments in one fund, which represented approximately 13% of total investments.

NOTE 6 - INCOME TAX STATUS

The Plan has adopted a pre-approved plan document (Pre-Approved Plan). The Pre-Approved Plan received its latest opinion letter on November 30, 2020, in which the Internal Revenue Service ("IRS") stated the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has not applied for a separate determination letter.

The Plan Administrator and the Plan's tax counsel believe the Plan and Pre-Approved Plan are designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 7 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Plan investments are held by the Trustee, and, therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

These party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.

NOTE 8 - THIRD PARTY ADMINISTRATOR

Effective July 18, 2024, the Plan's former third party administrator was acquired by July Business Services. The Plan is still operating under the Pre-Approved Plan as of the date these financial statements were available to be issued.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
