## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
United Mailing Services, Inc. Profit Sharing Plan

### Opinion

We have audited the accompanying financial statements of United Mailing Services, Inc. Profit Sharing Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### Responsibilities of Management for the Financial Statements

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, including the form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the supplementary information in the accompanying supplemental schedule is fairly stated, in all material respects, in relation to the 2024 financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - United Mailing Services, Inc. Profit Sharing Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 8, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - United Mailing Services, Inc. is the plan administrator, sponsor and employer. RBC Wealth Management ("RBC") is the plan's investment advisor and custodian of plan assets. Sikich LLP is the third party administrator that maintains participant records and tax counsel that performs compliance testing. The sole shareholder of the plan sponsor serves as trustee of the plan.

**Investments** - The trustee directs the plan's investments. Earnings on investments bought, sold and held during the years are reflected in the accompanying statements of changes in net assets available for benefits.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

**Mutual funds** - Valued at the daily quoted market price as reported by the funds. Mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

## 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

**General** - The plan was established on January 1, 1997 as a defined contribution plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees are eligible for participation if they have reached age twenty-one and have completed one year of service (defined as 1,000 hours) either in the twelve-month period beginning on the employee's date of hire or in a plan year. Employees are enrolled on either January 1 or July 1 following the completion of the eligibility requirements.

**Contributions** - Contributions to the plan can be made on a discretionary basis by the employer, as determined by the board of directors. With certain exceptions, participants that have completed a year of service during the plan year and are employed as of the last day of the plan year are eligible to receive an employer contribution, if any. The employer made a discretionary contribution of \$100,000 in both 2024 and 2023. The contribution is allocated to participants based on their eligible plan year compensation, as defined in the agreement.

**Participant accounts** - Contributions are remitted to the plan's asset custodian, who invests them in accordance with the direction of the plan trustee. The value of each participant account is adjusted annually to reflect the earnings on investments received during the year. Each participant account is allocated a portion of the plan's investment earnings based upon their account balance at the beginning of the year less any benefit payments received during the year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** - Participants begin vesting in their participant account benefit upon two years of service, at which time they are 20% vested. Participants then vest at the rate of 20% for each year thereafter. Upon death, disability, or attainment of normal retirement age (defined as age 65) while employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions generally must be in the form of a single lump sum payment. Partial withdrawals or installments are permitted to satisfy Required Minimum Distributions obligations. In addition, hardship withdrawals are permitted in certain circumstances. In-service withdrawals are not permitted.

**Administrative fees** - Certain administrative fees of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees. There were no nonparticipant directed charges paid by the plan in 2024 and 2023.

**Forfeitures** - Forfeitures are used to either pay administrative fees of the plan, added to the employer discretionary contribution or used to reduce the employer's cash outlay for its discretionary contribution. During the years ended December 31, 2024 and 2023, forfeitures of \$2,000 and \$1,000 were added to the employer discretionary contribution and allocated to eligible participant accounts. The total unapplied forfeitures included in net assets available for benefits are insignificant as of December 31, 2024 and 2023.

**Notes receivable from participants** - Loans to participants are not permitted under the plan.

### 3. PARTY-IN-INTEREST TRANSACTIONS

RBC is the plan's investment advisor and custodian of plan assets and therefore, these transactions qualify as party-in-interest transactions. There were no direct or indirect fees paid by the plan to RBC for investment management services in 2024 and 2023. RBC receives indirect compensation from mutual fund service providers for services that RBC provides to the funds. The compensation received by RBC is used to offset certain amounts that would otherwise be owed by the plan to RBC for administrative services provided. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their participant accounts.

### 5. INCOME TAX STATUS

The plan adopted a Sikich LLP non-standardized pre-approved profit sharing plan. The pre-approved profit sharing plan received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
