Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of USG SelectBenefits Program (the "Program"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and program benefit obligations as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits and changes in program benefit obligations for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Program's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Program (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. We are required to be independent of the Program and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Program; and determining that the Program's transactions that are presented and disclosed in the financial statements are in conformity with the Program's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that audits conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1 - Program Description

The following description of USG SelectBenefits Program (the "Program") provides only general information. Participants should refer to the program agreement for a more complete description of the Program's provisions.

General

The Program was established to provide eligible employees of USG Corporation and other domestic subsidiaries (the "Corporation") the opportunity to select from certain taxable and nontaxable welfare and other benefits or receive additional cash compensation, including, but not limited to, a flexible benefits feature for active eligible employees. The medical portion of the Program covers all eligible salaried and hourly paid employees of the Corporation, while the remaining portion of the Program covers all eligible salaried and hourly paid employees of the Corporation who work at least 20 hours per week on a regular basis. The Corporation has appointed its human resources department, or its designated representative, as administrator of the Program. The Program is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Under the current program, the following benefits are provided to eligible participants: health care selectaccounts, dependent care selectaccounts, medical, dental, vision, long-term disability, short-term disability, employee and dependent life insurance (including accidental death and dismemberment coverage for employees), business travel accident coverage, retiree life insurance, and employee assistance coverage.

Employees are allowed to change their welfare and other benefits elected under the Program annually during the specified enrollment period prior to the start of each program year, as well as during certain qualifying life events.

Health Care and Dependent Care Selectaccounts Benefits

The health care selectaccounts is a self-insured medical care reimbursement program under Section 105 of the Internal Revenue Code (IRC). Participants may allocate up to \$3,200 in each program year for reimbursement of eligible medical expenses incurred during the program year and the first two and one-half months following the program year.

The dependent care selectaccounts is a dependent care assistance program under Section 129 of the IRC, where participants may allocate up to \$5,000 in a program year for reimbursement of eligible dependent care expenses that the employees' family units incurred during that program year.

The participants must make pretax contributions to the Program by electing to have their compensation reduced by an amount equal to their election for a program year. Any amounts remaining in a participant's selectaccounts after the allowable reimbursement period will be forfeited.

Retirees are not eligible to participate in the Program's flexible benefit feature.

Benefits

The Program provides medical, life insurance, and short-term disability benefits to eligible active employees and eligible dependents. Retirees who receive benefits paid from the corporation-sponsored retirement plan are enrolled for life insurance. Employees hired on or after January 1, 2002 will not be eligible for medical benefits upon retirement. Employees hired on or after January 1, 2011 will not be eligible for life insurance upon retirement.

Note 1 - Program Description (Continued)

Medical - Employees are offered a choice of a high- or low-deductible consumer-directed health plan (CDHP). The CDHP offers the standard features of a preferred provider organization (PPO) medical plan, combined with a corporation-funded health coverage account (HCA). Each year, the Corporation records an amount to each HCA to provide for payment of covered expenses up to the account maximum. The benefit received within the HCA depends on if the employee is enrolled in the high-deductible (HD) or low-deductible (LD) CDHP (\$500 (HD) or \$750 (LD) for an employee-only account or \$1,000 (HD) or \$1,500 (LD) for an employee with one or more dependents). The HCA and retirement reimbursement account (RRA) are funded only by the Corporation on a pay-as-you-go basis when claims are received and paid out of the accounts. If the entire HCA fund is not used during the year, then it is forfeited. The total HCA and RRA balances amounted to approximately \$3,400,000 and \$3,600,000 at December 31, 2024 and 2023, respectively.

Non-Medicare eligible retiree participants participate in a corporation-funded retiree health reimbursement account (the "Retiree HRA") instead of receiving medical benefits. Each year, the Corporation records an amount to each Retiree HRA to provide for payment of insurance premiums within a private insurance exchange or cover expenses. The benefit received within the Retiree HRA depends on the eligible participant's years of service and marital status upon retirement and is rolled from year to year with no expiration. Effective December 31, 2023, benefits received will continue to roll from year to year until the participant reaches age 66, at which time all accrued benefits will be forfeited. Additionally, participants over the age of 65 as of January 1, 2024 will have until December 31, 2024 to utilize accrued benefits that have rolled or have them forfeited on January 1, 2025. The total Retiree HRA balances amounted to approximately \$16,307,000 and \$15,433,000 at December 31, 2024 and 2023, respectively.

Life Insurance - The Corporation provides group insurance coverage for life and accidental death benefits for its participants. Eligible hourly employees are covered for \$50,000 in life and accidental death benefits insurance. Eligible salaried employees receive basic life and accidental death coverage equal to the participant's basic annual salary for each respective type of coverage.

The Corporation pays the entire cost of basic life and basic accidental death coverage. Participants' contributions are used to pay for supplemental life and supplemental accidental death coverage.

Short-term Disability - Hourly employees who are disabled due to injury, sickness, or pregnancy receive short-term disability income benefits weekly. The benefit is 50 percent of the employee's weekly wage up to a maximum benefit of \$575 but no less than \$50. The benefit will be paid to eligible participants for a maximum of 13 weeks if they have completed less than three years of service and 26 weeks if they have completed more than three years of service.

Funding of Benefits - The health care and dependent care selectaccounts are funded through the USG Employee Benefit Trust (the "Trust"), an IRC Section 501(c)(9) tax-exempt trust. The Northern Trust Company serves as custodian of the Trust.

The medical benefits are funded by both the Corporation and the participants, with the Corporation paying the major portion of the program costs. The Corporation pays the entire cost of basic life insurance, short-term disability, business travel accident coverage, and employee assistance program coverage. Eligible employees may elect to purchase certain welfare benefits on a pretax basis from the medical, dental, vision, and long-term disability coverages. The health care and dependent care selectaccounts are funded solely through employee pretax contributions.

Retiree participants are not required to make contributions to receive the Retiree HRA, and retiree life insurance coverage is paid by the Corporation. The Corporation may change and impose employee or retiree contribution requirements under any participating program at any time and for any reason.

Note 1 - Program Description (Continued)

Administrative Service Contracts

The Program has an agreement with Blue Cross Blue Shield of Illinois (BCBSIL) to provide certain medical coverage administrative services. Generally, BCBSIL handles the processing of claims, prepares drafts for benefit payments, and provides various data processing services to aid in program administration. BCBSIL also serves as the claims administrator for the health care and dependent care selectaccounts processing. Prescription drug administration and dental are provided by BCBSIL. Vision is provided by VSP Vision Care. Short-term and long-term disability/care, critical illness, accident, and life insurance coverage are provided by Metropolitan Life Insurance Company. The Program has an agreement with HSA bank, which administers flexible spending accounts. Certain participant contributions for the flexible spending accounts in 2024 were paid after the time frame required by the Department of Labor. The Corporation remitted these contributions during 2025 and remitted related lost earnings to the Program in 2025.

Party-in-interest Transactions

The Northern Trust Short-Term Investment Fund is managed by The Northern Trust Company or its affiliates. The Northern Trust Company is the custodian of the Program; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. However, they are exempt from the prohibited transactions rules under ERISA.

Termination

While it has not expressed any intent to do so, the Corporation has the right under the Program to modify the benefits provided to employees and to terminate the Program subject to the provisions set forth in ERISA. Upon termination of the Program, any amounts payable under the Program prior to termination shall be paid in accordance with the terms of the program document.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Program's common collective trust fund is stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The investment is valued at net asset value per share (NAV) (or its equivalent), which is based on the fair value of the underlying assets. There are no redemption restrictions or unfunded commitments on this investment.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Pharmacy Rebate Receivable

The program sponsor periodically received rebates from its prescription drug claims processor on certain eligible prescription claims by program participants. A receivable is recorded for such rebates as they are earned. As of January 1, 2021, the Corporation switched its prescription drug claims processor, which began remitting rebates to the Program when earned. There was no rebate receivable as of December 31, 2024 and 2023. Pharmacy rebates received of approximately \$7,212,000 and \$6,214,000 for the years ended December 31, 2024 and 2023, respectively, have been netted with claims payments.

Benefit Payments and Retiree Subsidies

Benefit and retiree subsidy payments are recorded upon distribution.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

The Program pays administrative expenses that primarily consist of fees paid to third-party administrators, the custodian, and the actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Corporation on behalf of the Program. During 2024 and 2023, the Corporation paid approximately \$400,000 in administrative expenses on behalf of the Program.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Program to employees' service rendered to the date of the financial statements (reduced by the actuarial present value of contributions expected to be received in the future from current program participants). Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Corporation and from existing program assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual claim costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

All retiree participants have transitioned to the fixed subsidy (HRA) plan design, and an assumption for per capita USG subsidy amount is not applicable in the retiree medical actuarial valuation.

The following were significant assumptions used in the valuations as of December 31, 2024 and 2023:

The foregoing assumptions are based on the presumption that the Program will continue. Were the Program to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Note 2 - Summary of Significant Accounting Policies (Continued)

The health care cost trend rate assumption does not have a significant effect on the amounts reported. As of December 31, 2024 and 2023, an increase or decrease in the health care cost trend rate assumption would not have an impact on the amounts reported due to the retiree participants receiving the Retiree HRA fixed subsidy.

The Program's deficiency of net assets over benefit obligations at December 31, 2024 and 2023 primarily relates to the postretirement benefit obligations. It is expected that the deficiency will be funded by the Corporation as the benefits become due and through future increase in retiree contributions. Funding for benefit obligations is not required under ERISA.

Other Program Benefits

Program obligations at December 31, 2024 and 2023 include health claims incurred and reported but not paid and health claims incurred by active participants but not reported, which are estimated by the Program's administration based on claims lag reports from insurance companies.

Risks and Uncertainties

Contributions to the Program and the program benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 30, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

The Northern Trust Company (the "Custodian") holds the Program's investment in the Northern Trust Short-Term Investment Fund and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedules of assets held at end of year and reportable transactions are based solely on information certified by the Custodian.

Note 4 - Tax Status

The Trust established under the Program to hold the Program's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code; accordingly, the Trust's net investment income is generally exempt from income taxes. The Trust has obtained a favorable tax-exemption letter dated March 10, 1992 from the Internal Revenue Service, and the program sponsor believes that the Trust continues to qualify and to operate in accordance with applicable provisions of the IRC.
