Independent Auditors' Report

To the Participants and Plan Administrator of

Opinion

We have audited the financial statements of Computer Aid, Inc. Medical Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits—modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits—modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits—modified cash basis of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits—modified cash basis for the year ended December 31, 2024, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

1. Description of the Plan

The following description of the Computer Aid, Inc. Medical Benefit Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General and Benefits

The Plan provides health benefits (medical and prescription drugs) covering the permanent, full-time employees and dependents of Computer Aid, Inc. (the Company), after 30 days of active service. The Plan was established on May 1, 1988 and the related Voluntary Employees' Beneficiary Association (VEBA) Trust (the Trust) was established on January 1, 1990. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan also provides health benefits under the Consolidated Omnibus Budget Reconciliation Act (COBRA). COBRA was effective for plan years beginning on or after July 1, 1986. The Plan is required to offer continuation of benefits for a specified period of time to qualified employees and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event as required by law.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The premiums are included in administrative expenses.

Self-Insured Benefits

All plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and then are reimbursed by the Plan's VEBA Trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions

The Company will periodically deliver to the Plan such amounts of money as shall be necessary for timely payment of all health claims and reasonable administrative expenses of the Plan.

In addition to deductibles and copayments, participants are generally required to contribute specified amounts based on applicable weekly premiums for their respective benefit elections.

COBRA premiums are paid directly to the third-party administrator and are forwarded to the Company less an administration fee. The fee is calculated based on the number of participants eligible during a given month. These premiums are reflected on the financial statements as COBRA contributions. COBRA claims are paid in the same manner as other health claims.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the modified cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America. Accordingly, additions are included in the year in which they are received and deductions are included in the year in which they are paid. Accrued income and expenses, payables and deferred expenses, which include stop loss receivables, prescription rebate receivables and administrative expenses payable, which may be material in amount, are not reflected on the accompanying financial statements. Certain material liabilities and obligations are disclosed in the notes to the financial statements.

Interest-Bearing Cash

During the years ended December 31, 2024 and 2023, interest-bearing cash consists of cash and insured savings accounts. All are held in a trust by Merrill Lynch.

Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported (IBNR) and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Self-insured claims are recorded when paid by the third-party claims processor.

Claim payments are recorded as benefits paid on behalf of participants for health claims in the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payables for health claims in the accompanying Statements of Net Assets Available for Benefits—Modified Cash Basis.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators and the custodian. These expenses are reported on the Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company and are excluded from these financial statements.

Stop-Loss Insurance

Premiums for stop-loss insurance are paid by the Company. Stop-loss refunds of \$211,220 have been included in employer contributions on the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis.

Investment Valuation and Income Recognition

The money market fund is reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when received by the trustee.

Claims Incurred but Not Reported

The Plan is self-insured for health claims up to \$275,000 per claim. Stop-loss insurance coverage is maintained for claims in excess of this amount. The Plan's liability for health claims incurred but not reported is estimated by the Plan's consultant, Hays, using actuarial data provided by the insurance providers who have been retained by the Company. Such estimated amounts are included in the benefit obligations note noted below.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

3. Benefit Obligations

4. Related-Party Transactions and Party in Interest Transactions

Certain plan functions are outsourced to a third-party. Health benefits are administered by Highmark Blue Shield (HBS) for participants in the Plan and qualify as party in interest transactions under ERISA. Fees paid by the Plan to HBS for administrative expenses amounted to \$1,340,956 for the year ended December 31, 2024.

Merrill Lynch is the custodian as defined by the Plan and qualifies as a party in interest. There were no fees paid by the Plan for cash management services for the year ended December 31, 2024.

5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the plan sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

6. Tax Status

The VEBA Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service and the plan administrator believes that the Trust, as amended, continue to qualify and to operate in accordance with the applicable provisions of the IRC, and therefore, believes that the related trust is tax-exempt.

The Plan is subject to routine audits by taxing authorities, however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

Claims incurred but not reported are calculated based on historical trends of claims reported but not settled and claims that have been incurred but not reported. Due to uncertainty inherent in the estimates and assumptions process, it is at least reasonably possible that changes in the estimates and assumptions in the near term would be material to the financial statements.

Financial instruments that potentially subject the Plan to credit risk consist of interest-bearing cash. The Plan maintains an account with a brokerage firm containing the interest-bearing cash. At times, balances may exceed the insurance limits of the Securities Investor Protection Corporation.
