Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Accurate Electric Employee Stock Ownership Plan (the “Plan”) provides only general information. Plan participants should refer to the Plan document for a more complete description of the Plan’s provisions

General

The Plan is a defined contribution plan covering eligible employees of Accurate Electric Construction, Inc. (the “Company”). The Plan includes a tax-exempt employee stock ownership plan (ESOP component) and a tax exempt 401(k) plan (non-ESOP component) under the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and sections 401(a) and 401(k) of the Internal Revenue Code of 1986, as amended (IRC). The Plan is administered by an officer of the Company and two other individuals, appointed by the Company’s Board of Directors. The trustee of the Plan is another officer of the Company, appointed by the Company’s Board of Directors. The Standard Insurance Company (Standard) is the Custodian for the non-ESOP portion of the Plan’s assets and executes all non-ESOP transactions under the direction of the Plan’s trustee. The Company is the asset custodian and executes all of the Plan’s transactions under the direction of the trustee for the ESOP-related assets. The records of the Plan are maintained by a third-party administrator.

Eligibility

A non-leased employee of the Company becomes eligible as a participant in the Plan upon reaching age 21 and one year of service. Participants commence on the entry date, which is the earlier of the first day of the first month or the first day of the seventh month coincident with or next following attainment of entry eligibility during a Plan year. As to prevailing wage provisions of the Plan, entry shall be upon the employment commencement date.

Contributions

The Plan provides for ESOP contributions by the Company. The Company’s discretionary contributions are made to the trust fund annually by the Company sufficient to cover any stock obligations and any other liabilities of the Plan as due. At the discretion of the Company’s Board of Directors, additional annual contributions may be made which are subject to certain limitations. The annual contribution may be made in the form of a contribution of cash or the Company’s common stock. The Company made ESOP contributions of approximately \$179,000 during the year ended December 31, 2024.

Each year, participants may contribute pre- or after-tax contributions up to 100% of their annual eligible compensation as defined by the Plan. Participants may also contribute rollovers from other qualified plans. Participants who have attained age 50 prior to the end of the Plan year are eligible to make catch-up contributions.

The Company, at its sole discretion, may make matching contributions for a plan year as a match, in whole or in part, to the elective deferrals made by participants for such plan year. Participants are not permitted to make elective deferrals in the ESOP portion of the Plan. There were no matching contributions made during the year ended December 31, 2024.

Contributions (Continued)

The Company shall contribute as a prevailing wage contribution an amount equal to the product of (a) a specified amount or rate per hour of service, and (b) the hours of service for a covered participant during the payroll period. Both (a) and (b) shall be determined under and as required by (c) the Davis-Bacon Act, as amended, 40 U.S.C §276a(b) as determined by the Secretary of Labor, and/or (d) any applicable similar federal, municipal or state prevailing wage statute as determined by the appropriate government official or agency, but only insofar as the above laws and regulations apply to amounts contributed as bona fide fringe benefits to a plan, fund or program to provide for the pension, retirement or death of a Participant covered by the prevailing wage provision of the Plan Document. If a participant is eligible to receive both a prevailing wage contribution and a Company discretionary contribution, the discretionary contribution will be reduced by the prevailing wage contribution for the applicable period or plan year. Prevailing wage contributions may be in the form of Company stock. Prevailing wage contributions were approximately \$11,000 during the year ended December 31, 2024.

Participant Investment Account Options

Each participant may direct their contributions and the Company's discretionary matching and safe-harbor contributions to any of the investment options available under the Plan, except for the Company's common stock.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions, Plan earnings and charged with an allocation of administrative expenses. Company contributions and forfeitures are allocated based on participants' eligible points or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their deferrals, rollovers and matching contributions into various investment options offered by the Plan.

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee may vote as directed by the Plan committee if no direction is received from the participant. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's portion of their accounts, plus actual earnings, is based on years of continuous service. A participant is 100% vested after five years of credited service. Participants who have less than five years of eligible service and are terminated due to death, disability, or retirement at age 65 or over are 100% vested. Prevailing wage contributions are immediately 100% vested.

Notes Receivable from Participants

On September 15, 2006, the Plan was amended to disallow loans. Prior to that date, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms ranged from one to five years or up to fifteen years for the purchase of a primary residence. The loans are collateralized by the participant's vested account and bear interest at a reasonable rate for loans of a similar nature made from financial institutions. Principal and interest is paid ratably through payroll deductions. Should the participant terminate, the balance of the outstanding loan becomes due and payable, and the participant's vested account will be used to repay the loan. A participant may have no more than one loan outstanding at any time. Participant loans are valued at their unpaid principal balance plus accrued but unpaid interest.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of their shares allocated to his or her account, less any shares previously diversified. In the 6th year, the percentage changes to 50%.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Payment of Benefits

Payment will either be paid as a single lump sum or installments over a period of time up to five years. A single lump sum will be paid to a terminated participant if their account balance is \$5,000 or less on the date of distribution. If the vested balance of the participant's account is greater than \$5,000 on the date of distribution, the account will be distributed in five annual installments. Distributions due to conflict of interest or death will be paid in a single lump sum.

All distributions are subject to the applicable provisions of the Plan document. Benefit payments are recorded when paid.

Forfeited Accounts

Forfeited balances from terminated participants' nonvested accounts are re-allocated annually to the remaining Plan participants in the ratio of each participant's eligible points to total eligible points of all participants. For the year ended December 31, 2023, there were ESOP forfeitures of 23.934 shares were re-allocated to Plan participants. Unallocated forfeitures totaled \$0 for each of the years December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. The fair value of Accurate Electric Construction, Inc. common stock is particularly subject to change in the near term.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses paid from the Plan represent recordkeeping and administrative fees which amounted to \$8,642 for the year ended December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (ASU) Topic 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in inactive markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, then the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Accurate Electric Construction, Inc. common stock: The fair value of the Company common stock is based on an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparable, and applicable discounts and premiums. The Trustees, under the Plan management, determines the fair value measurement policies and procedures. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At the time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

Money market fund: Valued at the net asset value of shares held by the Plan at year-end.

Registered investment companies: Valued at the daily closing price as reported by the underlying fund, which is traded on a national exchange.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan’s management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has a fully benefit-responsive guaranteed investment contract with The Standard Insurance Company ("The Standard"). The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting interest rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan.), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are investments sponsored by Standard. Other assets are invested in the stock of Accurate Electric Construction, Inc., the Plan sponsor. Transactions in these investments qualify as exempt party-in-interest transactions.

The Company provides certain accounting, administrative and investment management services to the Plan for which it receives no compensation.

NOTE 7 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

NOTE 8 - TAX STATUS

The Plan has adopted a non-standardized form of a prototype plan sponsored by Standard. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Authoritative accounting standards require the Plan to examine its tax positions for uncertain positions. Management is not aware of any tax positions that are more likely than not to change in the next 12 months or that would not sustain an examination by applicable taxing authorities.

The Plan's policy is to recognize penalties and interest as incurred in its statement of changes in net assets available for benefits.

NOTE 9 - RISKS, UNCERTAINTIES, AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.
