### **OPINION**

NOTE A - DESCRIPTION OF PLAN

The following description of the Ethos Therapy Solutions 401(k) Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of Ethos Therapy Solutions (Employer) who are age twenty-one or older and have completed 30 days of service. ETS Manufacturing, Inc. is an adopting employer and participates with Ethos Therapy Solutions in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Participants may contribute up to 100% of eligible compensation, as defined in the Plan document, up to the dollar limit established by the Internal Revenue Service. Participants are automatically enrolled in the Plan after meeting the service requirement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified defined benefit or contribution plans. The Employer may elect to make a discretionary matching contribution for eligible employees who have completed 30 days of service. No discretionary contributions were made for December 31, 2024 or 2023 Plan year.

**Participant Accounts** - Each participant's account is credited with the participant's contribution; the employer's matching contribution and an allocation of Plan earnings. Investment earnings are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their contributions and employer matching contributions into various investment options offered by the Plan.

**Vesting** - Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in the employer's contribution plus actual earnings or losses thereon is based on years of continuous service. A participant becomes 20% vested after the completion of one year of service and 20% each year thereafter until becoming fully vested after five years of credited service.

**Notes Receivable From Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear a fixed rate of interest of 4.25% to 9.5%, which commensurate with local prevailing rates at the time the loan is originated. All loans must have a definite repayment schedule, which provides for principal and interest payments to be made ratably through payroll deductions over a period not to exceed five years, except for home loans that may be repaid over a reasonable period of time that may exceed five years. Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest.

**Payment Of Benefits** - Payments of benefits are permitted in various methods depending upon whether the request for payment results from retirement, death, an event of disability or termination. The Plan does allow in-service distributions for eligible participants as permitted in accordance with the Internal Revenue Service guidelines. Balances less than \$5,000 may be paid in lump-sum distributions, without requiring participant approval.

**Forfeited Accounts** - Forfeitures of employer contributions resulting from the termination of participants with less than fully vested rights under the Plan shall be used to reduce future contributions. During 2024 and 2023, no forfeitures were reallocated to pay certain Plan expenses. At December 31, 2024 and 2023, no forfeitures were available for future use.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis Of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation And Income Recognition** – Investments in registered investment companies and collective investment trusts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use Of Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Payment Of Benefits** - Benefits are recorded when paid.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Plan Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions from the Plan are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events** - The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through October 8, 2025, the date the financial statements were available to be issued.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

**Registered Investment Companies (Mutual Funds)** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Investment Trust** - Valued at the NAV of units of a collective investment trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023, by caption on the Statements of Net Assets available for benefits within the valuation hierarchy. The Plan held no level 2 or 3 investments in either year.

NOTE E - PARTY-IN-INTEREST TRANSACTIONS

T. Rowe Price provides participant recordkeeping services to the Plan which qualifies as a party-in-interest. Fees paid by the Plan for these services were \$11,457 and \$7,242 for the Plan years ended December 31, 2024 and 2023, respectively.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2024 and 2023 were \$27,267 and \$12,095, respectively.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE G - TAX STATUS

The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan administrator timely adopted the prototype plan. The Plan administrator believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE H - RISKS AND UNCERTAINTIES

The Plan's investments include financial instruments which are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of financial instruments will occur in the near term that could materially affect the participants' account balances and the amounts reported in the accompanying financial statements.

NOTE I - PROHIBITED TRANSACTIONS

Participant contributions of \$112 were withheld from participants' pay in 2019 but were not remitted to the Plan's trust in a timely fashion. This constituted a loan from the Plan to the Plan Sponsor. These deferrals have not yet been contributed to the Plan and lost earnings have not been determined.

Participant contributions of \$283 were withheld from participants' pay during the 2023 plan year but were not remitted to the Plan's trust in a timely fashion. This constituted a loan from the Plan to the Plan Sponsor. These deferrals have not yet been contributed to the Plan and lost earnings have not been determined.

During 2021, two payroll contributions were not remitted to the Plan timely and were considered delinquent. The Employer has fully funded these delinquent deferrals; however, lost earnings have not yet been determined.

During 2022, six payroll contributions were not remitted to the Plan timely and were considered delinquent. The Employer has fully funded these delinquent deferrals; however, lost earnings have not yet been determined.

During 2023, eighteen payroll contributions were not remitted to the Plan timely and were considered delinquent. The Employer has fully funded these delinquent deferrals; however, lost earnings have not yet been determined.

During 2024, four payroll contributions were not remitted to the Plan timely and were considered delinquent. The Employer has fully funded these delinquent deferrals; however, lost earnings have not yet been determined.

The Employer will be working with the Plan's third-party administrator to fully correct these errors in 2025.

NOTE J - OPERATIONAL DEFECT

During the year ended December 31, 2023 audit, it was discovered that certain participants' loans were not properly set up for repayment. The Company will be working with the third-party administrator as well as the affected participants for correction and re-amortization of the loan agreements.
