We have performed an audit of the financial statements of Soft-Lite, L.L.C. 401(k) Plan (“Plan”) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 the related notes to the financial statements.

1 Description of Plan

The following description of the Soft-Lite, L.L.C. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan, which began October 1, 2002, is a defined contribution plan covering eligible employees of Soft-Lite, L.L.C. (“Company”) who meet the hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2025, the Plan merged into the Cornerstone Building Brands 401(k) Profit Sharing Plan. As of December 31, 2024, the Plan held assets of \$8,823,674. On January 1, 2025, these assets became assets of the Cornerstone Building Brands 401(k) Profit Sharing Plan. Subsequently, on March 1, 2025, these assets transferred to the Cornerstone Building Brands 401(k) Profit Sharing Plan.

Eligibility:

All employees of the Company, except union, leased, and non-resident alien employees, age 18 and older are eligible after one month of service. Before February 1, 2023, participants were eligible for matching contributions after two months of service.

Contributions:

Cash or Deferred Option [401(k)] - Participants may elect up to 85% of their compensation to be contributed to the Plan by the Company. An automatic election of 3% for employee elective deferral contributions is initiated for newly eligible employees and active participants. The Plan allows for automatic escalation of deferrals in the amount of 1% per year up to a maximum of 10%. Catch up contributions are allowed in accordance with Internal Revenue Service guidelines. Participants may also designate elective deferrals as Roth contributions to the Plan.

Employer Matching Contributions - The Plan allows for safe harbor contributions of 100% match of the first 3% and 50% match of the next 2% of eligible wages.

The Company may also make additional employer discretionary contributions. Such additional contributions, if any, shall be allocated to each participant in proportion to his or her compensation for the calendar year.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

Participants' Accounts:

401(k) Accounts - Each participant's account is credited with the participant's elective contributions, employer safe harbor matching contributions, employer discretionary contributions, and earnings and losses thereon.

Participants' Accounts, Continued:

Rollover contributions from other plans are also accepted, providing certain specified conditions are met.

Vesting:

All participants are 100% vested in elective deferrals, employer safe harbor matching contributions, and rollover contributions made to the Plan. Participants vest in additional employer discretionary contributions after 1 month. Employer discretionary contribution are subject to the following schedule:

Forfeitures:

Forfeitures due to termination from the Plan before a participant is 100% vested can be used to offset Company contributions or to pay Plan expenses. No forfeitures have been used as of December 31, 2024 and 2023.

Forfeited non-vested accounts totaled \$8,803 and \$3,600 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants:

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed five years with exceptions for the purchase of a primary residence. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at 2% above the prime rate. Principal and interest are paid ratably through payroll deductions.

Other Plan Provisions:

Normal retirement age is 65, however, a participant may elect early retirement on or after age 55. The Plan also provides for early payment of benefits after reaching age 59-1/2.

Payment of Benefits:

Upon termination of service by reason of retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

Investment Options:

Upon enrollment in the Plan, a participant may direct his or her contributions in any or all of the Plan's investment options.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment holder. The fair value of the investment in Voya Fixed Account (unallocated contract) is based on the value of the underlying assets held in the insurance company's general account.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

Substantially all administrative fees are paid by the Company.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

While no intent to terminate the Plan has been expressed, on January 1, 2025, the Plan merged into the Cornerstone Building Brands 401(k) Profit Sharing Plan.

Risks and Uncertainties:

The Plan's investments include investments in pooled separate accounts and an unallocated contract with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.

- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts:

The Plan invests in variable funds which are pooled separate accounts ("Account"), managed by Voya. The separate Account itself is valued at its accumulation unit value ("AUV") on a daily basis. The AUV is first established when a new fund starts and is then determined daily based on the shares of the underlying funds. The underlying funds include designated mutual funds or collective investment trusts, in some cases, which are valued daily at their net asset values ("NAV"). The fair value of the Account's assets is based on the NAV's of mutual funds and reflect the fair values of the mutual fund investments. The NAV is calculated daily upon close of the New York Stock Exchange and is based on the fair values of the underlying securities. The Plan invests in shares of the Account and not directly in shares of the open-end mutual funds themselves. As such, we have classified them in Level 2 of the valuation hierarchy.

Unallocated Contract (Fixed Fund):

The fair value of the unallocated insurance contract is based on the fair value of the underlying assets, which are held in the insurance company's general account. The fair value is expressed in units. The unallocated insurance contract is not fully benefit-responsive and is classified in Level 3 of the valuation hierarchy. Participant transactions may occur daily, there are no liquidity provisions, and there are no restrictions on redemptions.
