Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Schedule Required by ERISA

The supplemental schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The financial statements of the Plan as of and for the year ended December 31, 2023, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 14, 2024, indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with GAAP, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of the McGrath North Mullin & Kratz, PC LLO Profit Sharing / 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all employees of McGrath North Mullin & Kratz, PC LLO (the Company) who are age twenty-one or older, with the exception of union employees, non-resident aliens, leased employees, and employees not hired as regular salary/hourly employees. Company employees become eligible to participate in the Plan on January 1 and July 1 following their initial eligibility date. The Plan is administered by the McGrath North Mullin & Kratz, PC LLO Retirement Plan Committee (the Committee or Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may choose to contribute a percentage or a fixed amount of their annual pay, as defined in the Plan, provided the contribution does not exceed limitations set by the Internal Revenue Service, through either pre-tax or Roth contributions. Participants who have attained age fifty before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute rollover contributions from other qualified plans. The Company will make a nonelective Safe Harbor contribution of 3% of eligible wages and may elect to make discretionary nonelective contributions. In the current year, the Company has elected to make a contribution of 4% of participant's eligible wages. The Company made nonelective discretionary and safe harbor contributions of \$1,303,254 and \$1,277,383 for 2024 and 2023, respectively. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

Participants Accounts – Each participant account is credited with the participant's contribution, allocations of Company discretionary and Safe Harbor contributions, allocations of Plan earnings and losses, and is charged with an allocation of administrative expenses. Allocation of Plan earnings, losses, and administrative expenses is based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions and the Company's employer Safe Harbor contributions plus actual earnings (losses) thereon. Participants are vested in Company's employer nonelective contributions plus actual earnings (losses) thereon at 20% after two years of service and an additional 20% each subsequent year until the participant is 100% vested after six years of credited service.

Forfeited Accounts – Forfeitures of \$21,703 and \$4,957 were used to reduce employer contributions during 2024 and 2023, respectively. At December 31, 2024 and 2023 there were no significant forfeited non-vested accounts.

Payment of Benefits – On separation of service or when the participant has attained age 59 ½, a participant may receive a lump-sum cash settlement equal to the value of the participant's vested balance in his or her account, or the participant may elect to remain in the Plan in an inactive status until the age when required minimum distributions begin. On separation of service, if the vested account balance, excluding rollovers, is \$5,000 or less, a mandatory distribution will be made. If the vested account balance, including rollovers, is more than \$1,000 and \$5,000 or less it will be automatically rolled over to an individual retirement account.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date. Interest income is recognized as earned. Net appreciation (depreciation) in the fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recognized when paid.

Expenses – Administrative expenses can either be paid by the Company or by the Plan. Expenses paid directly by the Company are excluded from these financial statements. Investment related expenses are included within the net appreciation (depreciation) in fair value of investments.

Subsequent Events – Management evaluated transactions and events occurring subsequent to December 31, 2024, and through September 29, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

Risk and Uncertainties – The Plan invests in various investment securities which are exposed to interest rate, market and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the value will occur, that such changes could materially affect participant account balances, and the amount reported in the statements of net assets available for benefits.

3. Certified Investment Information

Certain information in the accompanying financial statements and supplemental schedule related to certain investments held as of December 31, 2024 and 2023 totaling \$67,353,664 and \$59,168,799, respectively, and net appreciation in fair value of investments totaling \$6,189,107 and \$7,468,045, and interest and dividends totaling \$2,820,679 and \$1,567,244 for the years then ended, respectively, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (Vanguard).

Self-directed brokerage accounts included in investments at fair value amounting to \$\$22,052,136 and \$20,619,810 as of December 31, 2024 and 2023, respectively, and net appreciation in fair value of investments totaling \$2,363,845 and \$2,253,909, and interest and dividends totaling \$588,248 and \$357,820 for the years then ended, respectively, are not certified.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level is based on the lowest level of any input that is significant to the measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds (CCT): Valued at the NAV of the CCT as provided by the fund's trustee. NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust to ensure securities liquidations will be carried out in an orderly business manner.

Self-Directed brokerage accounts: Accounts primarily consist of mutual funds, exchange traded funds, common stocks, treasury notes, and cash equivalents that are valued on the basis of readily determinable market prices (Level 1). Also included are corporate bonds which are valued at fair value using pricing from various sources such as issuers, investment managers, fund accountants, or default price if the price is not provided (Level 2). Level 3 securities consist of life insurance policies which are valued at the cash surrender value of the policy, which approximates fair value.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

5. Related-Party Transactions

The Plan engages the services of The Vanguard Group, Inc., whose responsibilities include investing assets, paying benefits to participants under the direction of the Plan Administrator, and performing the recordkeeping of the Plan. Administrative expenses paid by the Plan are paid to The Vanguard Group, Inc. and qualify as party in interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participant account balances become fully vested.

7. Tax Status

The Plan is a preapproved non-standardized plan created by the Company and adopted effective January 1, 2022. The Internal Revenue Service determined and issued an opinion letter for the preapproved plan as of June 30, 2020 that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan. However, the Plan administrator believes the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator believes the Plan has no significant uncertain tax positions. Therefore, no provision or liability for uncertain taxes has been recorded in the financial statements.
