## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of the Verrica Pharmaceuticals 401k, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Verrica Pharmaceuticals 401k and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 Financial Statements.

## **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Verrica Pharmaceuticals 401k’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.



### 1. Description of Plan

The following description of the Verrica Pharmaceuticals 401k (the "Plan"), provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all full-time employees of Verrica Pharmaceuticals Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Eligibility** – Employees of the Company are eligible to participate in the Plan immediately upon their employment commencement date.

**Contributions** – Each year participants may contribute up to 100% of pre-tax annual compensation as defined in the Plan and may elect to make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover) as defined in the Plan. The Plan includes an auto-enrollment provision under which newly eligible employees are automatically enrolled at a 4% deferral rate, with annual 1% increases up to a maximum of 10%. Contributions are initially invested in a designated balanced fund that may be changed by the participant. Employees can elect not to participate in the Plan.

The Company will make a safe harbor matching contribution equal to 100% of participant contributions up to 4% of eligible compensation. For the year ended December 31, 2024, the Company's safe harbor matching contributions totaled \$788,471. In addition, the Company may make discretionary profit sharing contributions. No such contributions were made for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

**Participant Accounts** – Each participant's account is credited with the participant's contributions and Company contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are 100% vested immediately in their contributions, safe harbor matching contributions, rollovers, plus actual earnings thereon. The Company's profit sharing contributions and earnings will vest under a 3-year cliff vesting schedule, where an employee is 100% vested after 3 years of service. Prior to the third year of service, the vesting percentage is zero.

**Forfeited Accounts** – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$683 and \$3,170, respectively. The Company may decide in its discretion how to treat forfeitures in any manner permitted under the Plan. These accounts may be used to reduce future employer contributions, for the payment of Plan expenses, or as additional employer contributions as described under the Plan. For the year ended December 31, 2024, \$2,500 of forfeitures were used to reduce the Company's safe harbor match.

**Investment Options** – Upon enrollment in the Plan, a participant may direct participant contributions to any of the Plan's investment options. Participants may change their investment options at any time.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than one loan outstanding at one time. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest based on the prime interest rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** – The payment of benefits under this Plan to the participant shall begin as soon as administratively feasible. Distributions are allowed in the event of termination of employment, disability, death, and retirement. Also, in-service distributions are allowed in the event of financial hardship or upon attainment of age 59-1/2, and only from fully vested accounts.

Participants must consent to any distribution from their account before reaching normal retirement age if their vested balance exceeds \$5,000. Under the Plan's involuntary cash-out provisions, participants who terminate employment with a vested account balance of \$5,000 or less are subject to mandatory distribution. Balances greater than \$1,000 but not exceeding \$5,000 are automatically rolled over to an individual retirement account designated by the Plan Administrator. Balances of \$1,000 or less are distributed directly to the participant in cash.

## 2. Summary of Significant Accounting Policies

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the investment advisor, trustee, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan document.

**Payment of Benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses directly associated with the administration of a participant's account may be charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### 3. Information Prepared and Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and net appreciation (depreciation) in the fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC as agent for Ascensus Trust Company, the custodian of the Plan, a qualified institution.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted process for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted process that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued at NAV at year-end, based on information provided by the trustee and using the audited financial statements of the trust at year-end.

### 5. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by The Vanguard Group, Inc. Certain record keeping fees are paid to The Vanguard Group, Inc. Accordingly, these investments qualify as party in interest transactions under ERISA. Additionally, certain administrative fees paid to the Plan's custodian and service providers, as well as participant loans, qualify as party in interest transactions. These transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules of ERISA.

The Plan sponsor failed to remit certain participant contributions in a timely manner during 2024, as required by Department of Labor Regulation 2510.3-102 and are considered prohibited transactions. Contributions pending full correction as of December 31, 2024 totaled \$143,855.

### 6. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### 7. Tax Status

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code ("IRC") Section 401(a). The plan administrator and the plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Subsequent Events**

Plan management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
