We have performed an audit of the financial statements of the Surface Combustion, Inc. Note 1 – Description of Plan

The following description of the Surface Combustion, Inc. Profit Sharing/401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan, as amended and restated, is a defined contribution plan covering all eligible employees, as defined in the Plan document, of Surface Combustion, Inc. (the Company and Plan Administrator) who are age 18 or older and who have completed at least one year of service with 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings (losses). Allocations of Plan earnings (losses) are based on participant account balances, as defined. Upon enrollment, participants direct the investments of their accounts among the investment funds offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000, reduced by the excess, if any, of the highest outstanding balance of any other loan from the Plan during the preceding twelve-month period, or 50% of their salary deferral and rollover account balance. Principal and interest are paid ratably through payroll deductions.

Contributions

Participants may make contributions to the Plan starting at 1% of eligible compensation, as defined in the Plan document, and up to the maximum allowable under the Internal Revenue Code (IRC). Unless participants specify otherwise, employees who become eligible to participate will be auto enrolled at an initial contribution of 3% as further defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

Note 1 – Description of Plan (continued)

Contributions (continued)

The Company may elect to make a discretionary matching contribution. For 2024 and 2023, the matching contribution was 50% of the employee's elective deferrals up to 3% of the participants' annual compensation. For the years ended December 31, 2024 and 2023, the matching contribution was \$136,889 and \$120,584, respectfully. The Company may also make a discretionary profit-sharing contribution. For 2024 and 2023, the profit-sharing contribution was 3.5% and 4% of the participants' annual compensation, respectively. For the years ended December 31, 2024 and 2023, the profit-sharing contributions was \$189,106 and \$197,165, respectively.

Payment of Benefits

Upon retirement, total disability, death, or termination, participants or their beneficiaries may elect to receive the vested value of their account in the form of a lump-sum payment, installment or annuity. Participants are also able to take a hardship withdrawal from their account, as further defined in the Plan document.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Company discretionary matching and profit-sharing contributions plus actual earnings (losses) thereon is based on years of service. Participants are fully vested after three years of credited service.

Forfeitures

Forfeited balances of terminated participant's nonvested accounts are added first as additional Company matching contributions then as additional profit-sharing contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Administrative Costs

Administrative costs for audit and trust fees, as rendered by parties-in-interest, are paid by the Plan, as described in the Plan document. Other administrative costs are paid for by the Company.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used.

As of and for the years ended December 31, 2024 and 2023, the Plan's investments were held by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (the Custodians).

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

The Empower Investments Fixed Account – Series Class II is a fully benefit-responsive investment contract valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan, it is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 3 – Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) of investments, and dividend and interest for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the Plan's Custodians.

Note 4 – Investment in Empower Investments Fixed Account – Series Class II

As of December 31, 2024 and 2023, the Plan held a fully benefit-responsive group annuity contract, the Empower Investments Fixed Account – Series Class II, with Empower Annuity Insurance Company of America. The Empower Investments Fixed Account - Series Class II is a general account product of Empower Annuity Insurance Company of America. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest crediting rate is reset quarterly. As described in Note 2, contract value is the relevant measurement attribute for this fund.

Certain events limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Such events include premature termination of the contracts by the Plan, layoffs, Plan termination, bankruptcy, mergers and early retirement incentives. In addition, the Empower Investments Fixed Account - Series Class II investment may delay a Plan Sponsor initiated withdrawal as defined in the contract. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable. There are no reserves against contract value for credit risk of Empower Annuity Insurance Company of America or otherwise.

Note 5 – Fair Value Measurement

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Note 7 – Income Tax Status

The Internal Revenue Service ruled on November 14, 2022, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan (the prototype plan upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
