We have performed an audit of the financial statements of 403(b) Thrift Plan for Employees of Betances Health Center (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the 403(b) Thrift Plan for Employees of Betances Health Center (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan established effective January 1, 2004, and restated May 1, 2019. The Plan covers all employees, excluding non-resident aliens with no U.S. source income, of Betances Health Center (the Employer). There is no minimum age and service requirement to be eligible to participate in the Plan. The Plan was amended effective April 1, 2024, to require participants to be employed for 1 consecutive month to be eligible for the Employer base contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitor investment performance.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1 percent of eligible compensation and their contributions invested in a Mutual of America Target Date Retirement Fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1 percent on the anniversary of their enrollment date until their deferral rate reaches 3 percent. The Employer makes an employer base contribution equal to 7% of the participants compensation for that Plan year. For the year ended December 31, 2024, employer base contributions totaled \$682,389. All employees are eligible to receive the employer base contribution, except for non-resident aliens with no U.S. source income, and those classified or treated as independent contractors or other non-employees by the Employer on its payroll records. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Employer's base contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 50 percent vested after two years of credited service and becomes 100 percent vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, reduced by the highest outstanding note balance of the participant within the previous one-year period. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is a variable rate set by Mutual of America and is equal to the rate credited to the Interest Accumulation Account plus 3 percent, as defined. Principal and interest are paid ratably through payroll deductions. The Plan document also allows participants to make direct payments. Terms range up to 5 years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, or for other reasons, a participant may elect to receive the value of the participant's vested interest in his or her account, as a lump sum, a single sum of a portion of their account, or in substantially equal installments over a fixed period not to exceed the life expectancy of the participant, as provided in the plan document. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed as a lump-sum distribution. In-service distributions are permitted for participants who are at least 59-1/2 years of age. In addition, the Plan allows for hardship distributions, if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$0, respectively. These accounts

will be used to reduce future employer contributions. During 2024, employer contributions were reduced by \$16,271, from forfeited nonvested accounts, in accordance with plan provisions.

Recent Regulatory Event

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act of 2022 builds on the SECURE Act of 2019 which revised existing rules around retirement saving. The SECURE 2.0 Act of 2022 contains dozens of new retirement-related provisions with effective dates beginning January 1, 2023 and beyond. SECURE 2.0 is intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers, custodian/trustee and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 8, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Pooled separate accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means. The underlying investments of the pooled separate accounts consist of mutual funds which are registered with the Securities and Exchange Commission and are carried at the net asset value (NAV) at which the mutual fund shares are actively traded. Mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily NAV and to transact at that price. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

Investment contract at fair value: The Interest Accumulation Account is part of Mutual of America's General Account (GA). Investments in the GA are liquid and not subject to any form of interest rate adjustment or loading charge. Mutual of America conducted an evaluation of the characteristics of the GA and concluded that the GA is comparable to a cash equivalent. This account is valued at contract value, which approximates fair value. The contract/fair value is based on the guaranteed principal and credited interest, not on market prices. The interest credited to this account is determined by Mutual of America and may change at its discretion. Due to the nature and characteristics of this contract, it is classified as level 2 in the fair value hierarchy.

4. Information Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Mutual of America Life Insurance Company, the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

5. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by the Custodian, and therefore, these transactions qualify as exempt party in interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Mutual of America Life Insurance Company receives revenue from investment fund service providers for services Mutual of America Life Insurance Company provides to the funds. This revenue is used to offset certain amounts owed to Mutual of America Life Insurance Company for its administrative services to the Plan. If the revenue received by Mutual of America Life Insurance Company from such investment fund service providers exceeds the amount owed for its services, Mutual of America Life Insurance Company remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to Mutual

of America Life Insurance Company for administrative expenses not covered by revenue sharing. During 2024, direct payments made by the Plan totaled \$1,890, and are included in administrative expenses.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Tax Status

The Plan adopted a prototype plan offered by Mutual of America Life Insurance Company stating that the written form of the underlying specimen plan is qualified under Section 403(b) of the Internal Revenue Code. The prototype plan received an IRS Opinion Letter dated March 31, 2017, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Delinquent Participant Contributions

For the year ended December 31, 2023, the Employer did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. These untimely remittances, which totaled \$242, constitute a nonexempt prohibited transaction under ERISA and are identified on the Schedule of Delinquent Participant Contributions for the year ended December 31, 2024. The Employer intends to compensate the affected participant for lost earnings resulting from the delay in remitting the contributions.

10. Compliance Matters

During 2024, the Employer identified that ineligible deferred compensation was included in participants' compensation for purposes of calculating their employer base contributions. The error impacted a limited number of participants and the Employer intends to correct the error and will forfeit the ineligible contributions totaling \$7,396 plus the related earnings from the affected participants' accounts as soon as administrative possible. Additionally, the Employer identified a missed deferral opportunity impacting one participant. The Employer intends to make a qualified non-elective contribution plus lost earnings to the affected participant's account for the missed deferral opportunity. The resulting qualified non-elective contribution plus lost earnings was determined to be immaterial to the financial statements as a whole, therefore, a receivable related to this matter is not included in the statements of net assets available for benefits as of December 31, 2024.
