INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
National Plus Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the National Plus Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the National Plus Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from John Hancock Trust Company LLC, a qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Report on Supplemental Information

Supplemental information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF PLAN

The following is a brief description of the National Plus Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a multi-employer defined contribution plan formed under Section 401(k) of the Internal Revenue Code for the benefit of members of UNITE HERE (the Union). Eligibility for plan participation is specified in the respective collective bargaining agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

The Trustee is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investments in coordination with the Investment Custodian.

Contributions

Participating employers contributions are made pursuant to a participant agreement with the Union or, for non-bargaining unit employees, pursuant to a participation agreement with the Trustees. Certain participants may elect to make voluntary contributions to the Plan equal to any whole percentage of their compensation, an amount per pay period, or an amount stated in cents per hour as may be permitted pursuant to the aforementioned participation agreement. Some participants must make mandatory contributions pursuant to the terms of certain collective bargaining agreements. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contribution into various investment options offered by the Plan.

Participants Accounts

Participant accounts are credited with participant's contributions and an allocation of employer contributions and plan earnings (losses). The accounts are charged with any distributions made to the participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1. DESCRIPTION OF PLAN (continued)

Vesting

Participants are fully vested in contributions made from their own funds plus actual earnings. Any participant who terminates employment with a contributing employer on or after January 1, 2014, is fully vested at all times in their employer contributions. Participants who terminated employment prior to January 1, 2014, were fully vested after two years of credited service. Any forfeited amounts may be reinstated if participants resume service with a participating employer within five years of the initial break in service.

Benefits

Upon termination of employment, retirement, death or disability, participants may elect to have vested benefits under the Plan paid in a lump sum distribution to the participant or monthly installments over a period of five, ten, fifteen or twenty years. At any time, a participant receiving installment payments may elect to accelerate the payment of benefits and receive the remainder of the participant's account in a single sum distribution of cash.

Notes Receivable from Participants

Effective February 15, 2024 participants may obtain loans from the vested value of their account. The maximum that may be borrowed is the lesser of \$50,000 or 50% of their vested account balance. The minimum dollar amount of a loan available to the Participant is \$500.00. Generally, loans must be repaid within five years/sixty months, except in limited circumstances, such as the purchase of a principal residence, in which case repayment may be made over a period not exceeding thirty years/360 months. Loan repayments may be made after termination until the earlier of the loan is paid in full or defaulted upon. The applicable interest rate that shall be assessed by the Plan against any loan incurred will equal the Prime Rate + 1 %. A participant will be permitted to have one outstanding loan at any time. Prior to the plan amendment, outstanding participant loans were a result of mergers.

Method of Accounting - The financial statements are prepared using the accrual basis of accounting.

Investments and Income Recognition - Investments are carried at fair value which generally represents the net asset value of the mutual funds and a common collective trust as of the last business day of the year as provided by the investment manager.

Purchases and sales are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fully benefit - responsive investment contract - The guaranteed investment contract is carried at contract value, which approximates fair market value.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Contributions Receivable - Contributions due and not paid prior to year-end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

Notes Receivable from Participants - Participant notes are measured at their principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. At December 31, 2024 and 2023, notes receivable from participants totaled \$1,864,257 and \$1,391, respectively, bearing interest of 5.25% - 9.50%.

Forfeitures - When certain terminations of participants in the Plan occur, any employer contributions held in participant accounts that are forfeitable under the provisions of the Plan document are held in the participant accounts until the participant has incurred a one-year break in service. Nonvested forfeited accounts are restored to the accounts of participants that return to service within five years, otherwise they are transferred from participant directed investments to unallocated investments held by the Plan. As of December 31, 2024 and 2023, the forfeited amounts totaled \$0. This account will be used to reduce future Plan administrative expenses. During the year ended December 31, 2023, forfeitures used to reduce the Plan's administrative expenses totaled \$22.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Reclassifications - Certain prior year amounts have been reclassified to be in conformity with current year presentations. The net assets remained the same.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Custodian has elected the method of compliance as permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, John Hancock Trust Company LLC, the Custodian has certified to the completeness and accuracy of allocated investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and supplemental Schedule H - Schedule of Assets Held at End of Year as of December 31, 2024 and 2023 and the related investment and notes receivable from participants activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE 4. PRIORITIES UPON TERMINATION

Although it has not expressed any intent to do so, the Trustees have the right to terminate the Plan subject to the provisions of ERISA.

NOTE 5. TAX STATUS

The Plan obtained its latest determination letter on December 18, 2014 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code, and was, therefore, exempt from federal income taxes under Section 501(a).

The Plan's administrator and the Plan's counsel believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 6. FAIR VALUE MEASUREMENTS (continued)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In accordance with Subtopic 820-10, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of net assets available for benefits.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period .

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2, or 3.

NOTE 7. BENEFIT-RESPONSIVE INVESTMENT

The Plan invests in the John Hancock Stable Value Guaranteed Income Fund, a fully benefit-responsive single group annuity contract. The assets of the contract are primarily invested in diversified fixed income securities.

Withdrawals for plan distributions, loans, hardship and transfers to other investments are permitted at full value. Withdrawals caused by Plan may either be paid out immediately, subject to a market value adjustment or at the full contract value over a period of 5 years.

NOTE 9. RELATED PARTIES

The Plan is administered by Amalgamated Employee Benefits Administrators, Inc., formerly known as Alicare, Inc. The Plan was charged \$265,165 and \$291,221 by Amalgamated Employee Benefits Administrators, Inc., for administrative services conducted for the Plan for the years ended December 31, 2024 and 2023, respectively, pursuant to approval by a committee of Plan trustees. The relationship between Amalgamated Employee Benefits Administrators, Inc., and the Plan is reviewed by a committee of Plan trustees. The Plan owed Amalgamated Employee Benefits Administrators, Inc. \$26,599 and \$23,920 at December 31, 2024 and 2023, respectively.

The National Retirement Fund (the NRF) pays substantially all general and administrative costs of the Plan, including but not limited to, payroll and related expenses, and office operations. A percentage of the total general and administrative costs of NRF is allocated to the Plan, as determined to be appropriate by the Plan's Board of Trustees. The percentage of expense allocated to the Plan was 30.50% and 15.80% of total administrative expenses incurred by NRF for the years ended December 31, 2024 and 2023, respectively. Allocated costs for years ended December 31, 2024 and 2023, totaled \$7,200 and \$16,370, respectively. As of December 31, 2024 and 2023, the Plan owed the NRF \$9,529 and \$3,200, respectively, for an overpayment of these allocated costs.

All Plan investments were in the custody of John Hancock Trust Company, LLC, the custodian, during the years ended December 31, 2024 and 2023; therefore, any transactions between the Plan and the custodian qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

NOTE 10. RESTRICTIONS OF PLAN ASSETS

Effective December 31, 2009, Hotel, Motel, Restaurant, Cafeteria, Luncheonette and Hospital Employees Local Union 4 Individual Account Fund (the “Local 4 Plan”) merged into the Plan. In accordance with the Resolution and Merger Agreement, the Local 4 Plan transferred all of its assets and liabilities to the Plan and ceased to exist on the effective date. This merger had no effect on the accrued benefits of the participants or beneficiaries of the Local 4 Plan. On December 31, 1998, the trustees of the Local 4 Plan elected to merge the net assets of a terminated defined benefit pension plan into the Local 4 Plan. Net assets of the terminated defined pension plan totaling \$1,179,313 were not distributed. Approximately \$209,000 of these net assets related to specific pension plan participants who could not be located; this amount has been recorded as a liability on the accompanying statements of net assets available for benefits. The remaining \$970,313 related to excess assets that were not allocated; this amount has been reported as reserved net assets on the accompanying statements of net assets available for benefits.

NOTE 11. RISK AND UNCERTAINTIES

The Plan investment in various types of investment securities. Investment securities are exposed to various risks, such as interest, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 12. NONEXEMPT TRANSACTIONS

There were certain employers who failed to remit employee deferrals for participant contributions within the time frame required by the Department of Labor (DOL). By DOL regulation an employer is required to segregate employee contributions from its general assets as soon as practicable but no later than fifteen business days after the end of the month in which amounts contributed by employees are withheld from their wages. Any remittances beyond that time are considered to be nonexempt or prohibited transactions by regulation. The total of these transactions was \$23,538 during the year ended December 31, 2024, respectively, which is included in the amount reported in the attached supplemental Schedule of Delinquent Participant Contributions.

NOTE 13. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
