Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lee Beverage of Wisconsin LLC 401(K) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Plan Description

The following brief description of the Lee Beverage of Wisconsin LLC 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan's summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Lee Beverage of Wisconsin, LLC. (Company), covering all employees of the Company who are age nineteen or older and have completed three months of service. The Plan entry dates are the first day of each quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator is responsible for the oversight of the plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants may elect to contribute a percentage of their pretax compensation or a Roth elective deferral that is an after-tax compensation contribution not to exceed the maximum annual dollar limit allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows participants to roll over contributions from other retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for discretionary Company contributions which are determined annually by the Board of Directors. In 2024, the Company matched 50% of participant's eligible elective deferral not to exceed \$50 per pay period for participants that are actively employed as of the last day of the plan year end and have completed 1,000 hours of service during the plan year. The Company made \$116,056 in match contributions for the plan year ended December 31, 2024.

The Company may also make a discretionary non-elective contribution. Eligible participants that are actively employed as of the last day of the plan year and have completed 1,000 hours of service during the plan year are eligible to participate in the discretionary non-elective contribution. The Company did not make a discretionary non-elective contribution for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Company matching contributions and allocations of (a) the Company's discretionary contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary reduction and rollover contributions plus earnings thereon. Company contributions and earnings thereon vest in accordance with years of continuous service. Participants are 100% vested in the Company's contributions and related earnings after three years of credited services. Participants who leave the plan because of death, early or normal retirement, or disability, as defined by the Plan, are considered 100% vested.

Notes Receivable from Participants

Effective October 6, 2023, participants may borrow from their fund accounts a minimum of \$1,000. The participant must be an active Company employee on the effective date of the loan. The aggregate outstanding balance of all loans to a participant shall not exceed the lesser of (a) \$50,000 or (b) one-half of the participant's vested account balance. The loan interest rate is set at the prime rate plus 2%. Principal and interest is paid ratably through payroll deductions. The loans are secured by the balance in the participant's account. Loans have a maximum term of five years, except for the purchase of a primary residence, which should not exceed fifteen years. Participants may have a maximum of one loan outstanding at a time.

Notes Receivable from Participants (Continued)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms on the plan document.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, financial hardship, termination of employment, or after reaching the normal retirement age of 65, as defined in the Plan agreement. The total vested portion of a participant's account balance is generally distributed in the form of a lump-sum payment. The Plan also allows for in-service distributions upon attaining age 62.

Forfeited Accounts

At December 31, 2024 and 2023 forfeitures of non-vested accounts totaled \$274 and \$3,749, respectively. Forfeited accounts may be used to reduce future plan expenses or Company contributions. Forfeitures used to reduce plan expenses was \$3,749 for the year ended December 31, 2024.

Note 2 – Summary of Significant Accounting Policies

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United State of America. The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to the fully benefit responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid for by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value investments. Fees related to the administration of payment of benefits are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under this framework are described as follows:

Level 1	Quoted prices (unadjusted) for identical assets in active markets that the Plan has the ability to access at the measurement date.
Level 2	Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities in active markets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data. If the asset has a specified (contractual) term, the level 2 input must be observable and substantially the full term of the asset or liability.
Level 3	Inputs that are unobservable and significant to the fair value measured.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the closing price as reported by the fund. Mutual funds held by the Plan are open ended mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value and to trade at the price. These mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Certified Investments

Information related to investments and notes receivable from participants included in the accompanying financial statements at December 31, 2024 and 2023 and supplemental schedule, at December 31, 2024 and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrators and certified as complete and accurate by Associated Trust Company, N.A.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary schedule.

Note 5 – Party-In-Interest Transactions

Certain plan investments were managed by Associated Trust, N.A. (Associated). Associated is the recordkeeper and custodian as defined by the Plan, and therefore, transactions with Associated qualify as party-in-interest transactions. Fees of \$34,807 for the year ended December 31, 2024 qualify as party-in-interest transactions. Other investment fees paid were netted against investment returns. Administrative expenses included investment advisory expenses and miscellaneous plan administration fees.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7 – Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, plan management believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of American requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit.
