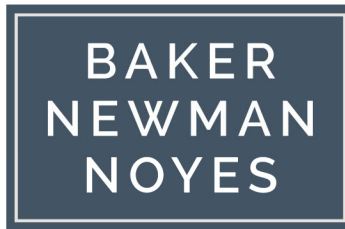

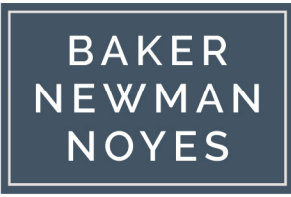

INDEPENDENT AUDITORS' REPORT

Trustees, the Plan Administrator and Participants
Cambridge Bancorp Employee Stock Ownership Plan

Opinion

We have audited the financial statements of Cambridge Bancorp Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), the related statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the changes in its net assets available for benefits in liquidation for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis

As discussed in Note 1 to the financial statements, the Board of Directors of the Plan's sponsor, voted on June 4, 2024 to terminate the Plan effective July 11, 2024 and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Plan Description

The following description of Cambridge Bancorp Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The Plan is administered by the trustees, consisting of three members of Cambridge Bancorp (the Company). The original effective date of the Plan was January 1, 1986. The Plan has been subsequently amended and restated.

On December 29, 2022, the *Consolidated Appropriations Act of 2023* was signed into law. The *Consolidated Appropriations Act* contained several provisions referred to as the SECURE 2.0 Act of 2022 (SECURE 2.0) which provided both required and optional provisions aimed at improving retirement-saving opportunities with effective dates varying across the provisions. Effective January 1, 2023, the required minimum distribution age was increased from 72 to 73 in connection with SECURE 2.0 legislation and the Plan was formally amended effective June 6, 2024

On July 12, 2024, the Company and Eastern Bankshares, Inc. (Eastern) closed their Agreement and Plan of Merger (the Merger Agreement) pursuant to which the Company merged with and into Eastern in an all-stock transaction. Under the terms of the agreement, each share of the Company's common stock was exchanged for 4.956 shares of Eastern common stock. On June 4, 2024, the Board of Directors voted to terminate the Plan effective July 11, 2024, as a result of the merger. As of the date of Plan termination, contributions to the Plan ceased and participants became 100% vested in their account balances, which will be distributed as either lump sum distributions or in shares of Eastern common stock. On July 24, 2024, the Plan applied for an advance determination as to whether the Plan meets the qualification requirements of Sections 401 and 403(a) of the Internal Revenue Code (IRC) with respect to the Plan's termination. On April 28, 2025, the Plan received a favorable determination letter from the IRS and began to process participants' final distributions. As of the date these financial statements were available to be issued, Plan investments had not been fully liquidated.

Eligibility

Employees of the Company are eligible to enter the Plan on January 1 or July 1 of each year provided they have attained the age of 21 and have completed 12 months of service with the Company, during which they have completed at least 1,000 hours of service.

Contributions and Funding Policy

Each year, the Company may make a discretionary contribution to the Plan in company stock or cash, as determined by the Board of Directors or a committee of the Board of Directors. There were no discretionary contributions for the year ended December 31, 2024.

1. Plan Description (Continued)

Voting of Shares

The Trustees shall vote all shares of Company stock held by the Plan with respect to all corporate matters upon which Company shareholders are entitled or permitted to vote. Notwithstanding the foregoing, each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all Company assets.

Participant Accounts

Each participant's account is credited with allocations of the Company's contributions and Plan earnings. A participant must complete 1,000 hours of service and be actively employed by the Company on the last day of the Plan year in order to receive an allocation of the Company contribution, unless the participant is disabled, deceased or of normal retirement age. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company common stock into investments which are more diversified. A participant who has attained the age of 55 and who has completed at least 10 years of participation in the Plan is permitted to diversify the investment of their account in assets other than Company securities. In each of the first 5 years, a participant may diversify up to 25 percent of shares allocated to their account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent.

Vesting

Participants begin vesting in their accounts after two years of service and are fully vested after six years or upon normal or early retirement, death, or disability.

Forfeitures

Non-vested balances of terminated participants constitute forfeitures which are reallocated to the remaining active participants in the same manner as the Company contribution. In 2024, forfeitures reallocated to active participants were not significant to the financial statements.

Payment of Benefits

Active participants have the option to receive dividends paid to the Plan for its investment in Company common stock in cash or have the dividend reinvested.

1. Plan Description (Continued)

Upon termination of employment for any reason, a participant or beneficiary will be entitled to the vested balance in their account in a lump-sum payment. Participants who were enrolled in the Plan on December 31, 1988 may elect to receive their distribution in equal annual installments not to exceed 10 years or a combination of lump sum and installments. Participants may request to receive distributions in Company stock, cash or a combination of both.

2. Summary of Significant Accounting Policies

Basis of Accounting

The 2024 financial statements have been prepared on the liquidation basis of accounting as prescribed by accounting principles generally accepted in the United States of America (U.S. GAAP) for a terminating plan. The 2023 financial statements were prepared on the accrual or ongoing basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with the investment in the common stock, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investment in the Company's common stock, which includes shares of Cambridge Bancorp common stock through the closing of the merger further described in Note 1 and shares of Eastern common stock for the period thereafter, is stated at fair value. Fair value per share is \$17.25 and \$69.40 at December 31, 2024 and 2023, respectively. The Company's stock is listed on the National Association of Securities Dealers Automated Quotations (NASDAQ) Capital Market. Consequently, the fair value is determined using publicly available market pricing.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments consists of unrealized appreciation of investments held during the year and realized gains or losses from sales of investments during the year.

Distributions to Participants

Distributions to participants are recorded when paid.

Contributions

Contributions are recorded when amounts are determined and approved by the Retirement Benefits Committee of the Plan.

Administrative Expenses

Administrative expenses incurred in connection with the operation of the Plan may be charged to and paid out of the Plan. The Company may elect to pay all or any portion of such expenses. All administrative expenses of the Plan were paid by the Company during 2024.

Subsequent Events

For the purposes of recognition and disclosure in these financial statements, management of the Plan has evaluated subsequent events through October 10, 2025 which is the date these financial statements were available to be issued.

3. Tax Status

The IRS has determined and informed the Company by a letter dated October 14, 2014, that the Plan is qualified and the Trust established under the Plan is tax-exempt under the appropriate sections of the IRC. The Plan Administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The updated determination letter received on April 28, 2025 referenced in Note 1, indicated that the termination of the Plan doesn't affect its qualification for income tax purposes. Therefore, the Plan Administrator and the Plan's Sponsor believe that the Plan was qualified and the related Trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 or 2023.

Common stock: The fair value is based on quoted prices of the Company's common stock, which is readily and regularly available in an active market (Level 1).

Interest-bearing cash: Valued at the carrying value which approximates fair value and is classified in Level 1 of the fair value hierarchy.

The valuation method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
