**1. Description of Plan**

The following brief description of the Consultants in Pain Medicine, PLLC 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan was amended and restated effective January 1, 2021 and is a defined contribution plan covering all employees of Consultants in Pain Medicine, PLLC, Raul G. Martinez, MD PLLC, Mark Moran MD PLLC, Shaun C. Jackson MD PLLC, and Scott P. Worrich MD PLLC (collectively the Employer), except employees who are members of a collective bargaining unit and nonresident aliens, who have completed one year of service and who are age twenty-one (21) or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

The Employer may, at its discretion, match a portion of participant contributions or make a non-elective discretionary contribution known as a profit-sharing contribution. Contributions are subject to certain limitations. The Employer did for the year ended December 31, 2024 make a safe harbor matching contribution equal to 100% of the first 3% of eligible compensation for all employees eligible to make elective deferral contributions. Additionally, the Employer for the year ended December 31, 2024 made a profit-sharing contribution equal to 100% of the first 2% of a participants' eligible compensation. Each year, participants may contribute up to a maximum limits of the Internal Revenue Code (IRC). Participants may contribute up to 100% of pretax annual income, as defined in the plan document. Participants may designate all or a portion of the deferred contributions as after-tax contributions into a Roth account. Participants who have obtained the age of 50 before the close of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

***Participant Accounts***

Participants may direct their contributions to selected investments as made available by the Plan administrator. The Plan currently offers various mutual funds, a money market fund, and self-directed brokerage accounts as investment options for participants. The self-directed brokerage account option if elected allows participants to invest in a wide array of investments including equity, debt, mutual funds of registered investment companies, and other investments as elected by the participant. Participants may change their investment options at any time.

**1. Description of Plan (continued)**

Each participant's account is credited with the participant's contribution, the Employer's contributions (if any), and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are not paid by the Employer. Allocations are in proportion to the participant account balances. Plan earnings are credited to each participant's account based upon the performance of the investments selected at each valuation date.

The benefit to which a participant is entitled is the benefit that can be derived from the participant's vested account.

***Payment of benefits***

On termination of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Any vested account balance under \$5,000 is automatically paid out as soon as administratively feasible. If the participant does not elect to have the distribution paid directly to him or herself or to an eligible retirement plan as a direct rollover, the Plan Administrator will pay the distribution as a direct rollover to an individual retirement account designated by the Plan Administrator. Hardship distributions are also available subject to certain limitations.

***Vesting***

Participants are 100% vested at all times in the accrued benefits from their elective contributions. Participants become 25% vested after two years of service and increasing 25% per year until 100% vested after the completion of four years of service in all matching and non-elective discretionary contributions made by the Employer and the earnings thereon.

***Forfeitures***

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited amounts from nonvested accounts may be used by the Plan for several purposes including reducing the Employer's matching and non-elective contributions or applied to reduce administrative expenses of the Plan. Unallocated forfeitures at December 31, 2024 and 2023 were \$9,026 and \$5,857, respectively. Forfeitures totaling \$6,000 were used to reduce Employer profit-sharing contributions in 2024.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

***Investment Valuation and Income Recognition***

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan management to make estimates and assumptions that affect the reported amounts assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of participant initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

**3. Information Certified by Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules

**4. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value in accordance with accounting principles generally accepted in the United States of America. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1           Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2           Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3           Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for major categories of investments measured at fair value:

*Level 1 Fair Value Measurements*

*Self-directed brokerage accounts.* Self-directed brokerage accounts are accounts that are managed by the individual participants and offer the participants the option of investing in funds within and outside the Plan investment options. All investments are valued at fair value using quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date (Level 1 inputs). All expenses and income associated with the participant's elections and activity are recorded at the individual participant level. Accounts primarily consist of mutual funds, common stocks, cash, U.S. governmental securities, and corporate bonds that are valued as described in this section.

*Common stocks:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Corporate bonds:* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the

Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Cash:* Held primarily in short-term money market funds, which are valued at cost plus accrued interest.

*U.S. government securities:* Valued using pricing models maximizing the use of observable inputs for similar securities.

**5. Tax Status**

The Employer adopted effective January 1, 2021, the CCH Incorporated DBA FtWilliam Com, Non-Standardized Pre-Approved Profit Sharing Plan With CODA, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in accordance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**5. Tax Status (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Related Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company, an affiliate of American Funds. Capital Bank and Trust Company is the investment custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibition of party-in-interest transactions under ERISA.

The Plan Sponsor paid certain administrative expenses related to the Plan for the year ended December 31, 2024.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8. Plan Termination**

Although it has not expressed intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all participants would become fully vested in their account balances.

**9. Subsequent Events**

Effective August 1, 2025, the Plan Sponsor changed to Texas Pain Partners, PLLC, the Plan name changed to the Texas Pain Partners, PLLC Retirement Plan, and Scott P. Worrich MD PLLC, as a participating employer, ceased participation in the Plan. These changes did not impact participant account balances, investments, or participant vesting and years of service.

Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.
