## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Evans Network Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### NOTE 1 - DESCRIPTION OF THE PLAN

---

The following description of the Evans Network Services, Inc. 401(k) Plan, formerly the Evans Delivery Company, Inc. 401(k) Plan, (the "Plan") provides only general information. The Plan was restated as of January 1, 2023, as part of the restatement, the Plan name changed. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering all employees of Evans Network Services, Inc. and any participating affiliates (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan administrator is responsible for oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitors investment performance.

##### **Eligibility**

Effective January 1, 2024, employees who have completed three months of service and are age 18 or older are eligible to participate in the Plan. Prior to January 1, 2024, employees were eligible when they completed one year of service and reached the age of 21. Employees are enrolled in the Plan on the first day of the month following when eligibility requirements are met.

##### **Contributions**

Each year, participants may contribute up to 90% of annual compensation on a pre-tax or after-tax basis effective January 1, 2024 in accordance with Roth provision, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions equal to 100% of elective salary deferral contributions up to 4%. The Company may make discretionary contributions to participants based on eligible compensation. In addition, the Company may also make a qualified nonelective contributions ("QNEC") to the Plan. There were no discretionary contributions made for 2024 or 2023. The Company paid a QNEC to the Plan in the amount of \$1,849, for the year ended December 31, 2023 to correct participant deferrals identified by management. The QNEC was included in employer contributions receivables on the statements of net assets available for benefits and employer contributions on the statement of changes in net assets available for benefits. There were no QNEC contributions made for 2024. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the safe harbor matching contributions as well as allocations of the Company's discretionary contributions, QNEC's and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE 1 - DESCRIPTION OF THE PLAN - CONTINUED

---

##### **Vesting**

Participants are vested immediately in their contributions, safe harbor matching contributions, and any QNECs made by the Company plus actual earnings thereon. Vesting in the Company's discretionary contributions is based on years of service as defined in the plan document. A participant is 100% vested in the Company's discretionary contributions after five years of credited service.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Effective June 5, 2024, the loan interest rate is set 2% above the prime rate, as defined. Prior to June 5, 2024, the loan interest rate was set 1% above the prime rate, as defined. Principal and interest are paid ratably through weekly payroll deductions.

##### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For payments of benefits for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or through a partial amount (payments of a portion of a participant's account that are not regularly scheduled). In addition, the Plan allows for hardship distributions if certain criteria are met.

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,163 and \$0, respectively. These accounts will be used to reduce future Company contributions or offset Plan expenses. Also, in 2024, employer contributions were reduced by \$4,738 from forfeited nonvested accounts.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

---

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers, custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to a fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Investment Concentration**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Company safe harbor contributions and discretionary contributions are recorded in the year services are rendered. Company QNEC contributions are recorded in the year in which the error occurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Deemed Distributions**

Participant loans that fail to comply with the terms of the plan may be treated as deemed distributions under Internal Revenue Code. A deemed distribution is reported as a taxable event to the participant in the year of default but does not result in an actual distribution of plan assets. These loans remain part of the plan's assets until they are repaid, offset, or otherwise resolved in accordance with plan provisions and applicable IRS regulations.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### **Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - FAIR VALUE MEASUREMENTS

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* The fair value of the investments in this category has been estimated using the net asset value ("NAV") per share as a practical expedient. The NAV of these accounts is based on the market value of its underlying investments. The NAV of these accounts is not a public-quoted price in an active market.

**NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

---

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company ("Lincoln") totaling \$2,066,201 and \$1,950,700 for the years ended December 31, 2024 and 2023, respectively. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT - CONTINUED

---

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

---

Certain Plan investments are managed by Lincoln National Life Insurance Company. Lincoln National Life Insurance Company is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as exempt party-in-interest transactions. Other transactions, which may be considered related-party or party-in-interest transactions, relate to normal plan management and administrative services, and the related payment of fees.

#### NOTE 6 - PLAN TERMINATION

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer discretionary contributions.

#### **NOTE 7 - TAX STATUS**

---

The Company has adopted a prototype non-standardized pre-approved profit-sharing plan with CODA sponsored by CCH Incorporated DBA ftWilliam.com. The prototype non-standardized pre-approved profit-sharing plan has received an opinion letter from the IRS dated June 30, 2020, as to the prototype non-standardized profit-sharing plan's qualified status. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE 9 - CERTIFIED INVESTMENTS**

---

Certain information in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln National Life Insurance Company (the custodian of the Plan).

#### NOTE 10 - DELINQUENT PARTICIPANT CONTRIBUTIONS

---

The Company did not remit certain participant contributions to the Plan totaling \$1,858 during 2023 on a timely basis as defined by the Department of Labor. The delinquent participant contributions result in a prohibited transaction totaling \$1,858, which is separately reported on Schedule H, Line 4a - Schedule of Delinquent Participant Contributions. The Company computed lost earnings on these 2023 deferrals and subsequently remitted the deferrals and has made a contribution for lost earnings to the plan in 2024.

#### NOTE 11 - OPERATIONAL DEFECTS

---

During the year ended December 31, 2024, it was discovered that certain of the Plan's provisions were not properly applied in the daily operation of the Plan. The definition of compensation for participant and employer contributions as per the plan agreement was not properly applied when calculating contribution amounts for certain payroll periods during 2024. The plan administrator determined that a qualified nonelective contribution in the amount of \$1,138 is required to make the affected participants and the Plan whole, including lost earnings, which has been funded by forfeitures in 2025, resulting in no additional receivable recorded on the statements of net assets available for benefits as of December 31, 2024.

During the year ended December 31, 2023, it was discovered that certain of the Plan's provisions were not properly applied in the daily operation of the Plan. The definition of compensation for participant and employer contributions as per the plan agreement was not properly applied when calculating contribution amounts for certain payroll periods during 2023. The plan administrator determined that a qualified nonelective contribution in the amount of \$1,849 is required to make the affected participants and the Plan whole, including lost earnings, which is included in employer contributions receivables on the statements of net assets available for benefits as of December 31, 2023. Additionally, it was discovered that certain participant Safe Harbor Contributions were not made during the year ended December 31, 2023. The plan administrator determined that the missed amount and related lost earnings were in the amount of \$2,845 and this amount was recorded as a receivable for the year ended December 31, 2023. The Company has corrected the operational defects in 2024.
