Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1. DESCRIPTION OF PLAN

The following description of the Brookgreen Gardens Matching Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 01, 1999 and is a tax deferred annuity or 403(b) plan covering all employees of Brookgreen Gardens (“the Organization”). Employees of the organization are eligible to become participants in the Plan on the first pay period after hire date. Participants who have reached age twenty-one, worked 1,000 hours and have 12 months of service are eligible for the Company match. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Plan Administration

The Plan is administered by the Chief Financial Officer and Vice-President of Finance which is appointed by the Board of Trustees of the Organization. The Plan’s trustees, Lincoln Financial Group Trust Company, Inc., Voya Life Insurance and Annuity Company, and The Corebridge Financial Inc (the “Trustees”), are responsible for the custody, recordkeeping, and management of the Plan’s assets.

Contributions

Each year, participants may defer up to the maximum allowable by Internal Revenue Code (IRC) Sections 403(b). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also rollover an amount from another plan to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

From Plan Year to Plan Year, the Organization will determine the uniform matching percentage to be contributed on behalf of each employee who is eligible for employer contribution. Beginning in 2005, the discretionary contribution was 2% of annual salary and increased to 4% in 2021 for eligible employees and matching three-quarter of the employee’s elective deferrals up to a maximum 5% of that employee’s salary per annum.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions and allocations of (a) the Organization’s contributions and (b) Plan earnings and (c) an allocation of administrative expenses. Allocations are based upon the participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account, and actual earnings thereon, is based on years of continuous service. Employer matching and profit sharing contributions will be vested in accordance with the following schedule:

Each year the participant must complete at least 1,000 hours of service to receive a credit for a Year of Vesting service.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, an annuity based on life expectancy, or rollover to an eligible retirement plan. Unless the participant elects otherwise, the distribution of benefits shall begin no later than 60 days after the plan year-end.

A participant may be eligible for distribution of the vested account balance, prior to the separation from service, in the event of a “financial hardship”. A participant can also take a distribution of fully vested account balances when they reach age 59.5 while still working and they can take a distribution of their rollover contribution account balance at any time. Other withdrawals and benefit payments may be allowable under certain provisions of the plan document.

Forfeitures

Forfeitures held in an account will be used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,149 and \$7,445 , respectively. These accounts may be used to reduce plan administrative expenses and fund additional employer contributions.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and includes all adjustments necessary to present fairly the financial statements of the Plan in conformity with the accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation or depreciation in fair market value of investments for such investments.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Participants may borrow amounts from the Plan. General guidelines are that the minimum loan amount be \$1,000, and the maximum number of loans you can have outstanding at any one time is two (2). The loan is limited to the lesser of \$50,000 minus the highest outstanding balance of loans in the past twelve (12) months or 50% of vested account balance. The loan must be repaid within five (5) years from the date of the loan and repaid at a frequency of at least a per payroll basis or if a loan is for the purchase of a home, the repayment period is ten (10) years.

Notes receivable from participants are measured at the unpaid balances along with any accrued but unpaid interest. No allowances for credit losses have been recorded as of December 31, 2024 and 2023, as the participant notes are secured by the participant's vested balance in their account. Delinquent participant loans, if any, are reclassified as a distribution based on the terms of the plan document. As of December 31, 2024 and 2023, outstanding loans totaled \$159,747 and \$91,441 respectively.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Organization (Plan Sponsor) or the Plan, as provided in the Plan document. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and included in administrative expenses.

NOTE 3. INFORMATION CERTIFIED BY THE TRUSTEE

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, no audit procedures have been performed on certain information certified as complete and accurate by the Lincoln Financial Group Trust Company, Inc., Voya Life Insurance and Annuity Company, and The Corebridge Financial Inc, (“the Trustees”), except to compare such information to the information included in the accompanying financial statements and supplemental schedule. Information certified by the Trustees includes investments and notes receivable from participants included in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, investment related income and interest on notes receivable from participants as included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and investments included in the Schedule of Assets (Held at End of Year).

NOTE 4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Pooled Separate Accounts: Valued at fair value of participant units held by the Plan at the year end, as reported by the investment manager of the fund, net of the reduction of deferred sales, charges or surrender charges. These PSAs are valued daily based on the market value of the underlying net assets in each separate account. The net asset value (NAV) is calculated in a manner consistent with GAAP for investment companies. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted. These PSAs are classified as Level 2

Guaranteed Investment Contracts: Valued at fair value that the plan would have received if the contract(s) had been terminated, which is book value less the potential surrender charges and market value adjustments. The NAV is calculated in a manner consistent with GAAP for investment companies. The reported values for fixed annuity options are reported daily by the annuity provider according to the methods described in the annuity contract. The annuity contract disclosures for pricing methods are considered an unobservable input.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. INVESTMENT CONTRACTS WITH INSURANCE COMPANY

In 2001, the Plan entered into a non-benefit-responsive group annuity contract with Voya Life Insurance and Annuity Company (Voya). The contract is included in the financial statements at fair value.

The contract provides investment options to invest in non-benefit-responsive guaranteed interest accounts and pooled separate accounts with Voya. Voya maintains the contributions in a general account. The guaranteed interest account is credited with a guaranteed and fixed rate of return for a specified period of time as determined or allowed by Voya in advance. The guaranteed interest account is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan by Voya. The guaranteed interest account provides contract value for a benefit event, such as termination, death, disability, or retirement. However, it may be subject to a potential surrender charge and market value adjustment when funds are withdrawn prior to their maturity or for a non-benefit event, such as a withdrawal from the account for a change in investment option. A non-benefit event is withdrawn at a maximum of 20% per year until fully withdrawn. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The interest rate in the guaranteed interest account was 3%.

NOTE 5. INVESTMENT CONTRACTS WITH INSURANCE COMPANY (CONTINUED)

The VALIC Fixed Accounts are credited with earnings on the underlying investments and reported at contract value which approximates fair value. The minimum guaranteed interest rate varies by participant and depends on the date the participant established their account.

In 2017, the Plan entered into a contract with Lincoln Retirement Services Company, LLC to offer the Lincoln Stable Value Account, which is a group fixed annuity contract issued by Lincoln National Life Insurance Company. The assets placed in the Stable Value Account are invested by Lincoln who pays investors in the account a credited interest rate. The method of crediting interest for the Stable Value Account is based on an external index and Lincoln guarantees a minimum credited interest rate of 1%.

NOTE 6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts and guaranteed interest accounts issued by Lincoln Financial Group Trust Company, Inc., Voya Life Insurance and Annuity Company (Voya) and Corebridge Financial Inc. Lincoln is the record keeper and trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. Voya and Corebridge are trustees of the Plan and therefore, these transactions qualify as party-in-interest transactions. 3G Retirement Services, LLC provides administrative services to the plan for a fee and therefore, these transactions qualify as party-in-interest transactions. During 2024, amounts paid to parties-in-interest for administrative member requested service fees and administration fees were \$4,031 paid directly by the Plan Sponsor to 3G Retirement Services, LLC and \$44,938 paid by the Plan to Lincoln Financial Group.

The Plan has notes receivable from participants at December 31, 2024 and 2023. As a result, these receivables and all transactions relating to these receivables qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer contributions.

NOTE 8. TAX STATUS

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the Internal Revenue Code ("IRC"). The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the Plan's Trustee by letter dated March 31, 2017, that the prototype plan document was designed in accordance with applicable sections of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan is reviewed by the Plan Administrator to ensure that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS. The Plan is not currently undergoing examination of any previously filed tax returns; however, the returns filed for the most recent three (3) years remain available for examination by taxing authorities. The Plan is not aware of any tax position in the returns which have less than a 50% of being affirmed under examination.

NOTE 9. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as an international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued. No events were identified that require adjustment to or disclosure in the financial statements.
