#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of **ENVIRONMENTAL DESIGN & RESEARCH, P.C. 401(k) PLAN**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### NOTES TO FINANCIAL STATEMENTS

#### NOTE 1 – DESCRIPTION OF PLAN

---

The following description of Environmental Design & Research, P.C. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution plan covering all employees of Environmental Design & Research, Landscape Architecture, Engineering & Environmental Services, D.P.C. (the “Plan Sponsor” or the “Company”) employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s retirement committee is responsible for oversight of the Plan. The Plan’s retirement committee determines the appropriateness of the Plan’s investment offerings and monitors performance.

##### **Eligibility**

The Plan covers all employees of the Company except nonresident aliens and union employees, who have attained 18 years of age and three months of service.

##### **Contributions**

Employees who are eligible to participate may elect to defer up to the maximum amount allowed under the law into the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. These contributions belong to the participant and cannot be forfeited for any reason. Roth contributions are allowed.

In addition, the Company makes a safe harbor matching contribution equal to 100% of participant elective deferrals that do not exceed 3% of the participant’s compensation, plus 50% of the amount of the participant’s elective deferrals that exceed 3% of the participant’s compensation, but do not exceed 5% of the participant’s compensation. During the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions to the Plan of \$724,209 and \$630,958, respectively. Discretionary profit sharing contributions may be made at the option of the Plan Sponsor. There were discretionary profit sharing contributions of \$895,970 and \$-0- for the Plan years ended December 31, 2024 and 2023, respectively. Contributions are subject to certain IRS limitations.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and Company matching, safe harbor and discretionary profit sharing contributions, rollover contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administration expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their pre-tax, Roth and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company’s non-elective profit sharing and employer matching portion of their account is based on years of continuous service. Participants are vested based on qualifying years of service as follows.

**Notes Receivable from Participants**

Active participants may only have one note outstanding at a time. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms of the note receivable range from one to five years, or longer for the purchase of a primary residence. Notes are secured by the balance in the participant's account and bear interest at the prevailing market rates (prime rate +1%) at the time of issuance. Principal and interest are paid ratably through payroll deduction.

**Payment of Benefits**

Upon termination of service due to death, disability, separation of employment, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Account balances less than \$7,000 will automatically be distributed by the Plan upon a distributable event. A participant may, upon attainment of age 59½, elect to receive all or a portion of their vested account balance while still employed.

**Hardship Withdrawals**

Hardship withdrawals are permitted and subject to certain limitations imposed by the Internal Revenue Service and specified in the Plan Document.

**Forfeited Accounts**

Upon termination, participants' non-vested account balances are forfeited. Forfeitures may be used to reduce any employer contributions. For the years ended December 31, 2024 and 2023, no forfeiture balance was used to reduce employer contributions. Forfeited non-vested accounts totaled \$25,593 and \$24,622 for years ended December 31, 2024 and 2023, respectively.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

---

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee and recordkeeper. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are charged directly to the borrowing participant's account and are included in the participant's outstanding loan balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan Sponsor. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

Management has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Money Market Fund:*** Valued at the net asset value, based on quoted market prices in active markets, of shares held by the Plan at year end.

***Mutual Funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Investment Contract with Insurance Company:*** An investment contract with VOYA Retirement Insurance and Annuity Company. Plan management has determined the investment with VOYA Retirement Insurance and Annuity Company is not fully-benefit responsive due to restrictions that apply to transfers and withdrawals from the account. The market value is determined by comparing the contract agreement to the 7-year Treasury Bond rate, the fixed account interest rate, and the date of contract issuance.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST  
TRANSACTIONS**

---

VOYA Retirement Insurance and Annuity Company is the trustee of the Plan's assets. As such, transactions between VOYA Retirement Insurance and Annuity Company and the Plan qualify as party-in-interest transactions. Transactions involving participant notes receivable also qualify as party-in interest transactions. As described in Note 2, the Plan Sponsor paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA and are exempt from prohibitive transaction rules.

#### NOTE 6 – PLAN TERMINATION

---

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### NOTE 7 – TAX STATUS

---

The Plan Sponsor adopted a new prototype plan agreement during the current year. The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

The Plan administrator and Plan's tax counsel believe that the Plan is designed and is being operated in compliance with applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 8 – RISKS AND UNCERTAINTIES

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
