## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**NOTE 1 - PLAN DESCRIPTION**

The following description of The Marken 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Marken LLP (the "Company") who have completed three months of service and are age 21 or older with the exception of employees covered by a collective bargaining agreement, leased employees and nonresident aliens who do not receive any United States earned income from the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration: The Plan is administered by certain employees of the Company (the "Plan Administrator"). The Plan's assets are maintained by Fidelity Management Trust Company (FMTC), the trustee of the Plan. Fidelity Investments Institutional Operations Company, Inc. is the record-keeper of the Plan.

Contributions: Participants may contribute up to 60% of eligible compensation as defined in the Plan agreement, subject to the maximum amount allowed by Internal Revenue Service guidelines. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan allows for discretionary employer matching contributions. For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 100% of the first 3% of deferred compensation and 50% of the next 2% of deferred compensation up to a maximum of 4% of eligible compensation each payroll period.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's discretionary matching contributions, and (b) Plan earnings/(losses) and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan. Participants may change their investment options at any time during the year.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their deferral contributions and rollover contributions plus actual earnings thereon. Vesting in discretionary employer matching contributions, plus earnings thereon, is based on years of credited service. Participants are fully vested after three years of service as follows:

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum as defined in the Plan document. If a participant's vested balance is \$1,000 or less, it will be automatically distributed upon termination. If the vested balance is greater than \$1,000 but less than \$5,000, the Plan administrator will direct the trustee to distribute the amount as an automatic rollover into an individual retirement account. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½. Distributions are allowed from a participant's rollover account at any time.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear a fixed rate of interest commensurate with prevailing rates as determined by the Plan Administrator. All loans are covered by demand notes and are repayable through payroll deductions. Participants may not have more than one loan outstanding at any time. The term of the loan must not exceed five years, except for qualified home loans in which the Plan Administrator establishes the specific terms and conditions of such notes.

Forfeitures: Forfeitures of discretionary employer match contributions may first be used to pay administrative expenses and then used to reduce employer contributions. As of December 31, 2024 and 2023, forfeitures available to reduce future contributions or administrative expenses totaled \$217,260 and \$75,452, respectively. There were no forfeitures applied against employer retirement contributions or administrative expenses for the years ended December 31, 2024 and 2023.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation/(depreciation) reported by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, risks pertaining to a pandemic and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 4 - FAIR VALUE MEASUREMENTS AND DISCLOSURES**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

**NOTE 4 - FAIR VALUE MEASUREMENTS AND DISCLOSURES**

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - INCOME TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the Volume Submitter Defined Contribution 401(k) prototype document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

**NOTE 5 - INCOME TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan invests in shares of mutual funds issued by Fidelity Investments, an affiliate of FMTC, the Plan trustee. Transactions in such investments and the Plan's payment of recordkeeping and investment management fees to FMTC and affiliates of FMTC qualify as party-in-interest transactions. Some administrative expenses of the Plan are paid directly by the Company. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 3, 2025, which is the date the financial statements were available to be issued.
