**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Durand, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### **Responsibilities of Management for the Financial Statements**

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF PLAN

The following description of the Durand, Inc. ("Organization") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** --- The Plan is a defined contribution plan established January 1, 1988 and restated January 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The board of trustees is responsible for oversight of the Plan. The finance committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's board of trustees.

The Plan's sponsor appointed John Hancock Life Insurance Company (the "Custodian") as custodian of the Plan's assets. Under the terms of the agreement between the Custodian and the Plan, the Custodian has the primary duty and responsibility to administer, manage and control the assets of the Plan. The Estate and Pension Advisory Board (the "Third-Party Administrator") is the third-party administrator of the Plan.

**Eligibility** --- All employees of the Organization are eligible to participate in the Plan except for non-resident aliens who receive no compensation from the employer which constitutes U.S. source income, those covered by collective bargaining agreements, leased employees, substitute counselors and respite counselors. Eligibility requirements per the Plan specify that the employee attain the age of 21 and with at least one year of service. Employees are able to enter the Plan on January 1<sup>st</sup> or July 1<sup>st</sup>, following the date upon which they meet the eligibility requirements.

**Contributions** --- Each year, participants may elect to contribute up to 100% of pretax annual compensation, as defined in the Plan document, subject to limitations specified in the Internal Revenue Code ("IRC"). Participants who have attained the age of 50 before the close of the calendar year are eligible to make catch-up contributions as specified in the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover").

For the years ended December 31, 2024 and 2023, the Plan Sponsor matched 100% of employee contributions up to 3%, plus 50% of employee contributions between 3% and 5%. The Plan sponsor can elect to make a discretionary matching contribution on behalf of each participant. For the years ended December 31, 2024 and 2023, the Plan sponsor did not exercise the discretionary match election.

**Participant accounts** --- Each participant's account is credited with the participant's contributions and the Organization's contributions, Plan earnings and an allocation of investment expenses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** --- Participants are fully vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service and follows the chart below. Moreover, participants are fully and automatically vested in their accounts after becoming eligible for retirement, incurring a disability prior to termination, or upon death.

**Notes receivable from participants** --- Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum amount that may be borrowed from a qualified plan without being subject to income tax (currently, \$50,000 or, if less, 50% of the value of a participant's non-Roth vested account balance). This amount may be further limited by the provisions of the contract or if participants have other loans under this plan. The loans are secured by the balance in the participant's account and bear interest equal to the Prime rate plus 2%. Loans in the plan bear interest at a rate that ranges from 5.25% to 10.50% for the year ended December 31, 2024 and 5.25% to 10.50% for the year ended December 31, 2023. Principal and interest are paid ratably through payroll deductions. The term of the loan may not exceed five years unless it is used to acquire the participant's principal residence.

**Payment of benefits** --- Benefits are recorded when paid. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment distributions solely to the extent necessary to satisfy the required minimum distribution rules of the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeited accounts** --- At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,109 and \$1,075 respectively. These accounts will be used to reduce future employer contributions. During the years ended December 31, 2024 and 2023 there were no forfeitures applied to reduce employer contributions or pay Plan expenses in either year.

**Hardship withdrawals** --- Upon proof, to the satisfaction of the Plan administrator of an immediate and heavy financial need, amounts contributed by the employee may be withdrawn for a hardship purpose. A participant may withdraw up to 100% of their elective deferral balance and up to 100% of their vested interest in matching contributions and non-elective contributions accounts to pay for a financial hardship. Terms are specified in the plan document.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** --- The financial statements of the Plan are prepared on the modified cash basis of accounting, a special purpose framework. Therefore, with the exception of appreciation or depreciation in the market value of investments, income and expense items are recognized only as cash is received or paid and receivables (other than loans receivable from participants), payables and accrued expenses are not reflected.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Use of estimates** --- The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Significant estimates in the accompanying financial statements include the Plan's investments that are stated at net asset value ("NAV") as reported to the Plan by the Custodian, based on the market values of the underlying assets. The pooled separate accounts invested in by the Plan do not publish a daily NAV, thus NAV is a practical expedient in determining the fair value of the fund. Actual results could differ from those estimates.

**Investment valuation and income recognition** --- Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** --- Notes receivable from participants represent participant loans that are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a deemed distribution is recorded.

**Payments of benefits** --- Benefits are recorded when paid.

**Expenses** --- Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2      Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Pooled separate accounts:* The Plan invests in a group annuity contract with the Custodian. The Plan's investments are stated at net asset value ("NAV") as reported to the Plan by the Custodian, based on the market values of the underlying assets. The stable value fund offered within the group annuity contract is invested in a common collective investment trust. The common collective trust is generally fully benefit responsive and therefore the published NAV is effectively its contract value, which is reported at fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The John Hancock Stable Value Fund is an investment option within the group annuity contract. The fund's subaccount is invested into John Hancock Stable Value Fund Collective Investment Trust (JH CIT). The underlying JH CIT itself is generally fully benefit responsive and honors eligible redemptions at \$1 per unit. It is important to note that JH CIT may, in some cases, defer payment and may not necessarily redeem its units at \$1 per unit in all cases. If the Plan had represented the contract value of net assets as of December 31, 2024 and 2023, the ratio of fair market value to contract value of net assets as 94.83% and 94.64%, respectively. As a result the daily net asset value is effectively its contract value, and for purposes of financial reporting, the fund is reported at fair value.

### **3. FAIR VALUE MEASUREMENTS (CONT.)**

The Plan only holds investments in a pooled separate account through its group annuity contract that does not publish a daily NAV, therefore, the investments are not subject to the fair value hierarchy classification requirements. Although the Custodian has stated that all subaccounts of the pooled separate account are considered level 1 investments, management has determined that these are level 2 investments due to the JH CIT fund noted above. Total investments at fair value were \$4,500,024 and \$3,853,082 at December 31, 2024 and 2023, respectively.

### **4. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of funds managed by the Custodian and therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Third-Party Administrator, is paid a fee based on a services agreement. Reasonable compensation for this arrangement is paid for by the Organization.

### **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **6. TAX STATUS**

The Plan has adopted a pre-approved Plan document sponsored by the Third-Party Administrator. The volume submitter plan has received an opinion letter from the IRS as to the plan's qualified status. The volume submitter plan opinion letter has been relied upon by the Plan. The Plan administrator believes the Plan is designed and is being operated in accordance with applicable sections of the Internal Revenue Code ("IRC").

Plan management is required to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 8. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian.

### 9. CORRECTIVE CONTRIBUTIONS

On October 3, 2024 (and clearing the bank on October 4, 2024), management remitted to the Plan \$8,033 of participant contributions transferred to the Plan late, for the year ended December 31, 2023. Total contributions not corrected as of December 31, 2023, also included lost earnings of \$646. Additionally, on October 3, 2024, the Plan's management provided matching contributions on the late remittances of \$1,128. The impact on the total employee contributions into the Plan as of December 31, 2024, follows:
