To the Board of Directors of Greater Mental Health of New York, Inc.  
as the Sponsor of Greater Mental Health of New York Profit Sharing Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Greater Mental Health of New York Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of Greater Mental Health of New York Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

A. **General** – The Plan is a defined contribution retirement plan financed through contributions from the Greater Mental Health of New York, Inc. (“Sponsor”). The Plan was established on January 1, 1991 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective January 1, 2022, the Plan document was amended and restated to bring the Plan in compliance with legislative and regulatory changes set forth in Internal Revenue Service (“IRS”) Notice 2017-37. The description of the Plan that follows has been updated to reflect any changes.

Effective September 1, 2024, the Plan name was changed to Greater Mental Health of New York Profit Sharing Plan. The Plan Sponsors’ name was also changed to Greater Mental Health of New York, Inc.

B. **Eligibility and Service Rules for Participation** – All employees, except nonresident aliens and leased employees, over the age of 18 are eligible to participate in the Plan. Participants are eligible for employer contributions upon completing one year of service during which the employee(s) must complete 1,000 hours.

C. **Employer Contributions** – The employer contributes to the Plan an amount equal to a percentage of each participant’s annual compensation based on a tiered method. Participants direct the investment of their contributions into the various investment options offered by the Plan.

Effective December 1, 2024, the employer contribution allocation is based on a grouping method. Participants are categorized into different classifications. There is a separate classification for the Chief Executive Officer, Chief Financial Officer, Chief Operating Officer, Executive Staff and other staff. The contribution is allocated to members of each class pro rata based on compensation. The employer contribution will be calculated based on the number of days the participant spent in each classification if the participant switched their job position during the Plan year.

D. **Participant Accounts** – Each participant’s account is credited with employer contributions and an allocation of Plan earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the amount accumulated in the participant’s vested account. All investments are participant directed.

E. **Vesting** – Vesting in the Plan’s discretionary contributions is based on years of service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years	25%
3 years	50%
4 years	75%
5 years	100%

F. **Forfeitures** – Participants who terminate employment before they vest will forfeit their interest in their employer contribution accounts. Such forfeitures are transferred out of the participant’s account and are held in a separate account. Forfeitures are applied first to pay Plan expenses for the year in which the forfeiture arises and then may be used at the discretion of the employer to reduce the employer’s contributions. As of both December 31, 2024 and 2023, there were no forfeited non-vested accounts. During 2024 and 2023, approximately \$75,450 and \$47,101, respectively, was used to reduce employer contributions.

G. **Distributions** – On termination of service due to death or retirement, a participant (or their beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, substantially equal installments or partial withdrawals. Hardship distributions and in-service distributions are not allowed.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

H. **Regulatory Compliance Affecting Retirement Plans** – The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 1.0 Act) became law on December 20, 2019. The SECURE Act made major changes to the Required Minimum Distribution rules, increasing the age from 70 ½ to 73 to participants over 72 after January 1, 2020. Plans were required to be formally amended for certain other changes if adopted on or before the last day of the 2023 plan year.

The SECURE Act 2.0 (SECURE 2.0) was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act of 2019, which altered the rules around how employees can save and withdraw money from their retirement accounts. SECURE 2.0 further increased the age of Required Minimum Distributions (“RMDs”), increased the catch-up contributions for older workers and required automatic enrollment for new plans. The SECURE 2.0 Act increased the age at which individuals must begin taking RMDs to 73 from 72, beginning January 1, 2023, as well as other increases starting in 2023.

The SECURE 2.0 Act increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024. In addition, the SECURE 1.0 Act and the SECURE 2.0 Act lowered the eligibility requirements to enable part-time workers to participate in 401(k) plans. These rules for long-term, part-time workers are expanded to apply to ERISA 403(b) plans, as well. The SECURE 2.0 Act changes the eligibility requirements under 401(k)'s so that it is easier for part-time employees to participate in them. The enacted law, the SECURE 1.0 Act, allows plans to limit eligibility for participation of part-time employees who reach the later of: (1) age 21 or completion of one 12-month period in which the employee worked at least 1,000 hours (pre-SECURE 1.0 Act rule); or (2) three consecutive years of service with 500 or more hours in each year. Under the SECURE 2.0 Act, a plan must allow a part-time employee to participate if the employee has either satisfied the above rule (1) or if the employee has completed two consecutive 12-month periods in which the employee worked at least 500 hours in each one of the two periods and reached age 21 by the end of the second 12-month period.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

- A. **Basis of Accounting** – The Plan’s financial statements are prepared on the accrual basis of accounting. The Plan adheres to accounting principles generally accepted in the United States of America (“U.S. GAAP”).
- B. **Use of Estimates** – The preparation of financial statements in conformity with U.S. GAAP requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. **Investment Valuation and Income Recognition** – The Plan’s investments, except for the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

The fully benefit-responsive investment contract held by the Plan is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the Plan.

- D. **Expenses** – The Sponsor pays certain expenses related to the Plan. The administrative expenses incurred by the funds are paid out of investor assets and are, therefore, netted into net appreciation in fair value of investments in the statements of changes in net assets available for benefits.
- E. **Benefit Payments** – Benefits are recorded when paid.

**NOTE 3 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY MATRIX TRUST COMPANY AS COMPLETE AND ACCURATE**

As noted in the independent auditors' report, the Plan Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") *Rules and Regulations for Reporting and Disclosure* under ERISA. **NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 Input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

**NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Mutual Funds:** Mutual funds are valued at the closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money Market Mutual Funds:** Shares held in the money market mutual funds invest in a variety of money market instruments to seek current income and are comprised of high-quality dollar-denominated debt securities. The composition of securities is structured to maintain a value of \$1 per share and is classified as Level 1 since it is in the active market.

All financial assets were mutual funds and money market funds carried at fair value as of December 31, 2024 and 2023 and were classified as Level 1.

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The contract value of the fully benefit-responsive investment contract is as follows as of December 31:

The Plan has a fully benefit-responsive investment contract with the CMFG Life Insurance Company ("CMFG") formerly Cuna Mutual Group through a Deposit Administration Group Annuity Contract (the "Contract"). CMFG maintains the contributions in a general account. The account is credited with earnings and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2C, because the Contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The Contract is included in the financial statements at contract value as reported by CMFG as of December 31, 2024 and 2023. Contract value represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the Contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer but cannot be less than zero. The crediting rate was approximately 2% as of both December 31, 2024 and 2023.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The Contract typically does not permit CMFG to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 – RELATED-PARTY TRANSACTIONS/PARTIES IN INTEREST**

CMFG is the record-keeper as defined by the Plan. Fees paid by the Plan for record-keeping services amounted to \$28,973 and \$26,307 for the years ended December 31, 2024 and 2023, respectively. Clarfeld Financial Advisors is the financial advisor for the Plan. Fees paid by the Plan for financial advisory services amounted to \$22,707 and \$17,426 for the years ended December 31, 2024 and 2023, respectively. The fully benefit-responsive investment contract is also issued by CMFG; therefore, these transactions qualify as exempt party-in-interest under ERISA. Matrix Trust Company is the Plan custodian and holds the Plans investments and transacts in investment transactions.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 8 – TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant's account balances and the amount reported in the statements of net assets available for benefits.

**NOTE 10 – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 5, 2025, the date the financial statements were available to be issued.
