

## Notes to Financial Statements

---

### 1. Description of Plan:

The following description of Employees' Pension Plan of Armstrong Pumps, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan covering substantially all full-time employees of Armstrong Pumps, Inc. (the Company). Employees who attain the age of 21 years and complete 90 days of service are automatically enrolled in the Plan and eligible to receive employer matching contributions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions:

Participants may elect to contribute up to 100% of pretax annual compensation, as defined in the Plan. Additionally, participants age 50 or older may elect to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make matching contributions or other discretionary contributions at the option of the Company's board of directors. Contributions are subject to certain IRS limitations. The Company provides a safe-harbor matching contribution of 100% of up to 5% of a participant's base compensation contributed to the Plan.

#### Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting:

Participants are immediately vested in all contributions.

#### Investment Options:

A participant may direct contributions into a variety of investment options offered by Fidelity Management Trust Company (Fidelity), a trustee of the Plan, some of which are proprietary in nature.

#### Notes Receivable from Participants:

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from one to five years or up to 25 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably generally through monthly payroll deductions.

#### Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over other allowed periods. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allows for in-service withdrawals for active employees that have reached normal retirement age, as defined by the Plan, or amounts contributed through distributions from other qualified plans. Additionally, hardship withdrawals are permitted if certain criteria are met.

### 2. Summary of Significant Accounting Policies:

#### Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

#### Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Income Recognition:**

The Plan's investments are stated at fair value. Inputs to the valuation methodology for mutual funds are unadjusted quoted prices for identical assets in active markets. The common/collective trust is valued based on net asset value per share without further adjustment, as a practical expedient to determine fair value. Net asset values are based on the aggregate fair values of the underlying investments. Participants may redeem shares at net asset value daily, without restriction.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

### **Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan agreement.

### **Benefit Payments:**

Benefits are recorded when paid.

### **Tax Status:**

The Internal Revenue Service has issued a favorable opinion letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

### **Subsequent Events:**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 24, 2025 (the date the financial statements were available to be issued).

### **Administrative Expenses:**

At the discretion of the plan administrator, certain administrative expenses have been borne by the Company.

### **3. Financial Information Certified by the Trustee (Unaudited):**

In accordance with the Department of Labor's Regulation 2520.103-8, certified "Statements of Account" for the Plan have been provided by Fidelity as of December 31, 2024 and 2023, and for the year ended December 31, 2024. The plan administrator has obtained certifications from the trustee that such information is complete and accurate as follows:

- Statements of Net Assets Available for Benefits - Investments and notes receivable from participants.
- Statement of Changes in Net Assets Available for Benefits - Investment income and interest income on notes receivable from participants.
- Schedule of Assets (Held at End of Year) - all items and amounts.

### **4. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **5. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



## Notes to Financial Statements

---

### 1. Description of Plan:

The following description of Employees' Pension Plan of Armstrong Pumps, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan covering substantially all full-time employees of Armstrong Pumps, Inc. (the Company). Employees who attain the age of 21 years and complete 90 days of service are automatically enrolled in the Plan and eligible to receive employer matching contributions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions:

Participants may elect to contribute up to 100% of pretax annual compensation, as defined in the Plan. Additionally, participants age 50 or older may elect to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make matching contributions or other discretionary contributions at the option of the Company's board of directors. Contributions are subject to certain IRS limitations. The Company provides a safe-harbor matching contribution of 100% of up to 5% of a participant's base compensation contributed to the Plan.

#### Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting:

Participants are immediately vested in all contributions.

#### Investment Options:

A participant may direct contributions into a variety of investment options offered by Fidelity Management Trust Company (Fidelity), a trustee of the Plan, some of which are proprietary in nature.

#### Notes Receivable from Participants:

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from one to five years or up to 25 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably generally through monthly payroll deductions.

#### Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over other allowed periods. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allows for in-service withdrawals for active employees that have reached normal retirement age, as defined by the Plan, or amounts contributed through distributions from other qualified plans. Additionally, hardship withdrawals are permitted if certain criteria are met.

### 2. Summary of Significant Accounting Policies:

#### Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

#### Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Income Recognition:**

The Plan's investments are stated at fair value. Inputs to the valuation methodology for mutual funds are unadjusted quoted prices for identical assets in active markets. The common/collective trust is valued based on net asset value per share without further adjustment, as a practical expedient to determine fair value. Net asset values are based on the aggregate fair values of the underlying investments. Participants may redeem shares at net asset value daily, without restriction.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

### **Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan agreement.

### **Benefit Payments:**

Benefits are recorded when paid.

### **Tax Status:**

The Internal Revenue Service has issued a favorable opinion letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

### **Subsequent Events:**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 24, 2025 (the date the financial statements were available to be issued).

### **Administrative Expenses:**

At the discretion of the plan administrator, certain administrative expenses have been borne by the Company.

### **3. Financial Information Certified by the Trustee (Unaudited):**

In accordance with the Department of Labor's Regulation 2520.103-8, certified "Statements of Account" for the Plan have been provided by Fidelity as of December 31, 2024 and 2023, and for the year ended December 31, 2024. The plan administrator has obtained certifications from the trustee that such information is complete and accurate as follows:

- Statements of Net Assets Available for Benefits - Investments and notes receivable from participants.
- Statement of Changes in Net Assets Available for Benefits - Investment income and interest income on notes receivable from participants.
- Schedule of Assets (Held at End of Year) - all items and amounts.

### **4. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **5. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
