Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jefferson Valley Racquet and Fitness Club 401(k) Discretionary Matching Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Opinion

Basis for Opinion

(1) Description of the Plan

The following description of the Jefferson Valley Racquet and Fitness Club 401(k) Discretionary Matching Plan (the "Plan") provides only general information about the Plan's provisions. General - The Plan is a defined contribution plan covering all eligible employees of Jefferson Valley Operations Inc. and Briarcliff Operations Inc. collectively Club Fit (the "Company" or "Employer"). The Plan was established and became effective on January 1, 1992. All employees, having attained age 21, and having completed one year of service and one thousand or more hours worked, as defined by the Plan, can become eligible to participate in the Plan on the first day of the quarter after attaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - There are four different contribution types available to the Plan:

Employer Non-Elective - The Company may, at its discretion, make a profit-sharing contribution to the plan. There were no Employer Non-Elective contributions to the Plan for 2024.

Elective Deferrals - Eligible employees, at their discretion, may make pre-tax deferral contributions or after-tax Roth deferral contributions to the Plan in one percentage increments. Eligible employees who have attained age 50 before the end of the year may make catch-up contributions (as limited by the Internal Revenue Code). All elective deferrals are limited to the maximum elective deferral contribution limit set annually by the Internal Revenue Service ("IRS")

Employer Matching - The Company may make matching contributions, as defined by the Plan. Currently, the Company will contribute a matching contribution equal to 25% of the employee's deferral, not to exceed 1% of the employee's compensation. During the year ended December 31, 2024, the Company made matching contributions of \$51,980.

Rollovers - Eligible employees may rollover distributions from other qualified retirement plans, as defined in the Plan, and certain Individual Retirement Accounts ("IRA's"). Rollover contributions are not matched by the Company. These contributions are 100% vested and non-forfeitable and will automatically be invested in accordance with the participant's investment election.

All contributions are subject to certain limitations of the Internal Revenue Code.

Investment Elections - Participant contributions and employer contributions are allocated into various investment options offered by the Plan as directed by participants. Investment options may be changed on a daily basis. If the participant does not make elective contributions, the Employer's contributions are allocated to the Plan's qualified default investment alternative.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Employer's contributions and allocations of the plan earnings. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions (includes employee deferrals and rollover contributions) plus actual earnings thereon and the Company's matching contributions (safe harbor contributions). A participant is fully vested in Employer Non-Elective Contributions after three years of credited service.

(1) Description of the Plan (Continued)

Notes Receivable from Participants - Participants may borrow from their plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans must be adequately secured by the participant's vested interest in the Plan. Loan terms range from 1-5 years. A participant may not have more than two outstanding loans at any point in time. The interest rate on the loan is computed using the prime rate, as specified by the Wall Street Journal plus 1%. Principal and interest is paid ratably through semi-monthly payroll deductions. A loan is in default when a scheduled installment payment has not been received by the last day of the calendar quarter following the calendar quarter in which the last scheduled installment payment was due. All loans will be due immediately upon termination to avoid loan default. There were no loans in default as of December 31, 2024 and 2023.

Payment of Benefits - Upon termination of service, due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the vested value of his or her account. If the vested account balance is less than \$5,000, the Plan requires a distribution or rollover once the participant is terminated. If the vested value exceeds \$5,000 the Plan does not require a distribution until the required minimum distribution rules apply, as defined in the Plan. In addition, participants are entitled to hardship withdrawals for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service and a participants must exhaust all available loan options and available distributions prior to requesting hardship withdrawal.

Forfeitures - Upon termination of employment, participants forfeit their unvested balances. In case of plan termination, normal retirement age, death, and full disability, the plan allows for 100% vesting. Forfeited balances of terminated participants' unvested accounts are used to first pay reasonable Plan expenses and then to reduce the Company's Non-Elective deferrals. If a participant is rehired before five one-year breaks in vesting service occur, the forfeited amount will be restored from a suspense account if the full amount of the distribution is repaid.

(2) Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Adoption of New Accounting Standard - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that are subject to the guidance in ASC 326 is employers' contributions receivable and notes receivable from participants. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

On July 30, 2025, the FASB issued Accounting Standards Update (ASU) 2025-05, Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets. This standard allows entities to elect a practical expedient that assumes that current conditions as of the fiscal year-end do not change for the remaining life of the asset. In addition, the standard provides for consideration of subsequent collections in developing reasonable and supportable forecasts as part of estimating expected credit losses. The Plan elected to early adopt this standard in the reporting period ended December 31, 2024.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(2) Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information principally provided by the Plans trustee, as described in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain administrative expenses of maintaining the Plan are paid by the Company. Expenses associated with administering participants' accounts are paid from Plan assets, which are first reduced by any forfeitures the plan administrator has directed to be used for payment of expenses. Any remaining expenses are shared among all participant accounts.

Subsequent Events - The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

(3) Information Certified and Provided by Ascensus Trust Company (Unaudited)

The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024 included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the trustee and furnished to the plan administrator. The plan administrator has obtained certifications from the Ascensus Trust Company ("trustee") that information provided to the plan administrator by the trustee related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 4 and supplemental schedule which appears throughout the financial statements and supplemental schedule related to the following assets:

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants', the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

(5) Related Party and Party-In-Interest Transactions

Certain plan investments are shares of mutual funds managed by Ascensus Trust Company. Ascensus Trust Company is the trustee for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments rather than a direct payment. Administrative fees paid by the Plan directly to Ascensus Trust Company were \$41,741 for the year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement, subject to the provisions of ERISA, to discontinue its contributions, amend or modify the Plan at any time. In the event of plan termination, all participants will become 100 percent vested in their total account balance under the Plan.

(7) Tax Status

The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service ("IRS") states that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
