## Sequoia Living Tax Sheltered Annuity Plan Notes to Financial Statements

---

### **Note 1 – Description of Plan**

The following description of Sequoia Living Tax Sheltered Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

**General** – Prior to January 1, 2012, the Plan was a defined contribution retirement plan covering substantially all employees of the Sequoia Living Tax Sheltered Annuity Plan (the Company or Sequoia). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Sequoia is the Plan's sponsor and serves as Plan administrator. Effective January 1, 2012, the Plan was amended so that no further pretax annual or employer contributions were to be made to the Plan, and the Plan would be considered frozen.

The Company changed its name to Sequoia Living; as a result, the Plan name has been amended from Northern California Presbyterian Homes & Services Tax-Sheltered Annuity Plan to the Sequoia Living Tax Sheltered Annuity Plan, effective February 6, 2019.

**Eligibility** – Prior to January 1, 2012, employees of Sequoia were immediately eligible to participate in the Plan upon being hired. After January 1, 2012, participants must have reached age 21 and completed one year of service, in which at least 1,000 hours are worked, to have been eligible to receive any employer paid contributions.

### **Contributions**

*Participant contributions* – Prior to January 1, 2012, participants contributed between 1% to 100% of pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. After January 1, 2012, participants were no longer able to make pretax deferral or catch-up contributions; however, participants may contribute amounts solely representing distributions from other qualified defined benefit or defined contribution plans.

*Employer contributions* – Prior to January 1, 2012, Sequoia may have elected to make discretionary matching and profit-sharing contributions to the Plan. Sequoia matched 100% of employee contributions, up to 4% of eligible compensation deferred to the Plan. Profit-sharing contributions were allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. Contributions were subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with Plan earnings. Participant annuity accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined in the recordkeeping service agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Vesting** – Effective January 1, 2012, participants were immediately vested in all employee and employer contributions.

**Notes receivable from participants** – Prior to September 1, 2015, participants were able to borrow from the insurance companies using a portion of their Plan account as security for the loan. Loans to participants are issued directly from funds owned by the insurance companies and not directly from participants' accounts. Participants could borrow up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. To secure loans to participants, participants are required to pledge as collateral their annuity account value equal to 133% and 110% of the outstanding loan balance with Symetra Financial (Symetra) and Equitable Financial Life Insurance Company (Equitable), respectively. That amount must be available in the fixed account of the contract, transferred to it, or transferred to a fixed loan reserve account. In the event of default, the unpaid loan balance is deemed a distribution. For loans to participants, interest is paid directly to the insurance companies based on the rates and arrangements agreed to between the participant and the insurance company. The interest rate determined by the insurance companies was 2% to 2.5% above the current rate credited to the guaranteed interest options.

Loan balances outstanding from the insurance companies to the Plan's participants were \$33,183 and \$40,081 as of December 31, 2024 and 2023, respectively. As such, \$44,133 and \$53,308 of annuity account balances as of December 31, 2024 and 2023, respectively, served as loan collateral for the related loans.

Effective September 1, 2015, no new loans were permitted to be issued to participants.

**Payment of benefits** – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, a life annuity, a life annuity with a period certain, a joint-and-survivor annuity, or a combination of a fixed-dollar annuity and a variable annuity. For termination of service for other reasons, a participant may receive the value of the interest in his or her account as a lump-sum distribution.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – Investments are reported at fair value and contract value. The Plan's custodians, Symetra and Equitable, certify the contract value of the guaranteed interest accounts and the fair market value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by Sequoia and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent events** – Subsequent events are events or transactions that occur after the date of statement of net assets available for benefits but before the financial statements are issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date and before the financial statements are issued.

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were issued.

### **Note 3 – Investments**

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

*Pooled separate accounts* – Units held in pooled separate accounts (PSA) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The PSA may be redeemed daily.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Equitable Common Stock Index portfolio seeks to achieve a total return before expenses that approximates the total return performance of the Russell 3000® Index (Russell 3000), including reinvestment of dividends, at a risk consistent with that of the Russell 3000. The portfolio generally invests at least 80% of its net assets, plus borrowings, for investment purposes, in common stocks of companies represented in the Russell 3000. The Russell 3000 is an unmanaged index that measures the performance of the 3,000 largest U.S. companies based on total market capitalizations, which represents approximately 98% of the investible U.S. equity market.

The Equitable Large Cap Value Managed Volatility portfolio seeks long-term growth of capital. Under normal circumstances, the portfolio invests at least 80% of its net assets, plus borrowings for investment purposes, in securities of large-cap companies (or other financial instruments that derive their value from the securities of such companies). For this Portfolio, large-cap companies mean those companies with market capitalizations within the range of at least one of the following indices at the time of purchase: Standard & Poor's 500 Composite Stock Index, Russell 1000® Index, and Morningstar Large Core Index.

#### Note 4 – Fixed Annuity Accounts

The Plan entered into fully benefit-responsive investment contracts (FBRIC) with Equitable and Symetra. Equitable and Symetra maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the guaranteed percent. The crediting rate is reviewed on a defined basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The following table provides additional information for crediting rate:

The contracts meet the FBRIC criteria and therefore are reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Symetra and Equitable, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **Note 5 – Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS). The Plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for participants under Section 403(b).

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

#### **Note 8 – Party-in-Interest Transactions**

Plan investments include various Plan investments managed by the Plan custodians, and, therefore, transactions with the custodians qualify as exempt party-in-interest transactions.

Although it has not expressed any intention to do so, Sequoia has the right to terminate the Plan and discontinue its contributions at any time.
