We have performed audits of the financial statements of Defined Contribution Pension Plan for the Employees of American Committee for the Weizmann Institute of Science, Inc. **Note 1. Description of the Plan**

The following brief description of the Defined Contribution Pension Plan for the Employees of American Committee for the Weizmann Institute of Science, Inc. (Plan), is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

***General***

The Plan, which became effective December 1, 1986, is a noncontributory defined contribution plan covering all eligible employees of the American Committee for the Weizmann Institute of Science, Inc. (Organization). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Effective April 1, 2024, the Plan was restated as a result of its change from Mutual of America (MOA) to Teachers Insurance and Annuity Association (TIAA). The change initiated a “Black Out” period beginning April 10, 2024, and continued through April 24, 2024. During this period, funds could not be applied to the employee-selected funds with the Trustee or withdrawn from the Plan until the Trustee had time to accurately complete the conversion. At the end of the Black Out period, these funds were transferred to the new Trustee and invested in funds as requested by each participant.

***Eligibility for Participation***

A full-time employee previously became eligible to participate in the Plan on the first day of the month after his or her date of hire; if hired on the first working day of the month, the employee was eligible immediately. Effective April 1, 2024, full-time employees with at least one year of service and are age 21 or older are eligible to participate. Part-time employees whose regularly scheduled service is less than 20 hours of service are excluded until they complete one year of service with a minimum of 1,000 hours. A participant who leaves the Organization’s employment and is later rehired is included in the Plan immediately provided they are otherwise eligible to participate in the Plan.

***Contributions***

No employee contributions are permitted. The Organization makes contributions to the Plan in an amount equal to 9% of each participant’s eligible compensation. The Plan does not permit rollovers or transfers from other plans. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant’s account is credited with the allocations of (a) the Organization’s contribution and (b) the participant’s share of plan earnings. Plan income and expenses are credited or debited to participant accounts based on the pro rata share of the participant’s individual account balance to total plan assets. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

***Vesting***

The total value of a participant's account balance is fully and immediately vested upon one year of service or, if earlier, the attainment of normal retirement age. Previous service of any employee who leaves the Organization and is later rehired within 12 months of the date of the break in service is counted toward meeting the vesting requirement.

***Forfeited Accounts***

Participants who terminate employment before they vest will forfeit their interest in their organization contribution accounts. These accounts will be held in the Plan for use by the Organization to meet any obligations with respect to organization contributions. There were no balances outstanding for the forfeiture account as of December 31, 2024 and 2023.

***Payment of Benefits***

On termination of service due to disability or retirement, a participant (or a designated beneficiary) may elect to receive the vested interest in his or her account in either a lump-sum amount or installments (including interest). If the participant dies before distribution begins, the entire interest earned in the Plan will be distributed to the spouse or the named beneficiary by December 31 of the calendar year immediately following the calendar year of the participant's death. For termination of service resulting from other reasons, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution or maintain his or her vested interest within the Plan. If a participant terminates service and the value of the participant's vested account balance is not greater than \$1,000, the participant will receive a lump-sum distribution of the value of the entire vested portion of such account balance and the nonvested portion will be treated as a forfeiture.

***Notes Receivable from Participants***

Participants may not borrow from their fund accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Contributions are allocated to the TIAA Traditional Annuity contract and mutual funds.

The fair value of guaranteed investment contracts (excluding fully benefit-responsive investment contracts) are calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals, and administration expenses.

The Plan's investment in the MOA Group Annuity Contract is recorded at fair value. The fair value of the general investment account is calculated by the custodian utilizing current interest rates. This account has no liquidity restrictions and is not fully benefit-responsive.

Pooled separate accounts are valued at estimated fair value as provided by MOA.

Purchases and sales of securities are recorded on a trade-date basis. As applicable, interest income is recorded on the accrual basis, and dividend income is accrued on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Employer contributions are recorded in the year in which participant compensation is earned.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

The Organization (Plan Sponsor) pays substantially all administrative expenses at the Plan Sponsor's discretion. Fees paid for investment advisory and bookkeeping services are paid by the Plan (see *Note 4*).

**Note 3. Certification of Plan Custodians**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company (MOA), TIAA and College Retirement Equities Fund (CREF), qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments are products of the Plan's custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees of \$15,081 and \$243 were paid by the Plan for investment advisory services during the years ended December 31, 2024 and 2023, respectively.

The Organization provides certain administrative services at no cost to the Plan.

#### **Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of

**Note 6. Investment Contract with Insurance Company**

In 2024, the Plan entered into a fully benefit-responsive investment contract with TIAA. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract held by the Plan was \$3,130,816 as of December 31, 2024.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Organization or other Organization events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

### **Note 8. Plan Tax Status**

Effective April 1, 2024, the Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by TIAA. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Prior to April 1, 2024, the Plan and the related trust operated under the design which was determined and informed by the IRS by a letter dated August 22, 2017, that it is in accordance with applicable sections (Section 401(a)) of the Internal Revenue Code (IRC). Although the Plan has been amended subsequent to receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through October 3, 2025 which is the date the financial statements were available to be issued.
