Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Shawmut Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31 2024 and the related notes to the financial statements.

NOTE 1 – PLAN DESCRIPTION

Shawmut Woodworking & Supply, Inc. (the “Company”) established the Shawmut Design and Construction 401(k) Plan (the “Plan”) on July 1, 1996. Effective December 1, 2016, the Company became a wholly owned subsidiary of Shawmut Group Inc. The Plan name also changed from the Shawmut Design and Construction 401(k) Plan to the Shawmut Group 401(k) Plan (the “Plan”). The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of Shawmut Group Inc., and its participating subsidiaries, affiliates and locations (collectively, the Company or the Employer), who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts and a common collective trust.

Each year, the Company may make discretionary matching contributions to the account of each eligible employee. Employees are eligible to receive a discretionary match if they are age 18 or older and have completed three (3) months of service. During 2024, the Company made contributions equal to 50% of the first 8% of eligible compensation that a participant contributes to the Plan. The Company may, at its discretion, make additional profit-sharing contributions to the Plan on an annual basis. There were no profit-sharing contributions for the current Plan year. Contributions are subject to certain limitations.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s contributions, (b) Plan earnings, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions that do not exceed a dollar amount or percentage of eligible compensation uniformly determined by the employer for all eligible participants. Earnings allocations are based on each participant’s interest in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are vested immediately in their contributions and rollovers plus actual earnings thereon. Vesting in the Company’s discretionary contributions, plus actual earnings thereon, is based upon years of service. A participant is one hundred percent (100%) vested after five (5) years of credited service in accordance with the following schedule:

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$5,000 are automatically distributed to participants as soon as administratively feasible in a single lump-sum payment. Active participants may also take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or (50%) of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. The period of repayment of a loan may not exceed five (5) years unless used for the purchase of a primary residence, in which case the period of repayment may not exceed ten (10) years. All loans are covered by demand notes and are repayable through payroll deductions.

Forfeitures: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$78,353 and \$29,343, respectively. Forfeitures of employer matching contributions are used to offset administrative expenses and then to reduce future employer matching contribution.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Transfers to Other Plan: Effective September 23, 2024, the Company amended the Plan to provide eligible participants with a one-time opportunity to transfer a portion of their pre-tax account balances from the Plan to the Shawmut Employee Stock Ownership Plan (ESOP Plan). Participants could elect to transfer up to 50% of their balance in the Company's 401(k) Plan, subject to a \$250,000 limit, excluding Roth, after-tax, loan, and QDRO amounts. Transferred funds were credited to each participants' Investment Cash Accounts of the ESOP Plan before being used to purchase shares of common stock at fair market value, which will be allocated to each participant's Investment Stock Accounts within the ESOP Plan. Transfers totaling \$2,292,989 are included on Statement Of Changes in Net Assets Available for Benefits under Plan Transfer. The plan transfers were structured to comply with Internal Revenue Code Section 411(d)(6)(D).

Transfers from Other Plan: For the year ended December 31, 2024, ESOP Plan diversification of \$758,023 were transferred to the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 10, 2025 which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and an insurance company. See Note 4 for discussion of fair value measurements.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by participants' account balances. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments, and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

Collective Trust: The fair values of participation units held in the collective trust are based on the net asset values reported by the fund managers as of the financial statement dates. The collective trust provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan holds units of pooled separate accounts managed by Principal Life Insurance Company. Principal Life Insurance Company is an affiliate of the Principal Trust Company, the Trustee of the Plan, and therefore, these transactions and the Plan's payment of fees to Principal Life Insurance Company qualify as party-in-interest transactions. Some administrative expenses of the Plan are paid directly by the Company. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. In addition, the Plan paid for management and administrative services in the amount of \$289,181 for the year ended December 31, 2024 and are included in administrative expenses on the statement of changes in net assets. The Plan sponsor pays, directly, any other fees related to the Plan's operations. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
