Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion, except as described in the Basis for Qualified Opinion section below.

Basis for Qualified Opinion

We were unable to obtain sufficient appropriate audit evidence to support the completeness and accuracy of participant distributions recorded in the statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan's records did not contain adequate documentation to support the amounts and disclosures related to these distributions. As a result, we were unable to determine whether any adjustments might be necessary to the financial statements.

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Information Required by ERISA

The supplemental Schedule of Assets Held at End of Year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - DESCRIPTION OF PLAN

The following brief description of the DME Express, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of DME Express, LLC and certain affiliates thereof (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA). The Plan Sponsor is a part of a controlled group, along with DME Express of Louisiana, LLC and DME Express, LLC dba Kokua Medical.

The Plan is administered by the Company, whereby employees of the Company serve as the Administrative Committee of the Plan. Capital Bank and Trust Company (Trust Company) served as the custodian and record keeper of the Plan until November 2024. John Hancock became the custodian and record keeper in November 2024.

Eligibility

Employees may begin participation on the 1st day of the month following the completion of 90 days of service. To be eligible for elective deferrals and employer contributions, the employee must also be employed by the Company and have attained the age of 21 years.

Contributions

The Plan provides for (a) employee contributions, pre-tax or after-tax Roth, up to 100% of eligible compensation as defined in the Plan document, not to exceed the maximum allowable under the Internal Revenue Code; (b) Company matching contributions, made at the sole discretion of the Company; and (c) discretionary Company contributions, which are profit sharing contributions.

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Code (\$23,000 for 2024). Participants ages 50 and over as of year-end are eligible to make catch-up contributions to the extent permissible under law and regulations.

Vesting

Participants are immediately vested in their own contributions plus or minus any earnings or losses thereon. Vesting of employer contributions is based upon years of service. Participants vest at the rate of 33% per year of service, beginning with the second year, until fully vested. Participants automatically become 100% vested upon:

1. Normal retirement (attainment of age 65)
2. Disability
3. Death

Participants who terminate for any other reason are entitled to the vested amount of their accounts.

Forfeited Accounts

Forfeitures of employer contributions due to participant withdrawals prior to being 100% vested may be used to reduce future Company contributions or offset Plan expenses. During 2024, no forfeitures were used to reduce the employer matching contributions or expenses. At December 31, 2024 and 2023, unused forfeited non-vested accounts totaled \$5,178, and \$207, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's matching and discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

When benefits become due, distributions are automatically made in a lump sum.

Hardship Withdrawals

The Plan provides for participant withdrawals in the event of financial hardship. Financial hardships include the participant's purchase of a primary residence, certain educational, medical, and other specific expenses.

Administrative Expenses

Certain administrative expenses incurred in connection with the Plan are paid by the Company. The Company will not seek reimbursement from the Plan for the payment of these expenses.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the year. Cash is stated at cost, which approximates fair value. All employer and employee contributions are invested under the direction of the participant.

Interest and dividends are recorded on an accrual basis.

Gains and losses resulting from the sale of investments are differences between the average cost of specific investments sold and proceeds received. Transactions are recorded on the settlement date basis.

Payments of Benefits

Benefits are recorded when paid.

NOTE C - TRUSTEE CERTIFICATION

The Plan Administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified by Capital Bank and Trust Company and John Hancock, the respective trustees and record keepers of the Plan during the periods under audit.

The information certified by the trustee was the annual report and accounting as of and for the years ended December 31, 2024 and 2023, which includes beginning and ending balances of investments, and a detailed listing of the transactions in the various funds, including investment earnings.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

FASB ASC 820-10-50-2 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-50-2 are described below:

Basis of Fair Value Measurements

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The following table presents by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024 and 2023. As required by FASB ASC 820-10-50-2, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

NOTE E - TAX STATUS

The Plan has adopted a volume submitter prototype plan. The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020, that the Plan is acceptable under section 401 of the Internal Revenue Code. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate participation in the Plan at any time subject to the provisions of ERISA. In the event of full or partial termination of the Plan, the participants will become fully vested in the Company's contributions to their account.

NOTE G - RISKS AND UNCERTAINTIES

The Plan provides for investments in various investment securities, which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE H - RELATED-PARTY TRANSACTIONS

Certain plan investments are shares of mutual funds managed by the John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The transactions are covered by an exemption from the “prohibited transaction” provisions of ERISA and the Internal Revenue Code.

NOTE I - SUBSEQUENT EVENTS

The Company has evaluated subsequent events and their related disclosures through October 13, 2025 which coincides with the financial statement issuance date and identified no such events.
