Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Apax Partners US, LLC 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Plan Description

The following brief description of the Apax Partners US, LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan provides employees of Apax Partners US, LLC (the Employer or the Company) with the opportunity to save for retirement on a tax-advantaged basis. This Plan is a type of qualified retirement plan commonly referred to as a 401(k) Plan. Participants under the Plan may elect to contribute a portion of their compensation to the Plan. In addition, the Employer may make contributions to the Plan on the participants' behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), the Internal Revenue Code (IRC), and other federal and state laws. The provisions of the Plan are subject to revision due to changes in laws or due to pronouncements by the Internal Revenue Service (IRS) or Department of Labor (DOL).

Eligibility: Employees will generally become eligible to participate when they have completed six consecutive months of service and have attained the age of 21. Employees will actually participate once they reach the Entry Date. The Entry Date is defined as the first day of the plan year quarter coinciding with or next following the date the employee satisfies the eligibility requirements.

Employee contributions: Eligible employees may contribute a percentage of their pretax annual compensation as selected by the participant, as defined by the Plan, and subject to IRS limitations on maximum deferral contributions, which was \$23,000 (or \$30,500 for eligible employees age 50 or older) for 2024. The annual compensation of each employee taken into account under the Plan may not exceed \$345,000 for 2024.

Employer contributions: The Employer may elect to make a discretionary matching contribution not to exceed 6% of the employees' compensation. During the year ended December 31, 2024, the Employer elected to match 100% of 3% of an employee's eligible compensation on an annual basis. This matching contribution is subject to the vesting schedule below. In order to maintain safe harbor status, the Employer also makes a nonelective contribution equal to 3% of the employees' compensation for the plan year, which amounted to \$1,038,240 in 2024. This contribution is 100% vested.

Additionally, the Employer elected to make a discretionary profit-sharing contribution, which amounted to \$445,698 in 2024. In order to share in the profit-sharing contribution, employees must be credited with six or more consecutive months of service during the plan year and be employed on the last day of the plan year. Employees will always be eligible in the year of their death, disability or retirement. This contribution is subject to normal vesting.

Vesting: Employees are always 100% vested in their accounts attributable to elective deferrals including catch-up contributions, rollover contributions and safe harbor contributions. In order to reward employees who remain employed with the Employer for a long period of time, the law permits a vesting schedule to be applied to certain contributions that the Employer makes to the Plan. The vested percentage in the participant accounts attributable to the matching contributions and discretionary profit-sharing contributions is determined under the following schedule:

Note 1. Plan Description (Continued)

Participant accounts: Each participant's account is credited with the participant's deferral contributions and allocations of the Company's contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Rollover contributions: Participants may transfer to their Plan accounts part or all of an eligible rollover distribution received from other qualified plans and certain IRAs. Rollover contribution accounts will be subject to the terms of this Plan and will always be fully vested and nonforfeitable.

Distributions from the Plan: A participant's vested interest may be distributed only after the participant's disability, termination from employment, attainment of early retirement age 55, the later of age 62 or attainment of normal retirement age (59½) or death. If one of the aforementioned conditions is met, participants may withdraw all or any part of their vested account at any time. Employees may be entitled to receive in-service distributions. However, these distributions are not in addition to other benefits and will therefore reduce the value of the benefits the employee will receive at retirement. These distributions are made at the employee's election and subject to possible administrative limitations on the frequency and actual timing of such distributions. Amounts may be withdrawn from rollover contributions at any time.

Forfeitures: The Plan may utilize all of the forfeited amounts to pay administrative expenses and reduce future contributions made by the Employer. Forfeited nonvested accounts amounted to \$41,062 and \$52,770 on December 31, 2024 and 2023, respectively. During 2024, the Plan used \$59,669 of the forfeited amounts to reduce contributions made by the Employer.

Administrative expenses: All administrative expenses are paid by the Plan with the exception of professional fees which are paid by the Employer. During the 2020 plan year, the Plan began allocating a formulated portion of interest and dividend income to the forfeiture account to fund administrative expenses. For the year ended December 31, 2024, \$414 was transferred to the forfeiture account to cover administrative expenses.

Termination of the Plan: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company will instruct the Custodian either (a) to continue to administer the Plan until all funds are depleted or (b) to distribute the assets remaining in the funds. If the funds are to be distributed, the Custodian will distribute to each participant the amount credited to his/her account on the distribution date. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Loan provisions: Only active employees who participate in the Plan and have a minimum vested account balance of \$2,000 may request a loan. Loans can be requested in the range of \$1,000 to \$50,000 or 50% of the vested balance, whichever is less. The number of loans a participant may have outstanding at any time is three. The loans are secured by the vested balance in the participant's account. The loans bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. The term of repayment of a loan other than a home loan must not be greater than five years. The term of repayment of a home loan must not be greater than 15 years.

Hardship withdrawals: Participants may withdraw their employee pretax contributions (but not the earnings on the pretax contributions) and rollover contributions, if applicable, to satisfy immediate and heavy financial needs. In accordance with IRS regulations, participants must first exhaust all other assets available before obtaining a hardship withdrawal. All hardship withdrawals must be approved by the Plan Administrator.

Note 2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, except for the fully benefit-responsive investment contract, which is reported by the Master Trust at contract value.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Participant loans are classified as notes receivable from participants, which are segregated from Plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. Form 5500 presents notes receivable from participants as an investment.

Contributions: Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The Employer discretionary matching contributions are recorded in the year in which the related employee contributions are made.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan evaluates events occurring after the date of the financial statements to consider whether or not the impact of such events needs to be reflected and/or disclosed in the financial statements. Such evaluation is performed through the date the financial statements are available for issuance, which was October 13, 2025, for these financial statements.

Note 3. Information Certified and Provided by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Empower Trust Company, LLC (Empower) and Empower Life & Annuity Insurance Company of New York (ELAINY), the custodian of the Plan. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and supplemental schedule related to the investment assets, notes receivable from participants and related income.

The Custodian certified to the completeness and accuracy of the investments totaling \$56,270,475 and \$50,024,231 as of December 31, 2024 and 2023, respectively, and certified to the completeness and accuracy of notes receivable from participants as of December 31, 2024 and 2023, totaling \$131,253 and \$96,305, respectively.

In addition, the Plan's custodian also certified to the completeness and accuracy of \$5,583,321 of net appreciation in fair value of investments, \$2,840,083 of interest and dividends related to the aforementioned investments and \$7,149 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The Plan Sponsor is responsible for the determination of fair value. Accordingly, they perform periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the Plan Sponsor has not historically adjusted the prices obtained from the pricing services. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Guaranteed Investment Contract

In 2009, the Plan entered into a benefit-responsive contract with ELAINY. Participants may elect to make contributions or make transfers from other Plan funds into the Key Guaranteed Portfolio Fund, which provides a guarantee of principal and a guaranteed quarterly interest rate that is backed by the general account assets of ELAINY. Effective January 2024, the fund changed from the Key Guaranteed Portfolio Fund to the Empower Investments Fixed Account Series IV.

The interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio and is reset quarterly. The minimum interest crediting rate is 0%.

Either party may terminate the contract with written notice. Termination becomes effective on the 75th calendar day after receipt of the notice in good order, or the next business day if the 75th day is not a business day. An alternate termination date may be agreed upon, but termination cannot proceed without all required information. Upon termination of the contract, the Plan Sponsor may choose from three options. First, Great-West Life & Annuity Insurance Company of New York (GWL&A of NY) can pay the total book value of the Fixed Account in 20 quarterly installments, beginning within 90 calendar days of termination. The initial payment will be 1/20th of the book value, with subsequent installments decreasing proportionally (e.g., 1/19, 1/18, etc.) until the full amount is paid. Interest will continue to accrue on the remaining balance until all funds are remitted. Participant-initiated transfers and distributions may continue, but Plan Sponsor transfers will cease post-termination. Second, a lump-sum payment may be requested, subject to a market value adjustment, calculated using a formula based on Treasury rates. The payment will be the lesser of the book value or the adjusted value. Lastly, any other termination method permitted by law may be used if mutually agreed upon in writing by both GWL&A of NY and the Plan Sponsor. The Employer does not believe that any events, which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6. Income Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan documents; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Notes to Financial Statements

Note 7. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into various financial instruments.

The Plan may indirectly invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Guaranteed Portfolio Fund represents approximately 2.04% and 2.28% of the Plan's net assets as of December 31, 2024 and 2023, respectively, and represents an obligation from ELAINY to repay as amounts come due. The Plan Administrator does not believe that any events would limit the Plan's ability to transact at contract value.

Note 8. Party-in-Interest Transactions

The Plan offers participant loans and participants invest in a guaranteed investment contract issued by the Plan's record keeper and custodian, Empower and ELAINY (See Note 5). Income from a revenue sharing agreement with Empower totaling \$85,574 for the year ended December 31, 2024, is netted against administrative expenses in the statements of changes in net assets available for benefits. These transactions with Empower and ELAINY qualify as exempt party-in-interest transactions under ERISA.
