## INDEPENDENT AUDITOR'S REPORT

To the Participants and Board of Trustees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of FJ Management Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

### Note 1 – Description of Plan

The following description of the FJ Management, Inc. (the Sponsor) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of the Sponsor who have completed 90 days of service, hourly employees who have completed 90 days of service, and have attained age 21, excluding any employee who is a member of a collective bargaining agreement and is covered by a collective bargaining agreement not specifically providing for coverage of such employee under the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

A participant of the Plan may elect to contribute pre-tax deferrals or Roth deferrals (collectively “elective deferrals”) to the Plan. A participant may elect to defer not less than 1% of annual compensation and a maximum of 100% of annual compensation.

The Sponsor makes QACA Safe Harbor contributions in the amount of 100% of the first 2% and 50% of the next 4% of participant elective deferrals contributed to the Plan. A participant may complete a salary deferral agreement to select an alternative deferral amount or to elect not to contribute to the Plan. Each year, the Sponsor may make a discretionary nonelective contribution. If made, it will be allocated to the Accounts of eligible Participants within each Participating Employer, in the same ratio that each Participant’s Compensation bears to the total Compensation of all Participants. Each Participating Employer’s Contributions, attributable to each specific contribution type made by such Participating Employer, will be allocated only to eligible Participants of such Participating Employer.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their deferral contributions, plus actual earnings thereon. Qualified Safe Harbor matching contributions attributable to a participant account vest after two years of service. Non-elective contributions vest as follows:

### **Payment of Benefits**

On termination of service due to death, Beneficiary(ies) will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, however, the Beneficiary may elect to receive another form of benefit.

On termination of service due to disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, however, the participant may elect to receive another form of benefit, such as a partial withdrawal or Installment Payments.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator.

### **Forfeited Accounts**

Employer contributions were reduced by \$599,403 during the year ended December 31, 2024, from forfeited nonvested accounts. Forfeitures as of December 31, 2024 are \$1,015,553. These accounts are used to reduce future employer contributions or to pay Plan expenses.

### **Administrative Expenses**

Significant administrative expenses of the Plan related to the third-party administrator are paid by the Sponsor. Additional administrative expenses charged by the plan custodian and investment advisor are paid by the Plan.

## **Note 2 – Summary of Significant Accounting Policies**

### **Basis of Accounting**

The Plan's financial statements are presented on the accrual basis of accounting in accordance with generally accepted accounting principles.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### **Investment Valuation**

Investments are reported at fair value. Fair value is based on quoted prices for identical assets in active markets. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

### **Payment of Benefits**

Benefits are recorded when paid by the Plan.

### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent notes receivable from participants

are recorded as a distribution based upon the terms of the Plan document. Management of the Plan estimates that these notes are fully collectible and therefore has no reserve for bad debt.

### **Concentrations of Credit Risk**

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist primarily of marketable securities are subject to daily changes in market valuations. The Plan believes it is not exposed to any significant credit risk on cash and cash funds.

### **Investment Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of Benefits**

Benefit payments are recorded as deductions when paid. Excess contributions paid within two and one-half months of year-end are treated as a reduction in prior year contributions.

### **Subsequent Events**

Management of the Plan has evaluated subsequent events through October 13, 2025, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

### **Note 3 – Fair Value Measurements**

The Plan discloses and recognizes the fair value of its assets and liabilities in accordance with Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures (ASC 820) which among other things, defines fair value and provides enhanced disclosures about investments that are measured and reported at fair value. ASC 820 establishes a hierarchal disclosure framework, which prioritizes and ranks the level of market price observability used in measuring investments at fair value. A number of factors, including the type of investment and the characteristics specific to the investment, impact market price observability. Investments with readily available active quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories:

- Level 1 inputs, which have the highest priority, are quoted prices for identical assets in active markets.
- Level 2 inputs are observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active.
- Level 3 inputs, which have the lowest priority, are unobservable inputs that reflect the Plan's own assumptions, consistent with reasonably available assumptions made by other market participants.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information,

volatility statistics, specific and broad credit data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

**Mutual Funds** - These investments are valued at the net asset value (NAV) of shares held by the fund based on closing prices reported in an active market and classified within Level 1 of the valuation hierarchy. The investments can be redeemed on a daily basis and there is no restriction on redemption.

**Common Collective Trusts** - Valued at NAV based on collective trust's underlying investments as determined by the fund's issuer. Redemptions from these collective trust funds generally can be made daily and are determined to have a readily determinable fair value.

### Note 4 – Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank (the trustee of the Plan).

### Note 5 – Investments at Contract Value

#### Group Annuity Contract

The Plan has a fully benefit-responsive group annuity contract with Standard Insurance Company (Standard). The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying asset in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing interest rates for the fund over the year. The actual average yield earned by the Plan for the group annuity contract is derived by averaging the Plan's quarterly interest rates. The actual average for 2024 and 2023 was 2.8% and 3.1% respectively.

### **Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **Note 8 – Income Tax Status**

The Plan participates in a prototype plan sponsored by Transamerica Retirement Solutions. The Internal Revenue Service has determined and informed Transamerica Retirement Solutions by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has not obtained a separate determination letter from the Internal Revenue Service. Although the Plan has been amended since the date of the determination letter received by Transamerica Retirement Solutions, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in accordance with the requirements to qualify for tax exempt status.

### **Note 9 – Risks and Uncertainties**

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 10 – Party in Interest Transactions**

Notes receivable from participants represent party-in-interest transactions. Fees paid by the Plan for these investment management and recordkeeping services to Transamerica amounted to \$827,034 for the year ended December 31, 2024. The above party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

### **Note 11 – Plan Merger and transfers to the plan**

Effective January 1, 2024, the Krause Group 401(k) Plan transferred out \$74,100,695 in plan assets of which \$327,230 were held back in 2 funds that had provisions limiting that plans ability transfer them out in total. During 2024 the FJ Management Inc. 401(k) Plan received assets transferred from the Krause Group 401(k) plan that resulted in an increase in assets of \$62,984,881. The remaining \$11,443,044 in assets transferred out of the Krause Group

Plan were transferred to another plan for employees of other divisions which were not acquired by the FJ Management plan sponsor.

During 2024 an additional \$963,675 of assets were transferred into the FJ Management Inc. 401(k) Plan from several employees who moved from separate divisions of the FJ Management group and which have their own separate plans. During 2024 the total transfers in from other plans was \$63,948,556.
