**NOTE 1. DESCRIPTION OF PLAN**

The following description of the Clawson & Staubes, LLC (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Clawson & Staubes, LLC who have attained the age of 21 and completed three consecutive months of service except for employees covered by a collective bargaining agreement, a non-resident alien and a code section 410(b)(6)(c) employees including affiliated employers not as an adopting employer. The Plan's entry dates are the first day of each quarter coinciding with or following the completion of three months of service. The Plan was restated under IRS Cycle 3 restatement effective May 3, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

**Contributions**

Participants may make pre-tax or post-tax contributions of up to 100% of annual compensation but may not exceed the limits set forth by the Internal Revenue Code. The Plan may accept rollover contributions made on behalf of any eligible employee, regardless of whether such employee has met the age and service requirements of the Plan. The Plan Administrator establishes the procedures that regulate the method by which rollovers will be accepted. Participants direct the investment of their contributions into various investments options offered by the Plan.

The Company contributes a safe harbor matching contribution on behalf of each contributing participant in an amount equal to 100% of the participant's contribution not to exceed 3% of the participants compensation, plus 50% of the amount of contributions that exceed 3% of the participant's compensation, but do not exceed 5% of their compensation. The Company may make additional discretionary matching contributions during the year. The Company may make a discretionary profit-sharing contribution to the Plan on behalf of the participant who has completed one year of service during the Plan year. For the year ended December 31, 2023, the Company made safe harbor matching contributions in the amount of \$302,257. The Company did not make any additional discretionary matching contributions nor profit-sharing contributions for the year ended December 31, 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions and allocations of (a) the Company's matching and discretionary contributions, and (b) Plan earnings or losses, and (c) an allocation of administrative expenses. Allocations are based upon the participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants have a fully vested and non-forfeitable interest in their elective deferral, rollover contribution, and employer safe harbor matching contribution accounts. Participants will become fully vested upon their attainment of normal retirement age as set forth in the Plan document, death or disability while an employee of the Company. Vesting in employer discretionary matching contributions and profit-sharing contributions plus actual earning thereon is based on the schedule below:

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates, which correspond with local prevailing rate as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant or designated beneficiary may elect to receive a lump sum payment equal to the balance of the participant's vested account or receive installments of the participant's vested account balance over a period not to exceed the participant's life expectancy. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan Sponsor may elect to distribute funds to the terminated participants through the mandatory involuntary cash-out provisions of the Plan, for any balances less than \$5,000 as an individual retirement account rollover or amount less than \$1,000 directly to the participant.

**Forfeitures**

At December 31, 2023 and 2022, there were \$24,383 and \$6,905 in forfeitures. These accounts may be used to reduce plan administrative expenses and fund additional employer contributions.

**NOTE 2. SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting and includes all adjustments necessary to present fairly the financial statements of the Plan in conformity with the accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment, Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair market value of investments for such investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses of the Plan are paid by the Company and any expenses not paid by the Company are paid directly by the Plan and the Participants. Investment-related expenses are included in the net appreciation or depreciation in fair value of investments, as provided in the plan document.

**Subsequent Events**

The Plan has evaluated subsequent events through the report date the financial statements were available to be issued.

**NOTE 3. CERTIFICATIONS (UNAUDITED)**

The following is a summary of the Plan's asset information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the Plan administrator. The Plan administrator has obtained certifications from Voya Institutional Trust Company, the custodian for 2023 and 2022, that information provided to the Plan administrator by the custodian related to the following investments is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

For the year ended December 31, 2023, the custodian has certified to the completeness and accuracy of the Plan's net appreciation in the fair value of investments of \$2,502,955, interest income on notes receivable from participants of \$263 and interest and dividend income of \$491,999.

**NOTE 4. FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2     Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2023 and 2022.

***Shares of registered investment companies (mutual funds):*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5. FULLY BENEFIT - RESPONSIVE INVESTMENT CONTRACT**

The Plan invests in a fully benefit-responsive investment contract, Voya Fixed Account, issued by Voya Retirement Insurance and Annuity Company ("VRIAC"). The contract value of the fund is \$2,004,878 and \$196,748 for December 31, 2023 and 2022, respectively. The Fixed Account is an obligation of VRIAC's general account which supports all of the company's insurance and annuity commitments. All guarantees are based on the financial strength and claims-paying ability of VRIAC, who is solely responsible for all obligations under its contracts. The fixed maturities in the VRIAC portfolio are generally rated by external rating agencies and, if not externally rated, are rated by VRIAC on a basis similar to that used by the rating agencies. Ratings are derived from three National Association of Insurance Commissions acceptable rating organizations ratings.

Stability of principal is the primary objective of this investment option. The Fixed Account guarantees minimum rates of interest and may credit interest that exceeds the guaranteed minimum rates. Daily credited interest becomes part of principal and the investment increases through compound interest. All amounts invested by the Plan in the Fixed Account receive the same credited rate. The Fixed Account invests primarily in U.S. corporate public and private securities, foreign corporate public and private securities, mortgage loans on real estate, residential and commercial mortgage-backed securities, and U.S treasury, agencies and municipalities.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and an allocation of administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity was provision s, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan Administrator and Trustee do not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

**NOTE 6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Voya Institutional Trust Company is the custodian of the Plan's assets.

Investment vehicles, which are managed by Voya Institutional Trust Company and these transactions are considered as party-in-interest transactions. Any transaction involving these investments are on the open market at fair market value as outlined in Note 3. Consequently, such transactions are permitted under the provisions of the Plan and are exempt party-in-interest transactions under ERISA. For the Plan year ended 2023, fees paid by the Plan amounted to \$1,125 for recordkeeping and investment advisory.

**NOTE 7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer contributions.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as an international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9. TAX STATUS**

The Plan has timely adopted a restated, non-standard defined contribution pre-approved plan 401(k) profit sharing plan. The non-standardized defined contribution pre-approved plan has received an advisory letter from the IRS dated June 30, 2020, whereby the IRS stated that the non-standardized defined contribution pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). While the Plan cannot rely on the non-standardized defined contribution pre-approved plan advisory letter, the Plan administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax exempt.

**NOTE 9. TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10. PROHIBITED TRANSACTION**

The Plan Sponsor did not remit to the Plan's trust certain employee contributions totaling \$6,621 for the year ended December 31, 2023 within the period prescribed by the Department of Labor regulations. Delays in remitting contributions to the trust were due to administrative errors. Plan management has not made the necessary corrections for these late deposits, including calculating and remitting the lost earnings to affected participants accounts in accordance with the U.S. Department of Labor and/or Internal Revenue Service guidelines as of December 31, 2023.
