INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Kismet PEO 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Kismet PEO 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of assets available for benefits as of December 31, 2024, and the related statement of changes in assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution) .

Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year then ended, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the

Their report dated January 23, 2025 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Kismet PEO 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a multiple employer defined contribution plan established effective August 31, 1978 and most recently amended effective September 24, 2024. The Plan that covers eligible employees of Kismet PEO, LLC (the Plan Sponsor) and participating employers (Employers). The Plan Sponsor is an administrative services organization and participating employers have become members of the Kismet PEO and have agreed to adopt the provisions of the Plan with rights to elect specific provisions at the individual employer level. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - Eligible employees of Kismet PEO, LLC, Gilbert's Insurance Agency, Inc., Synergy Insurance Company, Synergy Claims Management Company, Inc., SOS Safety Solutions, LP, Kismet Consulting, LLC, Buhl Regional Health Foundation, Community Partnership, Inc., Engage Energy & Industrial Consulting, Hruska Janitorial, Inc., Industrial Robot Supply, Inc., Penn-Northwest Development Corporation, Petra Power, LLC, Synergy Select, LP, G-Force Security Solutions, LLC and Therapanacea, Inc., who have completed the specific provisions applied at the individual employer level, are eligible for enrollment in the Plan. Eligibility provisions for participating employers include minimum age requirements ranging from 18 to 21 years of age and minimum service requirements ranging from 2 months to 12 months. Employees may enroll in the Plan on the first day of the Plan year quarter or month following the date in which eligibility requirements are met, depending on their individual employer's adopted provisions.

Effective January 1, 2025, G-Force Security Solutions, LLC entered into a transfer agreement to transfer assets into the Plan.

Hruska Janitorial, Inc. entered into a transfer agreement on December 31, 2023 to transfer assets out to a different plan.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in net assets during the reporting periods. Actual results could differ from those estimates.

Contributions - Participants may elect to make pre-tax or after-tax (Roth) contributions the Plan up to 100% of compensation, subject to IRS limitations. Rollover contributions represent contributions from other plans and are not subject to IRC contribution limits.

The Employers may contribute safe harbor contributions based on participants' annual compensation, regardless of the participants' contributions, at their discretion. The Employers may also make profit sharing and matching contributions at their discretion. Matching contributions are contributed based on the amount of the participants' elective deferrals and profit sharing contributions are allocated based on participants' annual compensation. The Employers authorized discretionary profit sharing contributions of \$274,893 and \$255,640 during the years ended December 31, 2024 and 2023, respectively.

The Plan has an automatic enrollment provision (1% salary deferral with 1% increases on the first day of each Plan year until reaching a maximum of 15%) whereby employees must elect out of the Plan if they do not wish to participate.

Participant Accounts - Each participant's account is credited with the participant and applicable employer contributions and an allocation of the Plan's earnings and expenses. Earnings are allocated based on a participant's account balance as a percentage of the total account balances for the applicable investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Participants may direct their contributions as well as their share of employer contributions and any related earnings into various investment options, and may change their investment options at any time.

Vesting - Participants are immediately vested in their contributions, Employer's safe harbor contributions, and actual earnings thereon. The Employers elect individual vesting schedules for matching contributions, profit sharing contributions, and actual earnings thereon.

Payment of Benefits - On termination of service due to death, disability, retirement, or other reasons and subject to certain restrictions, a participant or designated beneficiary may elect to receive either a lump sum amount equal to the value of his or her account, a rollover to another qualified plan or individual retirement account, or partial withdrawals, subject to applicable tax withholding requirements. All distributions are subject to the provision of the Plan for each employer. After termination, if a participant's vested balance is less than or equal to \$1,000 the vested account may automatically transferred to an individual retirement account established in the participant's name without participant consent.

Forfeitures - Forfeitures shall be used to reduce the Employers' contribution to the Plan. As of December 31, 2024 and 2023, the available balance in the forfeitures account was \$30,033 and \$30,899, respectively. During the years ended December 31, 2024 and 2023, there were forfeitures of \$34,304 and \$33,870, respectively.

Administrative Expenses - Certain administrative expenses are charged directly to the individual participant accounts, others are allocated. Participants who take a note from the Plan incur a one-time fee for establishing the note. Participants may elect to pay additional fees for express delivery of any type of distribution. Administrative expenses are paid by the Plan Sponsor to the extent not paid by the Plan.

Notes Receivable From Participants - Certain participating employers of the Plan have elected provisions allowing for participants to borrow funds from their account balance. Permitted participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years or a reasonable period of time not to exceed 10 years for the purchase of a primary residence. Loans accrue interest at a rate equal to the prime rate plus 1% at the inception of the loan and are secured by the participant's account balance. The interest rates on the loans outstanding at December 31, 2024 and 2023 ranged from 5.25% to 9.5% and 4.25% to 9.5%, respectively.

Investment Valuation and Income Recognition - Investments are reported at fair value. The Plan presents net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on these investments, in the statements of changes in assets available for benefits. The unrealized appreciation or depreciation of investments is determined by the change in current market value from the beginning of the period to the end of the period (if held for the entire period), or from the date of purchase to the end of the period. Realized gains and losses on securities sold or redeemed are determined on the basis of specific identification, from the date of purchase to the date of sale. Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded as earned based on the ex-dividend date. Investment management fees are deducted from income earned and are reflected as a component of net appreciation or depreciation in the fair value of investments.

Fair Value Measurements - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded (Level 1 inputs)

Stable Value Fund: Collective investment trust valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

Risks and Uncertainties - The Plan invests in various investment securities which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Subsequent Events - The Sponsor has analyzed subsequent events through October 8, 2025, the date which the financial statements were available to be issued. During August 2025 the Plan custodian was changed from Ascensus, LLC to Transamerica.

2. CERTIFIED FINANCIAL INFORMATION

Ascensus, LLC, (formerly Newport Trust Company, LLC), the custodian, has certified that the following information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Information included in the schedule of assets held for investment purposes at December 31, 2024, as shown on the accompanying schedule.

3. PLAN TERMINATION

The Plan Sponsor anticipates and believes that the Plan will continue without interruption but reserve the right to discontinue the Plan at their discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested.

4. INCOME TAX STATUS

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan from Ascensus, LLC. The Internal Revenue Service has stated in a letter dated November 30, 2020 that the Plan, as designed, was in accordance with the applicable sections of the IRC. Although the Plan has since been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for years before 2021.

5. RELATED PARTIES AND PARTIES-IN-INTEREST

Ascensus, LLC (formerly Newport Trust Company, LLC) serves as custodian of the Plan, and accordingly, is considered a party-in-interest.

Neither the Sponsor nor the employees of the Sponsor involved in administering the Plan receive any compensation from the Plan.
