Note 1. Description of Plan

The following brief description of the Sickness and Accident Fund of Local One, Amalgamated Lithographers of America, For Lithographic Employees (the "Plan") is provided for general purposes only. Reference to the Plan document should be made for more complete information.

General - The Sickness and Accident Fund of Local One, Amalgamated Lithographers of America, for Lithographic Employees is a multiemployer plan covering employees of participating employers pursuant to collective bargaining agreements between Local One, Amalgamated Lithographers of America ("Local One, ALA") and signatory employers, including those represented by the Metropolitan Lithographers Association, Inc. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration of the Plan is the responsibility of the Board of Trustees (the "Trustees") and is governed by a joint board.

Eligibility - Retired participants aged between 62 and 65 are eligible for benefits if they meet one of the following criteria: they have participated in the Fund for 25 years, including within the 24 months prior to retirement at age 62; they have participated in the Fund for 35 years, including within the 36 months at or after age 62; or they have participated in the Fund for 40 years, regardless of when such participation ended.

Contributions - Employer contributions are made in accordance with the provisions of agreements entered into by the Plan and participating employers. Participants contribute specified amounts based on applicable monthly premiums.

Benefits - The Plan is a Health and Welfare fund providing hospital, medical, prescription drugs, dental, disability benefits, and other benefits and services for eligible employees (including retired employees and employees temporarily unemployed) and other benefits for eligible dependents of employees. The Plan also provides vacation and certain relocation benefits.

Insured Benefits - The Plan has entered into multiple group contracts with private insurance carriers to provide hospital, medical, prescription drug and dental benefits. The Plan also entered into a participation agreement with Trucking Employees of New Jersey Welfare Fund, Inc. (TENJ) to provide hospital, medical, dental, vision, and prescription drugs to the Plan's covered members.

Self-insured Benefits - Other Plan benefits including vacation and relocation benefits are self-insured. A participant's vacation account includes the amount attributable to contributions received from an employer during the fiscal year of the Plan. Participant contributions are received by the Fund on an after-tax basis. The vacation benefit is available

Self-insured Benefits (continued) and payable as of May 1st of each year with proper application to the Plan. Relocation benefit is terminated, unpaid relocation benefits are payable when befitting.

Note 2. Summary of Accounting Policies

Basis of Accounting and Use of Estimates - The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits – Premium are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. All other self-insured benefits are recorded when paid by the Plan. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Employers' Contributions and Related Receivables - Payroll contributions are determined from reports submitted by employers on a self-reporting basis. The amount of employer contributions receivable represents the estimated contributions due from employers.

Property and Equipment - Property and equipment, which is predominately used in operations, is stated at cost, less accumulated depreciation, or amortization. Depreciable assets are depreciated principally by the straight-line basis over the estimated useful lives, ranging from three to 31.5 years. Expenditures for maintenance and repairs are expensed as incurred, whereas additions and improvements that extend the life of the asset are capitalized. Depreciation and amortization expense is recorded in fund administrative expenses.

Fees and other Expenses - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with related affiliated entities. In computing these allocated costs, various factors were considered, including the time spent, space used, costs incurred, and volume of transactions relating to the Plan in relation to the other plan (see note 10)

Operating Leases - The Plan has elected, for all underlying classes of assets, to not recognize right of use assets and lease liabilities for leases obligations that are not material to the financial statements and therefore related disclosures under Accounting Standards Codification Topic 842 for these leases are not included in the financial statements. The Plan recognizes lease expenses associated with immaterial leases as incurred over the lease term.

Subsequent Events - The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Note 3. Postretirement and Postemployments Benefits Obligations

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants upon retirement. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements. The obligations represent the amounts that are expected to be funded by contributions and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and (b) active employees after retirement from service.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligation. If the assumed rates increased by one percentage point each year, it would increase the obligation by \$50,994 and \$54,628 as of December 31, 2024 and 2023, respectively.

Accumulated Eligibility Credits at December 31, 2024 and 2023 are estimated by the Plan's actuary in accordance with accepted actuarial principles.

Note 6. Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the plan has taken any uncertain position that more likely than not be sustained upon examination by the relevant tax authority. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 7. Termination of Plan

Although it has not expressed any intention to do so, the Trustees has the right under the Plan to terminate the Plan subject to the provisions of ERISA and the terms of the CBA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants.

Note 8. Transactions With Related Party and Parties-In-Interest

The Plan share some common trustees, administrative staff and facility with Local One, ALA and Amalithone Realty Corp. The Plan reimburses Local One, ALA and Amalithone Realty Corp., for its pro-rata share of common operating expenses incurred to provide plan related services. Charges incurred amounted to \$ 5,824 and \$4,811 for the years ended December 31, 2024 and 2023, respectively.

The Plan reimburses related entities for payroll and related expenses expended on its behalf. Reimbursements amounted to \$78,384 and \$63,509 for the years ended December 31, 2024 and 2023, respectively.

Note 9. Risks and Uncertainties

The Plan maintains its cash accounts at a commercial bank. Cash accounts at the bank are insured by Federal Deposit Insurance Corporation (FDIC) for up to \$250,000. From time to time, the Plan may have amounts on deposit in excess of FDIC limits. Management believes the Plan is not exposed to any significant credit risk on cash.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 10. Operating Lease

The Plan, together with other affiliates, is party to an operating lease with its affiliate, Amalithone Realty Corp, for the use of office space located at 113 University Place, New York, NY. The original lease was signed in 1998 and has since been extended and modified six times, most recently extended effective July 1, 2023 through June 30, 2026.

The Plan's share of the lease obligation is determined annually based on the results of a space allocation study.

Note 11. Loan Payable – Local One

In August 2009, Local One provided a \$500,000 loan to the Local One-L Health and Welfare Plan to secure health insurance benefits and pay reasonable administrative costs with the creation and maintenance of the Plan. The terms of the loan stipulate that the loan will be paid without interest and may be called by Local One at any time after the Health and Welfare Plan has established a reserve equal to at least six months of premiums for existing participants after the loan has been repaid.

Note 12. Plan Amendments

During the Plan years ending December 31, 2024 and 2023, there were no significant plan amendments affecting the Plan.
