Notes to Financial Statements

December 31, 2024 and 2023

1. Plan Description

The following description of Pacific Northern Environmental 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan was established June 1, 1996 and is a defined contribution plan covering eligible employees, as defined by the plan document, of Pacific Northern Environmental, LLC, formerly known as Pacific Northern Environmental Corp, and certain adopting affiliates (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”). The Plan’s trustees are responsible for oversight of the Plan including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Eligibility

Eligible employees, upon completing two months of employment with the Company and attaining 18 years of age, may participate in the Plan with respect to elective salary deferral contributions on the first day of the month coincident with or next following satisfaction of the eligibility requirements. With respect to employer matching and nonelective profit sharing contributions, an employee must complete two months of service, attain 18 years of age, and, if under age 62, be employed on the last day of the plan year to participate commencing on the first day of the year coincident with or next following satisfaction of the eligibility requirements. Members of collective bargaining units where retirement benefits were the subject of good faith bargaining and non-resident aliens are excluded from participating in the Plan.

Contributions

Each year participants may elect to contribute to the Plan a portion of their eligible compensation, as defined. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they elect not to participate. Until changed by the participant, automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation and their contributions are invested in a designated fund. An automatically enrolled participant’s automatic deferral rate will increase by 1 percent each plan year, annually on July 1st, up to a maximum deferral rate of 8 percent of eligible compensation. For the year ended December 31, 2024, on an annual basis, the Company elected to contribute a matching contribution up to 40 percent of the first 5 percent of eligible compensation that a participant contributes to the Plan, plus an additional 2 percent if the participant contributes 6 percent to the Plan, plus an additional 0.50 percent if the participant contributes 7 percent or more to the Plan, plus an additional 0.50 percent if the participant contributes 8 percent or more to the Plan. The Company may also elect to make a discretionary profit sharing contribution. Discretionary profit sharing contributions, if any, are allocated to employees who are eligible to participate in the non-elective portion of the Plan based on each participant’s eligible earnings compared to the eligible earnings of all other employees who share in contribution. Participants direct the investment of their elective salary deferrals and their allocation of employer contributions into any of the investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the employer's discretionary profit sharing contributions and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer contributions portion of participant accounts is based on years of credited service. For employer contributions, participants vest according to a six year graded vesting schedule at the rate of 20 percent per year after two years of credited service. A participant is 100 percent vested after six years of credited service. Participants also become fully vested in employer matching and non-elective contributions upon death, disability, or attainment of retirement age as defined in the plan document.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants are permitted to have only one outstanding loan simultaneously. Participant loans are collateralized by the balance in the respective participant's account. Each loan's interest rate is determined by management at the issuance date based on prevailing rates for similar instruments and remains fixed throughout the duration of the note. Until otherwise determined by the Plan's trustees, the interest rate will be the prime rate of interest published by Wall Street Journal as of the date of the loan plus 2 percent. Interest paid by a participant is credited to the participant's individual account. Principal and interest are paid ratably through payroll deductions with payment terms up to five years for general purpose loans or thirty years if the loan is used to acquire a principal residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account either in installments or a lump-sum amount. If the participant's vested account balance is less than \$5,000, the Plan may distribute the amount in a lump sum payment. Participants may elect to take a partial or total distribution from their elective salary deferral contributions account when they reach age 59½, or at any time thereafter, even if they have not terminated employment with the Company. Amounts attributable to rollover contributions to the Plan or voluntary after-tax elective salary deferral contributions may be withdrawn from the Plan without restriction.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,666 and \$7,479, respectively. These accounts may be used to offset a portion of the Plan's expenses or to reduce future employer contributions. Plan expenses and employer contributions during the year ended December 31, 2024 were reduced by \$14,830 and \$20,055, respectively, from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by the Plan's investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a corresponding benefit payment is recorded.

Benefits Payments

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the Plan’s investment custodian for all of the Plan’s assets as follows:

Common/collective trust funds: Investments in common/collective trust funds are presented at estimated fair value, which is determined based on the unit value of the related fund. Unit value is generally determined by the sponsor of the collective investment funds by dividing each respective fund’s NAV by its units of participation outstanding at each valuation date.

Registered Investment Companies. Registered investment companies, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the fund. Registered investment company investments held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Insurance company general accounts. The fair value of unallocated insurance contracts, consisting of assets allocated to Key Guaranteed Portfolio Fund through a Empower Annuity Insurance Company of America group annuity contract, is calculated based on contributions made, less withdrawals and administrative expenses, plus interest credited. The Plan’s investments in unallocated contracts and the related interest rate guarantees are subject to the credit risk of Empower Annuity Insurance Company of America and are solely funded by the assets held in its general account. There are no

reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate for the contract is reset quarterly. The average yield earned by the Plan and crediting rate were 1.41 percent for the year ended December 31, 2024. Certain events may limit the ability of the Plan to transact at contract value. Such events include premature termination of the contracts by the Plan, plant closings, layoffs, termination of the Plan, bankruptcy, mergers, and early retirement incentives. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The unallocated contracts are not considered to be fully benefit responsive. Accordingly, unallocated contracts are presented at fair value and are classified in Level 2 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Empower SecureFoundation Balanced Fund

The Plan has entered into a contract with Empower Annuity Insurance Company of America to provide for the availability of certain lifetime withdrawal benefits (the "Withdrawal Benefits") to participants of the Plan. Under the agreement, shares of Empower SecureFoundation Balanced Fund have been made available as an investment option to participants of the Plan. Shares of the fund may only be purchased in conjunction with the purchase and acceptance of the Withdrawal Benefits issued by Empower Annuity Insurance Company of America, or its predecessors or affiliates, either as a fixed deferred annuity contract, a certificate to a group fixed deferred annuity contract, a variable annuity contract, or a rider to a variable annuity contract. The Withdrawal Benefits are intended to provide a periodic income stream for the life of an individual participant,

provided certain conditions are met, commencing approximately at age 65. Contributions, periodic withdrawals or payments from the contract, guarantee benefit fees and other fees are governed by the terms of the Withdrawal Benefits contract. The redemption or exchange of a participant's shares of the fund would generally result in the cancellation of the Withdrawal Benefits. The Withdrawal Benefits may also be terminated under other circumstances.

6. Related Party and Party-In-Interest Transactions

Certain assets held by the Plan are investments in registered investment companies and insurance company general accounts for which Empower Annuity Insurance Company of America, Empower Trust Company, LLC, or affiliated entities ("Empower") acts as account manager, investment custodian, or issuer; therefore, these transactions qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan and receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan. Excess revenue sharing, if any, is deposited into the Plan's ERISA spending account which is then used to pay a portion of the Plan's administrative expenses.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through charges at the investment level rather than by direct payments from the Plan. During the year ended December 31, 2024, the Plan made direct payments totaling \$146,064 for a portion of the Plan's administrative expenses, including investment advisory and recordkeeping fees, which were not offset by revenue sharing. The plan sponsor pays directly certain other fees related to the Plan's operations.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would continue to be fully vested in the employer contributions portion of their accounts.

8. Tax Status

The Plan has adopted a volume submitter agreement as the plan document which the Internal Revenue Service has determined, by a letter dated November 14, 2022, is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC, and therefore, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
