INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees and Plan Administrators of
Stewart Manufacturing, LLC 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Stewart Manufacturing, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Stewart Manufacturing, LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stewart Manufacturing, LLC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Stewart Manufacturing, LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

NOTE A – DESCRIPTION OF PLAN

The following description of the Stewart Manufacturing, LLC 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all full-time employees of Stewart Manufacturing, LLC (“Employer”). Eligible employees have three months of service and have attained the age of eighteen. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established January 1, 1998 and has a favorable determination letter from the Internal Revenue Service (IRS).

Plan Administration – The Plan is administered by management personnel of the Employer. The Plan’s recordkeeper, The Security National Bank of Sioux City, Iowa, as agent for First Bank Upper Michigan, the trustee, is responsible for management of the Plan’s assets.

Contributions – Participants may contribute to the Plan by means of a wage deferral agreement. They may defer any percentage of eligible compensation, as defined in the Plan, up to the maximum amount permitted by the Secretary of Treasury, \$23,000 for 2024 and \$22,500 for 2023. Participants projected to be age 50 or older by the end of the calendar year may also make a catch-up contribution of up to \$7,500 for 2024 and 2023. The Employer contributes 50% of the first 6% of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Employer. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contribution, the Employer’s match, any discretionary contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. Participants designate the investment options into which contributions are allocated, and they may redirect their investment options directly with the recordkeeper on any business day. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer’s matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Participants will vest as follows:

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Notes Receivable from Participants – Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 reduced by the excess of the Participant’s highest outstanding balance of all loans on any day during the year period ending on the day before the loan is made, or 50% of their vested account balance. Participants may only have one loan outstanding at any given time. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loans must be repaid in level payments over a five-year period unless the loan was for the purchase of a principal residence, in which case the term can be up to 10 years. The loans are secured by the balance in the participant’s account and bear a reasonable rate of interest of 2% over Prime. Principal and interest are paid ratably through payroll deductions.

Excess Contributions Payable - There were no excess contributions for the years ended December 31, 2024 and 2023.

Payment of Benefits – On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account or in annual installments. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution if it is less than \$1,000. If the account balance is greater than \$1,000 but less than \$5,000 and the participant does not elect to receive the distribution directly or have it paid to an eligible retirement plan by direct rollover, then the Plan’s administrator shall pay the distribution in a direct rollover to an individual retirement plan determined by the Plan administrator. If a participant’s vested account balance is greater than \$5,000, the participant may elect to receive it as a lump-sum distribution or may have it rolled over to another qualified plan or IRA.

Forfeited Accounts – At December 31, 2024 and 2023, the balance of forfeited non-vested accounts was \$17,598 and \$1,557, respectively. Forfeitures may be used to pay plan expenses or used to reduce the employer’s matching contributions under the Plan. In 2024 and 2023, employer contributions were reduced by \$0 and \$7,365, respectively, from forfeited non-vested accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements and supplemental schedules of the Plan are prepared using the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

Investment Valuation and Income Recognition – The investments in all of the funds are presented at fair value, based on the quoted market prices of the underlying securities within each fund at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expense when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits - Benefits are recorded when paid.

Date of Management's Review - Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through the date of the accompanying independent auditor's report, October 13, 2025, which is the date the financial statements were available to be issued.

NOTE C – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE D – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE E – INCOME TAX STATUS

The Plan operates under an adoption agreement in connection with a prototype 401(k) profit-sharing plan. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the IRS dated June 30, 2020 stating the prototype plan and related trust constitute a qualified plan under Section 401 of the Internal Revenue Code. Although the Plan has been amended since that date, the plan administrator and management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. As such, no provision for income taxes has been included in the Plan's financial statements.

NOTE F – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of quoted prices for similar assets in active markets or identical or similar assets in inactive markets. It could also be inputs other than quoted prices that are observable for the asset or those that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate market valuation techniques on a recurring basis based on the available inputs to measure the fair value of its investments. The Plan measures the fair value of mutual funds and cash equivalents using Level 1 inputs when available because they generally provide the most reliable evidence of fair value. No Level 2 or 3 inputs were used.

NOTE H – PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by subservice organizations of The Security National Bank of Sioux City, Iowa, the recordkeeper of the Plan. Investments with parties-in-interest are indicated on the supplementary Schedule of Assets Held at the End of the Year. Notes receivable from participants and fees paid by the plan for investment management and other services are also considered transactions with parties-in-interest. Fees paid by the Plan to the recordkeeper for investment management and other services amounted to \$45,861 and \$49,192 for the years ended December 31, 2024 and 2023, respectively. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE I – ERISA BOND REQUIREMENT

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets and is required to be at least equal to the lesser of 10% of the Plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024 and 2023, the Plan's sponsor maintained bond coverage in the amount of \$500,000 each year.
