INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
of the 403(b) Thrift Plan of Change, Incorporated

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the 403(b) Thrift Plan of Change, Incorporated, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 403(b) Thrift Plan of Change, Incorporated's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Note 1 – Description of Plan:

The following description of the 403(b) Thrift Plan of Change, (the “Plan”) Incorporated provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Change, Incorporated (the “Organization”). All employees of the Organization are eligible to participate in the Plan, make salary reduction contributions, and are eligible to receive the Organization’s matching contribution, except for those employees who are classified or treated as independent contractors and those who are eligible to make salary reduction contributions to another plan described in Sections 401(k) or 403(b) of the Code, or a governmental eligible deferred compensation plan described in Section 457(b) of the Code. There is no minimum age or service requirement to make salary reduction contributions to this plan. However, in order to receive an employer match contribution the employee must have worked 1,000 hours and completed one year of service. Employees are included as a participant in the Plan on the first day of the month following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may make elective deferrals up to the maximum percentage of eligible compensation or dollar amount permissible under the Internal Revenue Code, \$23,000 for 2024, and \$22,500 for 2023. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions in the amount of \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. There is also a provision for special 403(b) “catch up” for employees with 15 years of services with a public school system, hospital, home health services agency, health and welfare agency, church, or convention of the association of churches, the elective deferral limit can be increased by the lessor of:

- \$3,000
- \$15,000 reduced by the total of special 403(b) catch-up elective deferrals made for the qualified employee by the Organization in prior years, or
- \$5,000 multiplied by the number of years of service at the Organization, reduced by the total deferrals made for earlier years

An employee who qualifies for the 15-year rule can have an elective deferral as high as \$26,000 for 2024 and \$25,500 for 2023. The Organization will make a matching contribution on the participant’s behalf equal to 100% of the salary reduction amount the participant contributes during the plan year. However, such matching contributions shall not exceed \$3,000 of the participant’s compensation received during the plan year. Contributions are subject to certain IRS limitations.

Note 1 – Description of Plan (Continued):

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Organization's contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are vested immediately in their contributions, rollover contributions, the Organization's matching contribution, and actual earnings thereon.

Plan Loans

Loans issued to participants of the Plans are collateralized loans. There are no withdrawals of loan amounts from a participant's account nor are principal and interest payments applied towards a participant's account. Rather the participant is borrowing from Mutual of America Life Insurance Company and using their account balance as collateral. For a loan to be issued, the loan amount, plus a 20% reserve, must be placed into the general account. The amount is then considered to be "in reserve" and cannot be withdrawn or transferred. As loan payments are applied, the "reserved" amount is reduced by the amount of the loan payment and can be withdrawn and/or transferred. These loans are not considered to be assets of the Plan. Loans are to be repaid over a period not to exceed five years, unless used to acquire a principal residence, and bear a variable rate of 5.85% as of December 31, 2024 and 4.60% as of December 31, 2023. The amount of outstanding loans at December 31, 2024 and 2023 were \$243,137 and \$162,884, respectively.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant or a designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or a withdrawal may be paid in any other method of payment permitted by the contract from which the withdrawal is made. Amounts contributed may only be withdrawn in-service upon demonstration of financial hardship or after the participant reaches the age of 59.5 years. Amounts withdrawn due to hardship must be distributed in a single sum.

Note 2 – Summary of Significant Accounting Policies:

Basis of Accounting

The financial statements of the 403(b) Thrift Plan of Change, Incorporated have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for the discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Organization are recorded in the year in which the participant compensation is earned.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

Reclassification

The Plan's policy is to reclassify amounts reported in prior year financial statements when necessary for classification adopted during the current year.

Consideration of Subsequent Events

For the year ended December 31, 2024, the Plan has evaluated the subsequent events for potential recognition and disclosure through October 10, 2025, the date the financial statements were available to be issued. No subsequent event items were identified.

Note 3 – Certified Investments:

Certified information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Insurance Company, the custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 - Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under FASB ASC 820 are described below:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 4 - Fair Value Measurements (Continued):

Level 3- Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value except for those measured and reported using the net asset value ("NAV") practical expedient. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled Separate Accounts – Securities are listed on national securities exchanges and valued on the basis for year-end closing price. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits, and administrative maintenance charges and other items) and reported by the insurance company denotes readily determinable fair value. These investments are measured using the NAV practical expedient.

Interest Accumulation Account – A guaranteed investment option that is measured using the NAV practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 - Tax Status:

Effective January 1, 2020, the Plan documents were converted to pre-approved Volume Submitter Plan and Trust documents sponsored by Mutual of America Life Insurance Company. The Internal Revenue Service (IRS) has determined and informed Mutual of America Life Insurance Company by a letter dated March 31, 2017 that the form of the volume submitter plan and trust documents being utilized by the Plan are acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. As permitted by this IRS letter, the Plan is relying on the IRS approval of the volume submitter plan documents it is utilizing, and did not obtain its own determination letter from the IRS. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC) and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (U.S. GAAP) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan has not been examined by the Internal Revenue Service for open years under the Statute of Limitations.

Note 7 – Related Party Transactions and Party-in-Interest Transactions:

Plan investments are managed by Mutual of America Life Insurance Company. Mutual of America is the custodian, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan, and paid to Mutual of America are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Note 8 – Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
