INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Five Star Fabricating, Inc. 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Five Star Fabricating, Inc. 401(k) Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Five Star Fabricating, Inc. 401(k) Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 22, 2025, which is the date the financial statements were available to be issued.

Key parties of the plan - Five Star Fabricating, Inc. is the plan sponsor, employer and plan administrator. PPG Retirement Plan Services Ltd. is the third-party administrator that maintains plan documents and tax counsel that performs various compliance tests. Voya Retirement Insurance and Annuity Company ("Voya") is the investment agent that holds custody of plan investment assets and record keeper that maintains participant records. An employee of the plan sponsor is the plan trustee. Baird Insurance Services Inc. is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to the plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. At the end of each business day, Voya determines the value of the investments and allocates the value to participants. Earnings, including the net appreciation (depreciation) in fair value of investments bought, sold or held during the years, are reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments at fair value.

Voya separate accounts - The Voya separate accounts are valued at the net asset value ("NAV") as provided by Voya. The NAV is generally based on the fair value of the underlying mutual fund investments held by the separate accounts less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the separate account would sell the investment for an amount different than the reported NAV.

Investment at contract value - The plan has a fully benefit-responsive guaranteed investment contract through an annuity contract issued by Voya. Voya maintains the contributions in a general account. Voya is contractually obligated to repay the principal and a declared amount of interest. The contract provides two declared interest rates; a current rate, determined at least monthly, and a guaranteed minimum floor rate, determined at least annually. The average yield earned by the fund was 1.50% in 2024 and 1.37% in 2023.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value at any time. However, Voya may limit participant transfers, which are made at contract value, from this investment to other investments within the plan. The plan administrator has determined this transfer limit does not have a practical effect in determining the fully benefit responsiveness of this contract.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor can request a lump sum distribution with a market value adjustment or an installment payout, at contract value, over a period of years. The contract will continue in full force until all assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with Voya. As of the date these financial statements were available to be issued, the plan sponsor is not aware of any events that may limit the ability of the plan to transact at contract value with Voya or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was established on July 1, 1992 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to participate in the plan if they have reached the age of eighteen and completed 250 hours of service in a three-month period. An employee will be deemed a participant and allowed to enter the plan immediately following the date the plan's eligibility requirements are met.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. The plan has safe harbor provisions requiring the employer to make safe harbor matching contributions equal to 100% of the first 3% of compensation that a participant contributes to the plan and 50% of the next 2% of compensation that a participant contributes to the plan. These contributions are funded coinciding with payroll.
- d. Employer non-elective and/or matching contributions may be made at the discretion of the employer's board of directors. There were no such employer matching contributions in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions, rollover contributions and an allocation of employer contributions. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral, rollover and employer safe harbor matching contributions and related earnings. For any discretionary employer contributions and related earnings, participants begin vesting upon completing two years of service, at which time they are 20% vested. The participant's vesting then increases at the rate of 20% per year thereafter. Upon death, disability or qualified retirement (defined as attaining age 60) while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or retirement. Participants generally receive distributions of their accrued benefits in the form of a lump sum payment. In-service withdrawals can commence upon reaching age 59½. Hardship withdrawals are permitted under certain circumstances.

Forfeitures - Forfeited nonvested accounts may be used to pay plan administrative expenses or reduce employer contributions. Such accounts exist from discretionary employer contributions that were made in years prior to implementing the safe harbor provisions. Forfeitures used to pay plan administrative expenses were \$1,000 in 2024. Forfeitures used to pay plan administrative expenses were insignificant in 2023. Unapplied forfeitures were insignificant as of December 31, 2024 and 2023.

Notes receivable - Participants may request loans from the plan subject to certain limitations. Each participant may only have one loan outstanding at a time. The minimum loan amount is \$1,000 and the loans generally cannot exceed the lesser of \$50,000 or one-half of the participant's vested balance. Loans must be paid back over a period not to exceed five years, the exception being when the loan is for the purchase of a primary residence, in which case the maximum term is 15 years. As of December 31, 2024, the notes receivable had interest rates ranging from 4.25% to 9.50% with various repayment schedules through October 2028. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

Administrative expenses - Certain fees and expenses are paid by the employer. Certain other fees and expenses are paid with plan assets and recorded by the plan as administrative expenses in the accompanying financial statements. Such expenses include participant directed fees for distribution and loan processing and optional individual investment management services and nonparticipant directed fees for service and administration paid via forfeitures.

3. PARTY-IN-INTEREST TRANSACTIONS

The plan investments are managed by Voya. Voya is also the investment agent that holds custody of plan investment assets. As such, transactions between the plan and Voya qualify as party-in-interest transactions. Voya also provides certain administrative services to the plan pursuant to a service agreement between the plan sponsor and Voya. Voya receives revenue from mutual fund service providers in the form of indirect compensation for services Voya provides to the funds. This revenue is used to offset certain amounts that would otherwise be owed by the plan to Voya for its administrative services to the plan.

Notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in any unvested employer contributions and related earnings.

5. INCOME TAX STATUS

The plan is operating under a PPG Retirement Plan Services non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The letter provided by the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As a result, the plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however the plan administrator and tax counsel believe that the plan currently is designed and operated in compliance with the applicable requirements of the IRC, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.
