# **Infinity Foods Retirement Savings Plan**

## **Notes to Financial Statements**

### **December 31, 2024 and 2023**

---

#### **1. Plan Description**

Infinity Foods Retirement Savings Plan (the “Plan”), a defined contribution plan, was established on May 20, 2016. The Plan’s participants include employees of Great American Snacks, Inc. (the “Company”) and certain former employees of Infinity Foods, Inc. Employees of Great American Snacks, Inc. became eligible to participate in the Plan effective January 1, 2017. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all common law employees of the Company, as defined by the Plan document, commencing on the date of employment.

Temporary and seasonal employees are eligible to participate in the Plan once they have completed one year of eligibility service which is defined as at least 1,000 hours of service within a 12 consecutive month period ending each December (“Plan Year”). There are no eligibility service requirements in the Plan for employees other than temporary or seasonal employees.

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **Investments**

All investments under the Plan are participant directed. Upon enrollment in the Plan, a participant may direct both employee and employer contributions in 1% increments in any of the 20 investment options. Participants may change their investment allocations at any time.

#### **Contributions**

A participant may elect to contribute up to 50% of their annual compensation, within certain limitations, to the Plan on a pre-tax or post tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may, in its discretion, make a Regular Matching Contribution to the Plan for each Plan year up to an additional 3%, which shall be determined by the Company for each Plan Year. The discretionary Regular Matching Contribution was 3% for the years ended December 31, 2024 which totaled \$413,392, partially offset by forfeitures of \$77,497.

Participants can also make contributions to the Plan in the form of a rollover of funds from another qualified plan. There were no rollover contributions for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution, employer contributions and an allocation of Plan earnings, losses and expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Each participant is fully vested in his or her elective employee contributions, catch-up contributions and rollover contributions immediately. Each participant becomes fully vested in his or her Employer Regular Matching Contributions upon completion of three years of vesting service or upon reaching normal retirement age of 65, with no vesting during the first two years.

### Transfer of Assets

In November 2024, the Nampa, ID plant closed resulting in the merging of the Plan with an affiliate benefit plan, McCain Foods USA, Inc., with an effective date of December 2024. Due to the merger, \$3,787,570 of assets, inclusive of \$61,782 of notes receivable were transferred to the Plan on December 27, 2024, and the remaining assets of \$528,779 were transferred into the Plan in 2025.

### Benefits

On termination of service due to death, disability, retirement or otherwise leaving employment, the participant or beneficiary may elect to receive a lump sum amount equal to the value of the vested balance allocated to his account. If a participant's vested interest in his or her account does not exceed \$1,000, an automatic distribution of such interest shall be made in a lump sum payment or through direct rollover. Under Federal law, benefit payments must begin on April 1st following the calendar year in which the participant reaches age 72, or 73 if a participant reaches 72 after December 31, 2023.

### Notes Receivable from Participants

Notes receivable from participants are permitted under the Plan and are subject to such conditions and limitations as the Retirement Plan Administrative Committee deems necessary for administrative convenience and to preserve the tax-qualified status of the Plan.

No loan to any participant or beneficiary may be made to the extent that such loan, when added to the outstanding balance of all other loans to the participant or beneficiary, would exceed the lesser of (a) \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans during the one-year period ending on the day before the loan is made, or (b) one-half the current value of the nonforfeitable accrued benefit of the participant. The loan terms are generally between one and five years with a term of up to twenty years for the purchase of a primary residence.

Loans shall be made available to all participants and beneficiaries on a reasonably equivalent basis. Loans shall not be made available to highly compensated employees (as defined in Section 414(q) of the IRS Code) in an amount greater than the amount made available to other employees. Loans must be adequately secured using not more than 50% of the participant's vested account balance and bear a reasonable interest rate. Interest rates ranged from 4.25-9.5% at December 31, 2024, and December 31, 2023.

### Forfeitures

When a participant terminates employment prior to vesting in all of his or her employer contributions, such employer contributions and the net investment income thereon are forfeited. Forfeitures are used to reduce future employer contributions under the Plan. During 2024, there were \$77,497 forfeitures used to offset employer contributions. The Plan had \$24,060 and \$28,408 unallocated forfeitures as of December 31, 2024, and 2023, respectively.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation in the fair value of its investments which consists of the net realized gains and losses and the net unrealized appreciation and depreciation on those investments.

Purchases and sales of securities are recorded on a trade-date basis. Income from investments is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

#### **Risks and Uncertainties**

The Plan provides for various investments in any combination of collective trusts and mutual funds. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or an international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Delinquent Notes Receivable**

Delinquent notes receivable from participants are classified as distributions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

#### **Administrative Expenses**

Administrative expenses, such as legal, accounting, record keeping and trustee fees, are paid entirely by the Company. Loan processing fees and investment management fees are deducted from the participant's account balance.

### **3. Plan Trustee Certification**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends from investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

#### 4. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (“ASC”) 820, Fair Value Measurement and Disclosures, provides the framework for measuring fair value. That framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measures level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Collective Trusts**

##### ***Stable Value***

The stable value fund included in the common/collective trusts represents an investment in the Vanguard Retirement Savings Master Trust III. The trust fund fair market value is determined using NAV and is used for expedient purposes.

##### ***Target Date Retirement Funds***

The target retirement funds included in common/collective trusts represent investment in various Level I common stocks. The fair market value of the Plan’s interest in the collective trusts has been determined using NAV and is used for expedience purposes.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Tax Status**

The Internal Revenue Service has determined and informed the Company by letter dated October 18, 2017, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has subsequently been amended. The Company believes the Plan continues to be designed and operating in compliance with applicable requirements of the Internal Revenue Code.

The Company has analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for the year prior to 2021.

**6. Plan Termination**

The Company reserves the right to terminate the Plan at any time. In the event the Plan is terminated, participants will become 100% vested in their accounts, and the assets would be distributed to participants in accordance with the terms set forth in the Plan. See note 1 for details on the planned merger in December 2024.

**7. Party-in-Interest Transactions**

Certain investments of the Plan are shares of mutual funds and collective trust managed by the trustee. Transactions involving these investments are considered to be party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

**8. Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025 which is the date these financial statements were available for issuance.
