Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Shamin Management 1 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. Description of Plan

The following description of the Shamin Management 1 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined-contribution plan covering all full-time employees of Shamin Management, LLC and its affiliates (collectively, “the Company”) who are age 21 or older and have completed 1,000 hours of credited service during a consecutive twelve-month period. It is subject to the provisions of the Employee Retirement Income Security Act of 1975 (“ERISA”).

Eligibility

Every full-time employee shall be eligible to participate in the Plan as of January 1 or July 1 of the Plan year following the date employees are age 21 and following one year of service with no less than 1,000 hours.

Contributions

Each year, participants may contribute elective deferrals to the Plan up to the limits prescribed by the Internal Revenue Service as defined in the Plan. Participants may also roll over distributions from other defined-benefit or defined-contribution plans. A participant age 50 or older by the end of the Plan year may make catch-up contributions.

The employer may make a discretionary matching contribution equal to a uniform percentage or dollar amount of employee deferrals. The Company does not provide matching contributions for catch-up contributions. In addition, the Company may make a discretionary non-elective contribution to the Plan for employees employer on the last day of the Plan year who have at least 1,000 hours of service during the Plan year. For the year ended December 31, 2024, the Company provided a matching contribution of 20% up to 6% of compensation that a participant contributes to the Plan.

Forfeitures

Any forfeitures during a Plan year are first used to pay Plan administrative expenses and then to reduce the employer’s discretionary contributions. For the year ended December 31, 2024 \$10,101 was forfeited from nonvested accounts. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$16,493 and \$5,638, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the employer's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon occurs on a graduated scale as follows:

Notes Receivable from Participants

The Plan has a loan provision that allows participants to borrow amounts up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. The loans are secured by the balance in the participant's account. Interest rates are determined quarterly by the Plan Administrator, which are commensurate with local prevailing rates. The loans are fully amortizable and must be repaid within five years, except in the case of a loan for the purpose of acquiring a primary residence.

Payment of Benefits

On termination of service, due to death, disability, or retirement, participants or their beneficiaries may elect to either 1) receive a lump-sum amount equal to the vested balance of the participant's account, 2) receive substantially equal installments, or 3) defer payment until their required distribution date (age 70-1/2). Account balances less than \$5,000 at termination are automatically distributed.

Hardship distributions are permitted from a participant's elective deferrals. In-service distributions may be made to a participant who has not separated from the Company, provided that the participant has attained age 59-1/2. In-service distributions are permitted from a participant's pre-tax elective deferrals, employer matching contributions, employer profit-sharing contributions, qualified non-elective contribution accounts, rollover accounts, and transfer accounts. In-service distributions can only be made from accounts which are 100% vested.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) whereby revenue is recognized when earned and expenses are recognized when incurred.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments in common/collective trusts are valued using the net asset value per share practical expedient. Mutual funds are valued at quoted market prices. Purchases and sales of units are recorded on allocation dates, as are the earnings on investment accounts and the Company’s contributions. The allocation date is the last day of each month.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. The expenses paid using the Plan's assets will generally be allocated among the accounts of participants in the Plan. These expenses will be allocated either proportionally based on the value of the account balance or as an equal dollar amount based on the number of participants in the Plan.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

Investments Measured Using Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments. The redemption notice period is applicable only to the Plan.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

No Level 2 or 3 inputs were available to the Plan at December 31, 2024 or 2023.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation

techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Value at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Related Party and Party in Interest Transactions

Certain Plan investments are managed by the Custodian. Accordingly, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

6. Tax Status

The Internal Revenue Services (IRS) has determined and informed by a letter for the prototype plan adopted by the Plan, dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan Administration believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statement and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
