## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of H.I.S. International Tours (NY) Inc. 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ## **Emphasis of Matter**

### *Basis of Accounting*

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**1. DESCRIPTION OF PLAN**

The following description of the H.I.S. International Tours (NY) Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan covering all employees of H.I.S. International Tours (NY) Inc., Hawaii HIS Corporation, an affiliate, HHH. USA. INC., an affiliate, and Japan Hospitality LLC., an affiliate, (collectively the “Company”). Employees of the Company are eligible to become participants in the Plan when they have completed one year of eligible service, as defined in the Plan agreement, and have reached the age of twenty-one. The plan entry dates are the first day of each calendar quarter of a year. The Plan consists of employee contributions, and matching and discretionary profit sharing contributions from the employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** – Employees may elect to contribute to the Plan up to the legal maximum percentage of their annual compensation. Employees’ contributions are limited annually by the Internal Revenue Service (\$23,000 per individual with an additional \$7,500 catch-up contribution for individuals who are at least 50 years of age by the end of 2024). Transfers from qualified plans are allowed under the provision of the Plan. Employer matching contribution is 50% of the first 6% of eligible compensation that is contributed to the Plan, not to exceed 3% of the participant’s compensation. At the end of the Plan year, the Company, at the discretion of its board of directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participants’ compensation to the total compensation of all eligible participants. No discretionary contributions have been made by the Company since the Plan’s inception.

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution and the Company matching contributions, as well as allocations of the Plan earnings and Company’s profit sharing contribution, if any. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## 1. DESCRIPTION OF PLAN (continued)

**Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution amount and earnings is based on the participants' years of service, as follows:

<u>Years of Service</u>	<u>Vested</u>
Less than 1	0%
1	25%
2	50%
3	75%
4 or more	100%

Participants automatically become 100% vested on or after the date they reach normal retirement age or early retirement age, death or total disability.

**Benefit Payments and Withdrawals** – Benefits may be withdrawn upon termination of employment, becoming disable, and/or attaining normal retirement age (age 65). Upon termination, participants with a vested account balance in the Plan of no more than \$1,000 will have a lump-sum payment made directly to them. For participants with a vested account balance of more than \$1,000 but less than or equal to \$5,000, they may elect a distribution or roll over to an eligible retirement plan. Participants with a vested balance more than \$5,000 may elect to receive a lump sum payment or equal installment payments over the period specified in the Plan, roll over their vested balance to an eligible retirement plan, or choose to defer payments until they attain age 73 or retire, whichever is later. Participants may withdraw their vested balance before normal retirement age in certain circumstances and subject to the Plan's provisions.

**Administrative Expenses** – Reasonable administrative expenses of the Plan may be paid by the Plan to the extent not paid by the employer.

**Investment Options** – Participants may direct employee and employer contributions into various investment options offered by the Plan.

**Hardship Withdrawals** – The Plan permits withdrawals of active participant's elective contributions only in amounts necessary to meet financial hardship as defined by the Plan agreement. A participant is not required to exhaust all loan options before taking a hardship withdrawal and can continue to make elective deferrals immediately after the withdrawal.

**Notes Receivable from Participants** – Under the provisions of the Plan, a participant may obtain a loan for a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance, or \$50,000. A participant may be granted one loan during any one-year period. Only one loan may be outstanding at a time. All loans are required to be repaid within 5 years from the date of the loan. Each loan shall bear a reasonable fixed rate of interest to be determined by the plan administrator. In determining the interest rate, the plan administrator shall take into consideration fixed interest rates currently being charged by commercial lenders for loans of comparable risk on similar terms and for similar durations, so that the interest will provide for a return commensurate with rates currently charged by commercial lenders for loans made under similar circumstances. Such rate at December 31, 2024 was 8.50%. Principal and interest are paid ratably through semi-monthly payroll deductions.

**Plan Termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts.

## 1. DESCRIPTION OF PLAN (continued)

**Forfeitures** – The non-vested account of participant is forfeited as of the earlier of the date the participant receives a complete distribution of his or her vested account balance, or incurs five consecutive 1-year breaks in service. Forfeitures of terminated participants' non-vested accounts are first applied to pay plan expenses. Any forfeiture left after paying plan expenses is used to offset future employer contributions. Forfeitures of non-vested accounts amounted to \$4,662 for the year ended December 31, 2024. The balance of forfeited non-vested accounts was \$1,072 and \$0 at December 31, 2024 and 2023, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – As permitted by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan maintains its records on a modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. The modified cash basis of accounting utilizes the cash basis of accounting while carrying investments at fair value and recording investment income (loss) on the accrual basis. Contributions are recognized when received, and expenses and distributions are recognized when paid.

**Use of Estimates** – The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in aggregate fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation or as an addition to net depreciation in fair value for such investments.

**Contributions** – Participant and Company contributions are recorded when contributions are received by the Plan. Company matching contributions are recorded at the same time as the participant contributions.

**Payment of Benefits** – Benefit payments are recorded when paid.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant is terminated and the outstanding balance becomes default, the balance is treated as a taxable distribution and no longer outstanding. If the participant is still active and fails to make payments when due, the loan is considered to be in default and treated as a taxable distribution, but the fund remains as an outstanding loan for financial statement reporting purpose. No allowance for credit loss was recorded as of December 31, 2024 and 2023.

### 3. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the plan administrator and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan.

### 4. FAIR VALUE MEASUREMENTS

The fair value of financial assets and liabilities is measured in accordance with Accounting Standards Codification (“ASC”) Topic 820. Under ASC Topic 820, fair value is defined as the exit price, representing the amount that would be received in the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. ASC Topic 820 establishes a framework for measuring the fair value of financial assets and liabilities. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2- Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023 as noted below.

*Mutual funds:* Valued at the daily closing price as reported by the registered investment companies. These mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value (“NAV”) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Pooled separate accounts (“PSAs”) are privately managed by Principal Life Insurance Company and are not publicly quoted. PSAs are valued at the NAV, which is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the PSA less its liabilities. There are no redemption restrictions or unfunded commitments related to the PSAs, and the funds can be redeemed daily with no notice period.

#### 4. FAIR VALUE MEASUREMENTS (continued)

*Guaranteed interest accounts:* The Plan holds Guaranteed Interest Accounts (“GIAs”) with Principal Life Insurance Company. Principal Life Insurance Company maintains the contribution in the general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIAs promise contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible surrender charge when funds are withdrawn prior to their maturity. Thus, the GIAs are considered non-benefit responsive. The GIAs cannot be sold to a third party, thus, the only option to exit the GIAs is to withdraw the funds prior to maturity. The fair value is the discontinuance value which is the amount the plan participant would receive if they transfer or surrender their fund out the Guaranteed interest accounts prior to maturity. The fair value of the GIAs is computed using combination of the current interest rate based on remaining investment term at the reporting date as well as the interest rate on account. If the applicable interest rate is greater than the interest rate on the account, the fair value is the contract value reduced by a percentage. This percentage is equal to the difference between the applicable interest rate and the interest rate on the account, multiplied by the years (including fractional year) until the maturity date. If the applicable interest rate is less than or equal to the interest rate on the account, the fair value is equal to the contract value.

#### 5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a Guaranteed Option, a group annuity contract issued by Principal Life Insurance Company. The contract is fully benefit-responsive and is backed by the general account of Principal Life Insurance Company. The Guaranteed Option provides for the stability of principal and a declared interest rate that is credited to participant accounts. Participant-initiated withdrawals and benefit payments (including retirement, termination, disability, death, and loans, as permitted under the Plan) are made at contract value without surrender charges. However, transfers to competing investment options are subject to an equity wash provision, and employer-initiated withdrawals or plan termination may be subject to installment payments or early termination charges. The guarantees associated with this contract are obligations of Principal Life Insurance Company and are not insured by the Federal Deposit Insurance Corporation nor guaranteed by any bank.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

The Plan held units in various pooled separate accounts, as well as in GIAs and a Guaranteed Option, all of which are managed by Principal Life Insurance Company. Principal Life Insurance Company provided custodial and bookkeeping services to the Plan until July 28, 2024 and is an affiliate of Principal Trust Company, the current custodian of the Plan. Accordingly, these transactions are considered exempt party-in-interest transactions under ERISA.

Fees paid by the Plan to Principal Life Insurance Company for the year ended December 31, 2024 amounted to \$24,800. Certain administrative functions are performed by officers and employees of the Company. No such officers or employees receive compensation from the Plan.

## **7. TAX STATUS**

The plan administrator obtained an Internal Revenue Service (the "IRS") opinion letter, dated June 30, 2020, in which the IRS stated that the prototype, as then designed, qualifies under section 401(a) of the Internal Revenue Code (the "IRC"). The Plan has not received a determination letter specific to the Plan itself. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan. The financial statement effects are recognized when the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken.

The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **8. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued. There were no events that occurred subsequent to December 31, 2024 that would require recognition or disclosure in the financial statements.
