## Notes to Financial Statements

### Note 1. Description of the Plan

The following description of the Abatix Corp. 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of Abatix Corp. (“Abatix” or “Company”) and its wholly owned subsidiary. Full-time employees are eligible to participate in the Plan on the latter of (i) their first day of employment or (ii) the attainment of age twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Abatix Corp. Benefit Plan Administrator Committee (“Committee”) is responsible for oversight of the Plan. The independent investment manager determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Committee.

#### Contributions

Each year, participants may contribute the lesser of (i) 100 percent of their pretax annual compensation, as defined in the Plan, or (ii) the limits established by the Internal Revenue Service, including catch-up contributions for participants who have attained age 50 before the end of the plan year. Participants may also designate some or all of their contributions as after tax contributions to a Roth 401(k) option. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees enroll automatically in the Plan unless they affirmatively elect not to participate in the Plan. In addition, all eligible employees who are not participating in the Plan on January 1<sup>st</sup> of each year automatically enroll in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation. Their contributions invest in a designated target date fund based on their expected retirement year until changed by the participant.

The Plan also includes an auto-increase provision whereby the percentage of salary deferral of participants who are contributing less than the Internal Revenue Service (“IRS”) maximum dollar limit and do not opt out automatically increase by 1 percent each January 1<sup>st</sup> until that participant is contributing 10 percent of their compensation.

## Notes to Financial Statements

A participant in the Plan is eligible to receive an allocation of matching contributions from the Company on the first day of the calendar month following completing 1 year of employment in which they complete 1,000 hours of service, provided they are age 21. Currently, and in 2024, the Company contributes 55 percent of the first 6 percent of eligible compensation that a participant contributes to the Plan.

Additional profit sharing amounts may be contributed at the option of the Company's board of directors. During the years ended December 31, 2024 and 2023, the Company did not make a profit sharing contribution to the Plan.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The participant is entitled to the vested portion of their account.

### Vesting

Participants are vested immediately in their contributions plus actual earnings less an allocation of administrative expenses thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

### Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Committee. Principal and interest is paid ratably through semi-monthly payroll deductions.

## Notes to Financial Statements

### Payment of Benefits

Upon separation of service due to death, disability, retirement or termination of employment, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period.

### Forfeitures

Participants who terminate employment from the Company before they fully vest in the Company matching contribution, forfeit the unvested portion. At December 31, 2024 and 2023, Company matching contributions of forfeited non-vested accounts were \$1,278 and \$13,174, respectively. These forfeitures are used to reduce future Company contributions and/or to pay Plan expenses. During 2024 and 2023, forfeitures of \$34,554 and \$22,290, respectively, were used for Contributions and/or to pay Plan expenses.

## Note 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("US GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

### **Notes to Financial Statements**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### **New Accounting Pronouncements/Accounting Changes**

For the year ended December 31, 2024, the Company considered all updates by the FASB to the Accounting Standards Codification ("Codification"). There were no updates to the Codification that had a material effect on the financial statements or financial position of the Plan as of December 31, 2024.

#### **Plan Management's Review of Subsequent Events**

Effective January 1, 2025, the Company amended the plan to reduce the age requirement for all contribution purposes from age 21 to age 18.

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

#### Note 3. Certified Investments

All investment information disclosed in the accompanying financial statements and supplementary information, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, investment income (loss) and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information provided to Plan management and certified as complete and accurate by BOKF, NA (“BOKF”), the trustee/custodian of the Plan.

#### Note 4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any significant fair value measurement input. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

### Notes to Financial Statements

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Stable value fund: Valued at the NAV of the shares held by the Plan at year-end, which is based on the fair value underlying investments using information reported by the investment advisor at year-end.

#### Note 5. Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds and collective trust funds provided through BOKF. Additionally, certain investments inside the self-directed option are shares in a cash management fund through BOKF. BOKF is the record keeper and custodian/trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions.

#### Note 7. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### **Notes to Financial Statements**

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities that are exposed to various risks such as interest rates, market and credit risks. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in values of investment securities will occur in the near term, some changes could materially affect participant account balances, and the amounts reported in the statements of net assets available for benefits.
