## **Independent Auditor's Report**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Ruscilli Construction Co. LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). #### Plan Description

The following description of the Ruscilli Construction Co. LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all eligible employees of Ruscilli Construction Co. LLC (the Company and Plan Sponsor) who are age 21 and older with at least one month of service with the Company (effective July 1, 2023). Prior to July 1, 2023, the plan covered all eligible employees who were age 21 and older with at least one year of service. Employees whose retirement benefits are subject to a collective bargaining agreement, leased employees and non-resident aliens are not eligible to participate. Participants are automatically enrolled in the plan on the first day of the following month once eligibility requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, up to the legal limits, as defined in the plan agreement. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also permits for Roth elective deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company, at its discretion, may match employee contributions at a rate to be determined by management. For the year ended December 31, 2024 and 2023, the Company elected to make matching contributions equal to 50% of the participant's deferral up to a max of 2% of the participant's plan compensation. Contributions are subject to certain limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, Company matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Effective July 1, 2023, vesting in the Company's discretionary matching portion of their accounts, plus actual earnings, is based on continuous years of service according to the following vesting schedule:

1	0%
2	20%
3	40%
4	60%
5	80%
6 or more	100%

Prior to July 1, 2023, participants were immediately vested in the Company's contributions portion of their accounts.

Investment Options

A participant may direct Company and participant contributions in any of the various investment options offered by the Plan. Participants may change their investment options at any time. The Plan currently offers several mutual funds and one general insurance account as investment options.

Payment of Benefits

A participant may receive the value of his or her vested account upon retirement, disability or termination of employment with the Company. Upon death or disability of a participant or upon reaching retirement age, which is 65 years of age, the participant, or beneficiary, shall be entitled to the full value of the account. Distributions are made in a full lump sum or partial payment. Hardship withdrawals, as defined in the plan agreement, are also available to participants. The Plan also provides for in-service distributions of a participant's vested interest in his or her account for employees who reach age 59½ while still employed with the Company.

In the case of termination of employment, a participant with an account balance of more than \$5,000, excluding any balance from rollover contributions, may elect to receive his or her account balance as soon as administratively reasonable after the date of termination. If the terminated participant does not elect to receive his or her account balance, it will remain in the Plan Trust Fund until such election is made.

Participants who are terminated with an account balance equal to or less than \$5,000, excluding any balance from rollover contributions, may elect to receive his or her account balance as soon as administratively reasonable after the date of termination. However, if an election is not made timely, a mandatory distribution will occur in which the plan administrator will transfer the account balance to an IRA established in his or her name.

##### Forfeited Accounts

There were forfeitures of \$2,105 and \$1,422 in the plan as of December 31, 2024 and 2023, respectively. These accounts will be used to reduce employer contributions. Forfeitures used during 2024 and 2023 totaled \$1,425 and \$0, respectively.

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. There was no material impact to the Plan's 2024 or 2023 financial statements.

#### Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fixed selection option, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

#### Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recognized on the ex-dividend date and interest is recognized on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Plan's sponsor as provided in the Plan document.

#### Fixed Select Option

The Plan has a traditional fully benefit-responsive investment contract with Nationwide Life Insurance Company totaling \$14,329 and \$10,083 as of December 31, 2024 and 2023, respectively. Nationwide maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The crediting interest rates are based on an agreed-upon formula with the contract issuer, and are guaranteed for an agreed upon period, usually one year.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### Plan Termination

The Company has the right to discontinue its contributions at any time. Although it has not expressed any intent to do so, the Company also has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants' accounts will become fully vested.

#### Tax Status

The Company has adopted a prototype non-standardized pre-approved profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### Tax Status (continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Party-in-Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. During the years ended December 31, 2024 and 2023, the Plan paid for investment advisory services and record keeping services which qualify as party-in-interest transactions. Fees paid by the Plan amounted to \$54,308 and \$40,354 for the years ended December 31, 2024 and 2023, respectively.

#### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such change could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for benefits.
