Independent Auditor's Report

To the Administrator and Plan Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Renal Medicine Associates, Ltd. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

1) Description of the Plan

The following description of the Renal Medicine Associates, Ltd. 401(k) Profits Sharing Plan and Trust (the “Plan”) provides only general information. Participants and others should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a safe-harbor defined contribution plan covering all employees of Renal Medicine Associates, Ltd. (the “Company” or “Employer”) who have completed one year of service during which at least 1,000 hours were worked. The Plan was originally effective July 1, 1982, and has been amended and restated throughout the years to comply with tax legislation and most recently restated July 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan if they completed one year of service in which 1,000 hours were worked. Employees are able to enter the plan on the first day of the month coinciding with or next following the date eligibility requirements are met.

Contributions

Participants may contribute any percentage of their income, subject to the annual IRS limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals. Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

The Company contributes a safe harbor contribution for all eligible employees of 3% of the participants’ eligible compensation for the plan year. The Plan also provides for an employer profit sharing discretionary nonelective contribution. Participants must be employed on the last day of the year and have 1,000 hours of service to be eligible for this contribution. Profit sharing discretionary contributions of \$389,599 and \$414,651 were authorized for the years ending December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the employer’s contributions, and an allocation of the plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Plan participants can direct their accounts to be invested in a combination of available funds.

Vesting

Participants are immediately vested in their contributions, the employer's safe harbor contributions and actual earnings for these contributions. Vesting in the employer's profit sharing discretionary nonelective contribution is based on years of continuous service. Participants vest in the employer's profit sharing discretionary nonelective contribution based on the following schedule:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 not to exceed 50% of their vested account balance. The loans are secured by the balance in the participant's account. The maximum loan period is five years, unless used for the purpose of a principal residence. Loans bear interest of 1% over the prime lending rate quoted in the Wall Street Journal. Loan proceeds are available from all sources excluding Roth elective deferrals. Principal and interest is paid ratably through payroll deductions and credited to the participant's account.

Mandatory Cash-Out Provisions

If the amount of the participant's vested account balance to be distributed exceeds \$1,000 but is less than or equal to \$5,000 and the participant fails to timely elect a lump sum payment or direct rollover to a participant designated individual retirement account, then the Plan administrator will roll the entire vested balance to an individual retirement account established by the Plan administrator at a qualified institution for the benefit of the participant. Vested account balances of less than \$1,000 are distributed in cash directly to the participant without the participant's consent.

Payments of Benefits

Upon retirement, termination, disability, or death, a participant or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a series of substantially equal periodic installments. Additionally, participants may take an in-service distribution upon reaching 59.5 if they are fully vested. The Plan permits hardship withdrawals, subject to account balance limits and applicable laws.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$94,485 and \$64,027, respectively. These accounts can be used to reduce future employer contributions in accordance with the Plan document. Forfeitures of \$97,192 and \$42,235 were used to offset employer contributions for the years ended December 31, 2024 and 2023, respectively.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee of the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statement of changes in net assets available for benefits.

Risk and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related loan fees are recorded as administrative expenses and are expensed when incurred. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. At any time, the Employer may elect for the Plan to pay administration costs. The Employer paid the majority of the Plan's administrative expenses for the years ended December 31, 2024 and 2023, which are not included in these financial statements. Investment related expenses are included in the net appreciation (depreciation) of the fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through September 22, 2025, the date which the financial statements were available to be issued.

3) Investments and Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market: Valued at the net asset value (NAV) and shares held by the plan. Shares are primarily invested in direct obligations of the U.S. Treasury, U.S. government agencies, repurchase agreements and money markets with maturities of 13 months or less which have observable pricing inputs, including quoted prices for similar assets in active or nonactive markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4) Information Prepared and Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained or derived from information provided to the Plan administrator by, Ascensus, LLC, Ascensus Trust Company's parent company, the Trustee of the Plan, a qualified institution, and certified as complete and accurate:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants reflected on the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments and notes receivable reflected on the supplemental schedule of assets held at end of year.

5) Plan Termination

Although it has not expressed any intent to do so, the Employer, as the Plan's sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all of their entire account balance.

6) Tax Status

The Plan is operating under a prototype document with a nonstandardized adoption agreement. The Internal Revenue Service has determined and informed the Plan sponsor by letter dated June 30, 2020, that the prototype plan, as then designed, is in compliance with applicable sections of the Internal Revenue Code. The Plan is relying on the opinion letter of the prototype sponsor. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require the Plan’s administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7) Related-Party and Party-In-Interest Transactions

Ascensus Trust Company provides record-keeper services for the Plan. These transactions qualify as exempt party-in-interest transactions. The Employer provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

For the years ended December 31, 2024 and 2023, fees paid by the Plan for administrative expenses such as third party recordkeeping fees, distribution fees, and loan fees, amounted to \$3,745 and \$3,404, respectively.

8) Delinquent Participant Contributions

As disclosed in the supplemental schedule of delinquent participant contributions, two payrolls during the year ended December 31, 2024, were not remitted to the Plan within the time frame specified by the Department of Labor’s Regulation 20 CFR 2510.3-102, thus constituting nonexempt transactions between the Employer and the Plan. All delinquent 2024 participant contributions were remitted to the Plan no later than December 31, 2024.
