INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
BigTime Software, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of BigTime Software, Inc. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The BigTime Software, Inc. 401(k) Plan, ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 9, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - BigTime Software, Inc. is the plan sponsor, employer and plan administrator. Ascensus Trust Company is the directed trustee that holds custody of plan assets. Ascensus LLC, acting as the agent for Ascensus Trust Company, is the third party administrator, tax counsel that performs various compliance tests and investment agent that maintains investment and participant records. The Ascensus entities are collectively referred to as "Ascensus". Gallagher Fiduciary Advisors is the plan's investment advisor. An officer of the plan sponsor acts as a limited plan trustee.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the investment account summaries and prospectuses for more information. Earnings from investments bought, sold or held during the year is reflected in the accompanying statement of changes in net assets available for benefits.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the funds. The funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective January 1, 2018 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to contribute to the plan and receive employer contributions once they have completed one month of service and have reached age twenty-one. An employee will be deemed a participant and allowed to enter the plan on the first day of each calendar month immediately following the date the plan's eligibility requirements are met.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. New employees are automatically enrolled in the plan and have 6% of compensation withheld as elective deferral contributions. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Matching contributions can be made at the employer's discretion. The employer elected to contribute employer discretionary matching contribution equal to 25% of the first \$6,000 of participants' elective deferrals. In order to share in matching contributions, the participant must be employed on the last day of the plan year. These contributions are funded annually subsequent to year-end.
- d. Additionally, employer profit sharing, qualified nonelective and qualified matching contributions may be made at the employer's discretion. There were no such contributions in 2024.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage monthly.

Vesting - Participants are always 100% vested in their elective deferral contributions, rollover contributions and related earnings. Participants become 25% vested in their employer contributions and related earnings upon one year of service. The participant then vests at a rate of 25% for each year thereafter. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death or disability. Distributions are made in the form of a single lump sum or partial payments. In-service withdrawals can commence upon attaining the age of 59½. In addition, hardship withdrawals are permitted under certain circumstances.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer. Certain other administrative expenses are paid directly from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loan and distribution fees and non-participant directed charges for investment advisory and contract administrator fees. Certain non-participant directed charges are paid using forfeitures while other non-participant directed charges are allocated to the participants on an account value basis.

Forfeitures - Forfeited nonvested accounts can be used to pay plan administrative expenses or reduce employer contributions. Forfeitures used to pay plan administrative expenses were \$16,000 in 2024. Unapplied forfeitures were \$54,000 and \$5,000 as of December 31, 2024 and 2023.

Note receivable from participant - Effective January 1, 2024, participants can take out loans against their accounts with approval of the plan administrator. There are certain provisions and restrictions that apply which are further described in the loan procedures agreement. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may not have more than one loan outstanding at any given time. As of December 31, 2024, the note receivable from participant had a repayment schedule of June 2027 with interest at 8.75%. The note receivable from participant is valued at its unpaid principal balance plus any accrued but unpaid interest, which approximates fair value.

3. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

4. INCOME TAX STATUS

The plan adopted an Ascensus LLC pre-approved profit sharing plan. The pre-approved profit sharing plan received its most recent favorable opinion on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress.

5. PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the plan, plan sponsor and Ascensus qualify as party-in-interest transactions. Direct fees paid by the plan to Ascensus were \$20,000 in 2024. In addition, Ascensus receives certain indirect compensation from mutual fund service providers that is used to reduce administrative and service fees that may otherwise have been charged to the plan by Ascensus.

Transactions involving the note receivable from participant also qualifies as a party-in-interest transaction.

All such party-in-interest transactions are exempt from the prohibited transactions of ERISA.

6. INFORMATION CERTIFIED BY ASCENSUS TRUST COMPANY

Management has obtained certifications from Ascensus Trust Company, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held for the plan and the fair values of such and the note receivable from participant as of December 31, 2024 and 2023;
- b. Interest and dividends from investments and net appreciation (depreciation) in fair values of investments and interest income on the note receivable from participant during 2024; and
- c. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

As discussed in Note 1, the financial statements are prepared under the accrual method of accounting whereas additions and deductions are reflected in the period earned or incurred. The plan's Form 5500 was prepared under the cash basis method of accounting. As a result, the accompanying statement of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits for the year ending December 31, 2024, differed from the 2024 and 2023 Form 5500.
